AN ACT to amend the vehicle and traffic law, in relation to issuing  
distinctive license plates for African-American veterans

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. The vehicle and traffic law is amended by adding a new  
2     section 404-x to read as follows:  
3     S 404-X. DISTINCTIVE PLATES FOR AFRICAN-AMERICAN VETERANS. 1. ANY  
4     AFRICAN-AMERICAN WHO IS A VETERAN, AS DEFINED IN SECTION THREE HUNDRED  
5     FIFTY OF THE EXECUTIVE LAW, AND WHO RESIDES IN THIS STATE SHALL, UPON  
6     REQUEST, BE ISSUED A LICENSE PLATE BEARING THE WORDS "AFRICAN-AMERICAN  
7     VETERAN". APPLICATION FOR SAID LICENSE PLATE SHALL BE FILED WITH THE  
8     COMMISSIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL  
9     PRESCRIBE.  
10    2. THE DISTINCTIVE PLATE AUTHORIZED HEREIN SHALL BE ISSUED UPON PROOF,  
11    SATISFACTORY TO THE COMMISSIONER, THAT THE APPLICANT IS A VETERAN.  
12    3. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED  
13    IN THE SAME MANNER AS OTHER NUMBER PLATES UPON PAYMENT OF THE REGULAR  
14    REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE  
15    PROVIDED, HOWEVER, THAT AN ADDITIONAL ONE-TIME SERVICE CHARGE OF TEN  
16    DOLLARS SHALL BE CHARGED FOR SUCH PLATE. SUCH SERVICE CHARGE SHALL BE  
17    DEPOSITED PURSUANT TO THE PROVISIONS OF SECTION FOUR HUNDRED FOUR-OO OF  
18    THIS ARTICLE TO THE CREDIT OF THE DEPARTMENT OF MOTOR VEHICLES DISTINC-  
19    TIVE PLATE DEVELOPMENT FUND ESTABLISHED BY SECTION NINETY-FIVE-G OF THE  
20    STATE FINANCE LAW, AND SHALL BE USED FOR THE PRODUCTION, DESIGN, ADVER-  
21    TISING AND MARKETING OF DISTINCTIVE LICENSE PLATES PURSUANT TO SUCH  
22    SECTION NINETY-FIVE-G.  
23    S 2. This act shall take effect on the ninetieth day after it shall  
24    have become a law.
