AN ACT to repeal certain provisions of the tax law relating to the minimum wage reimbursement credit

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 38 of the tax law, as added by section 1 of part EE
2 of chapter 59 of the laws of 2013, is REPEALED.
3 S 2. Section 187-s of the tax law is REPEALED.
4 S 3. Subdivision 46 of section 210 of the tax law is REPEALED.
5 S 4. Clause (xxxv) of subparagraph (B) of paragraph 1 of subsection
6 (i) of section 606 of the tax law, as added by section 4 of part EE of
7 chapter 59 of the laws of 2013, is REPEALED.
8 S 5. Subsection (aaa) of section 606 of the tax law is REPEALED.
9 S 6. Subsection (z) of section 1456 of the tax law is REPEALED.
10 S 7. Subdivision (cc) of section 1511 of the tax law is REPEALED.
11 S 8. This act shall take effect immediately and shall apply to tax
12 years commencing on or after January 1, 2014.
