AN ACT to amend the public authorities law, in relation to the powers of subsidiaries of the Educational Housing Services Inc.; and to amend chapter 376 of the laws of 1998 amending the public authorities law relating to the powers of the Educational Housing Services Inc., in relation to extending the effectiveness thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The undesignated paragraph of paragraph (b) of subdivision 2 of section 1676 of the public authorities law, as amended by chapter 3 352 of the laws of 2008, is amended to read as follows:

16 Educational Housing Services Inc., a not-for-profit corporation, for 17 the acquisition, financing, refinancing, construction, reconstruction, 18 renovation, development, improvement, expansion, and equipping of hous-19 ing for students and/or faculty at institutions of higher education 20 [throughout the state and up to five] LOCATED WITHIN THE FIVE BOROUGHS 21 OF THE CITY OF NEW YORK AND WESTCHESTER COUNTY EITHER DIRECTLY OR ΒY 22 CREATION OF A wholly-owned [and] NOT-FOR-PROFIT SUBSIDIARY CORPORATION 23 OR controlled corporations [or], limited liability companies, OR PART-24 NERSHIPS that are not subject to federal income taxation (except with 25 respect to any unrelated business income) [as follows: one such corpo-26 ration or limited liability company for the acquisition, financing, construction, reconstruction, renovation, development, expansion, and equipping of a dormitory for housing for 27 refinancing, 28 improvement, students in connection with the city university of New York; one such 29 30 corporation or limited liability company for the acquisition, financing, 31 refinancing, construction, reconstruction, renovation, development, 32 improvement, expansion, and equipping of a dormitory located at 401 West 130th Street, New York, New York for housing for students and/or faculty 33 34 in connection with the city college of New York; one such corporation or 35 limited liability company for the acquisition, financing, refinancing, 36 construction, reconstruction, renovation, development, improvement, expansion, and equipping of a dormitory at 55 John Street, New York, New 37 38 York for housing for students and/or faculty; one such corporation or 39 limited liability company for the acquisition, financing, refinancing, 40 construction, reconstruction, renovation, development, improvement, expansion, and equipping of a dormitory at 231 East 55th Street, New 41 York, New York for housing for students and/or faculty; and one such 42 corporation or limited liability company for the acquisition, financing, 43 44 refinancing, construction, reconstruction, renovation, development, 45 improvement, expansion, and equipping of a dormitory at 1760 3rd Avenue, New York, New York for housing for students and/or faculty]. 46

S 3. Section 3 of chapter 376 of the laws of 1998 shall be and remain the full force and effect with respect to all projects undertaken pursuant to the authority of such chapter and this act whether by Educational Housing Services Inc., or its subsidiary.

51 S 4. Section 5 of chapter 376 of the laws of 1998, amending the public 52 authorities law relating to the powers of the Educational Housing 53 Services Inc., as amended by chapter 280 of the laws of 2008, is amended 54 to read as follows:

55 S 5. This act shall take effect immediately and shall expire and be 56 deemed repealed on December 31, [2013] 2018.

This act shall take effect immediately, provided, however, that 2 the amendments to the undesignated paragraph of paragraph (b) of subdi-3 vision 2 of section 1676 and the undesignated paragraph of subdivision 1 4 of section 1680 of the public authorities law made by sections one and 5 two of this act shall not affect the repeal of such paragraphs and shall 6 be deemed repealed therewith.
