AN ACT to amend the public health law, in relation to the definition of palliative care

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Legislative intent. The purpose of this act is to conform the concept of palliative care under article 40 of the public health law with that in sections 2997-c (palliative care patient information) and 2997-d (hospital, nursing home, home care, special needs assisted living residences and enhanced assisted living residences palliative care support) of the public health law.

7 S 2. Section 4002 of the public health law is amended by adding a new 8 subdivision 6 to read as follows:

9 6. "PALLIATIVE CARE" MEANS HEALTH CARE TREATMENT, INCLUDING INTERDIS-10 CIPLINARY END-OF-LIFE CARE, CONSULTATION WITH PATIENTS AND FAMILY 11 MEMBERS, AND PSYCHOSOCIAL AND SPIRITUAL SUPPORT, TO PREVENT OR RELIEVE 12 PAIN AND SUFFERING AND TO ENHANCE THE PATIENT'S QUALITY OF LIFE.

13 S 3. Section 4012-b of the public health law, as added by chapter 195 14 of the laws of 2002, is amended to read as follows:

S 4012-b. Hospice palliative care [program for persons with 15 advanced progressive 16 disease]. [1.] Notwithstanding any inconsistent and 17 provision of this article to the contrary, a hospice may also offer a program of palliative care for patients with advanced [and progressive 18 19 disease] LIFE-LIMITING CONDITIONS AND ILLNESSES and their families. Such 20 a program may be provided by a hospice issued a certificate of approval pursuant to section forty hundred four of this article, acting alone or 21 under contract with a certified home health agency, 22 long term home health care program, licensed home care services agency or AIDS home 23 24 care program, as such terms are defined in section thirty-six hundred 25 this chapter. 3 [2. For the purposes of this section the following terms shall mean:

4 (a) "Advanced and progressive disease" means a medical condition which 5 is irreversible and which will continue indefinitely, where there is no 6 reasonable hope of maintaining life.

7 (b) "Palliative care" means the active, interdisciplinary care of 8 patients with advanced, life-limiting illness, focusing on relief of 9 distressing physical and psychosocial symptoms and meeting spiritual 10 needs. Its goal is achievement of the best quality of life for patients 11 and families.]
