AN ACT to amend the state technology law and the tax law, in relation to a refundable tax credit provided to broadband deployment to residences and small businesses located in rural, unserved areas

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. This act shall be known and may be cited as the "credit for
2 rural broadband act of 2014".
3 S 2. Section 104 of the state technology law is amended by adding a
4 new subdivision 3 to read as follows:
5 3. THE OFFICE OF INFORMATION TECHNOLOGY SERVICES, IN CONJUNCTION WITH
6 INPUT FROM THE ADVISORY COUNCIL, IS HEREBY AUTHORIZED AND DIRECTED TO
7 PROMULGATE RULES AND REGULATIONS NECESSARY FOR VERIFYING AN "UNSERVED"
8 AREA UNDER THE CREDIT FOR RURAL BROADBAND ACT OF TWO THOUSAND FOURTEEN,
9 USING BROADBAND MAPPING DATA AT THE TIME A PROJECT IS PROPOSED.
10 S 3. Section 210 of the tax law is amended by adding a new subdivision
11 48 to read as follows:
12 48. CREDIT FOR RURAL BROADBAND DEPLOYMENT. (A) ALLOWANCE OF CREDIT.
13 A QUALIFIED TAXPAYER SHALL BE ALLOWED A CREDIT AGAINST THE TAX IMPOSED
14 BY THIS ARTICLE EQUAL TO ANY QUALIFIED CUSTOMER CONTRIBUTION IN AID OF
15 CONSTRUCTION RESULTING FROM NEW NETWORK CONSTRUCTION TO DELIVER BROAD-
16 BAND SERVICE TO THE INDIVIDUAL'S RESIDENCE OR PLACE OF BUSINESS LOCATED
17 IN AN UNSERVED AREA. THE CREDIT ALLOWED BY THIS SUBDIVISION SHALL BE
18 CLAIMED ANNUALLY OVER A FIVE-YEAR PERIOD EQUAL TO ONE-FIFTH OF THE CRED-

1 IT AMOUNT. IF THE CREDIT ALLOWED UNDER THIS SUBDIVISION IS GREATER THAN

14 (2) "QUALIFIED CUSTOMER CONTRIBUTION IN AID OF CONSTRUCTION" IS DETER-
15 MINED IN ACCORDANCE WITH THE FOLLOWING FORMULA: $(QCE/TC) - (ACM/35) =$
16 QC , WHERE QCE EQUALS THE QUALIFIED CONSTRUCTION EXPENSES; ACM EQUALS THE
17 AVERAGE COST OF CONSTRUCTION PER MILE IN THE PROPOSED UNSERVED SERVICE
18 AREA, AS CERTIFIED BY THE BROADBAND SERVICE PROVIDER, BUT NOT TO EXCEED

27 (3) "REQUIRED PROVIDER CONTRIBUTION IN AID TO CONSTRUCTION" SHALL
28 EQUAL THE QUALIFIED CONSTRUCTION EXPENSES, LESS THE SUM OF ALL THE QUAL-
29 IFIED CUSTOMER CONTRIBUTIONS IN AID TO CONSTRUCTION IN THE PROPOSED
30 UNSERVED SERVICE AREA.

31 (4) "BROADBAND SERVICE" MEANS INTERNET ACCESS SERVICE WITH TRANS-
32 MISSION SPEEDS THAT ARE EQUAL TO OR GREATER THAN COMBINED ADVERTISED
33 DOWNLOAD SPEEDS OF AT LEAST 4 MEGABITS PER SECOND (MBPS) AND UPLOAD
34 SPEEDS OF AT LEAST 1 MBPS PER SECOND OVER THE PROVIDER'S NETWORK.

35 (5) "UNSERVED AREA" MEANS AN AREA COMPOSED OF ONE OR MORE CONTIGUOUS
36 CENSUS BLOCKS WHERE AT LEAST NINETY PERCENT OF HOUSEHOLDS LACK ACCESS TO
37 FACILITIES-BASED TERRESTRIAL BROADBAND SERVICE. A HOUSEHOLD HAS ACCESS
38 TO A BROADBAND SERVICE IF THE HOUSEHOLD CAN READILY SUBSCRIBE TO THAT
39 SERVICE UPON REQUEST.

40 (6) "QUALIFIED TAXPAYER" MEANS A TAXPAYER WHICH IS A SMALL BUSINESS
41 CORPORATION AS DEFINED IN PARAGRAPH THREE OF SUBSECTION (C) OF SECTION
42 TWELVE HUNDRED FORTY-FOUR OF THE INTERNAL REVENUE CODE (WITHOUT REGARD
43 TO THE SECOND SENTENCE OF SUBPARAGRAPH (A) THEREOF) AS OF THE LAST DAY
44 OF THE TAXABLE YEAR.

45 S 4. Subsections (yy) and (zz) of section 606 of the tax law, as
46 relettered by section 5 of part H of chapter 1 of the laws of 2003, are
47 relettered subsections (yyy) and (zzz) and a new subsection (bbb) is
48 added to read as follows:

49 (BBB) CREDIT FOR RURAL BROADBAND DEPLOYMENT. (A) ALLOWANCE OF CREDIT.
50 A QUALIFIED TAXPAYER SHALL BE ALLOWED A CREDIT AGAINST THE TAX IMPOSED
51 BY THIS ARTICLE EQUAL TO ANY QUALIFIED CUSTOMER CONTRIBUTION IN AID OF
52 CONSTRUCTION RESULTING FROM NEW NETWORK CONSTRUCTION TO DELIVER BROAD-
53 BAND SERVICE TO THE INDIVIDUAL'S RESIDENCE OR PLACE OF BUSINESS LOCATED
54 IN AN UNSERVED AREA. THE CREDIT ALLOWED BY THIS SUBSECTION SHALL BE
55 CLAIMED ANNUALLY OVER A FIVE-YEAR PERIOD EQUAL TO ONE-FIFTH OF THE CRED-
56 IT AMOUNT. IF THE CREDIT ALLOWED UNDER THIS SUBSECTION IS GREATER THAN

7 (1) "QUALIFIED CONSTRUCTION EXPENSES" EQUAL THE TOTAL COST OF

11 CONSTRUCTION AS DETERMINED BY THE COMMISSIONER IN CONSULTATION WITH THE
12 PUBLIC SERVICE COMMISSION AND BROADBAND SERVICE PROVIDERS.

13 (2) "QUALIFIED CUSTOMER CONTRIBUTION IN AID OF CONSTRUCTION" IS DETER-
14 MINED IN ACCORDANCE WITH THE FOLLOWING FORMULA: $(QCE/TC) - (ACM/35) =$
15 QC , WHERE QCE EQUALS THE QUALIFIED CONSTRUCTION EXPENSES; ACM EQUALS THE
16 AVERAGE COST OF CONSTRUCTION PER MILE IN THE PROPOSED UNSERVED SERVICE
17 AREA, AS CERTIFIED BY THE BROADBAND SERVICE PROVIDER, BUT NOT TO EXCEED
18 A REASONABLE COST BASED UPON THE AVERAGE COST PER MILE OF BROADBAND
19 NETWORK CONSTRUCTION AS DETERMINED BY THE COMMISSIONER IN CONSULTATION
20 WITH THE PUBLIC SERVICE COMMISSION AND BROADBAND SERVICE PROVIDERS; TC
21 EQUALS THE NUMBER OF RESIDENTS AND SMALL BUSINESS CUSTOMERS IN THE
22 PROPOSED UNSERVED SERVICE AREA MAKING A QUALIFIED CUSTOMER CONTRIBUTION
23 IN AID TO CONSTRUCTION AND CONTRACTING FOR SERVICES OVER THE NETWORK;
24 AND QC EQUALS THE QUALIFIED CUSTOMER CONTRIBUTION IN AID OF
25 CONSTRUCTION.

26 (3) "REQUIRED PROVIDER CONTRIBUTION IN AID TO CONSTRUCTION" SHALL
27 EQUAL THE QUALIFIED CONSTRUCTION EXPENSES, LESS THE SUM OF ALL THE QUAL-
28 IFIED CUSTOMER CONTRIBUTIONS IN AID TO CONSTRUCTION IN THE PROPOSED
29 UNSERVED SERVICE AREA.

30 (4) "BROADBAND SERVICE" MEANS INTERNET ACCESS SERVICE WITH TRANS-
31 MISSION SPEEDS THAT ARE EQUAL TO OR GREATER THAN COMBINED ADVERTISED
32 DOWNLOAD SPEEDS OF AT LEAST 4 MEGABITS PER SECOND (MBPS) AND UPLOAD
33 SPEEDS OF AT LEAST 1 MBPS PER SECOND OVER THE PROVIDER'S NETWORK.

34 (5) "UNSERVED AREA" MEANS AN AREA COMPOSED OF ONE OR MORE CONTIGUOUS
35 CENSUS BLOCKS WHERE AT LEAST NINETY PERCENT OF HOUSEHOLDS LACK ACCESS TO
36 FACILITIES-BASED TERRESTRIAL BROADBAND SERVICE. A HOUSEHOLD HAS ACCESS
37 TO A BROADBAND SERVICE IF THE HOUSEHOLD CAN READILY SUBSCRIBE TO THAT
38 SERVICE UPON REQUEST.

39 (6) "QUALIFIED TAXPAYER" MEANS ANY INDIVIDUAL WITH NEW YORK ADJUSTED
40 GROSS INCOME OF TWO HUNDRED FIFTY THOUSAND DOLLARS OR LESS.

41 S 5. This act shall take effect immediately and shall apply to tax
42 years beginning on or after January 1, 2015.
