THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

The executive law is amended by adding a new section 170-c 1 Section 1. to read as follows:

- S 170-C. COLLECTION OF DEMOGRAPHIC INFORMATION. 1. EVERY STATE OR COMMISSION THAT DIRECTLY OR BY CONTRACT COLLECTS DEMO-GRAPHIC DATA AS TO THE ANCESTRY OR ETHNIC ORIGIN OF RESIDENTS OF SHALL USE SEPARATE COLLECTION CATEGORIES AND TABU-STATE OF NEW YORK LATIONS FOR SEXUAL ORIENTATION AND GENDER IDENTITY OR EXPRESSION.
- 2. THE TERM "GENDER IDENTITY OR EXPRESSION" MEANS HAVING OR AS HAVING A GENDER IDENTITY, SELF-IMAGE, APPEARANCE, BEHAVIOR OR EXPRESSION WHETHER OR NOT THAT GENDER IDENTITY, SELF-IMAGE, BEHAVIOR OR EXPRESSION IS DIFFERENT FROM THAT TRADITIONALLY ASSO-CIATED WITH THE SEX ASSIGNED TO THAT PERSON AT BIRTH.
- 3. THE DATA COLLECTED PURSUANT TO THE DIFFERENT COLLECTION CATEGORIES TABULATIONS DESCRIBED IN SUBDIVISION ONE OF THIS SECTION SHALL BE INCLUDED IN EVERY DEMOGRAPHIC REPORT ON ANCESTRY OR ETHNIC ORIGINS OF STATE OF NEW YORK BY THE STATE AGENCY, BOARD, OR RESIDENTS OF THECOMMISSION PUBLISHED OR RELEASED ON OR AFTER JULY FIRST, TWO THOUSAND SHALL BE MADE AVAILABLE TO THE PUBLIC IN ACCORDANCE THEDATA WITH STATE AND FEDERAL LAW, EXCEPT FOR PERSONAL IDENTIFYING INFORMATION, WHICH SHALL BE DEEMED CONFIDENTIAL, BY POSTING THE DATA ON THE
