AN ACT to amend the highway law, in relation to adding the Mountain Cloves scenic byway into the state scenic byways system

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 1 of section 349-dd of the highway law is  
2 amended by adding a new paragraph (j-12) to read as follows:  
3     (J-12) MOUNTAIN CLOVES SCENIC BYWAY WHICH SHALL CONSIST OF ALL THAT  
4 PORTION OF THE STATE HIGHWAY SYSTEM KNOWN AS STATE ROUTE TWENTY-THREE-A  
5 IN THE TOWN OF HUNTER, GREENE COUNTY, BEGINNING AT THE BOUNDARY BETWEEN  
6 THE TOWN OF JEWETT AND THE TOWN OF HUNTER, CONTINUING EASTERLY TO THE  
7 EASTERN BOUNDARY OF THE TOWN OF HUNTER AND THE TOWN OF CATSKILL; AND ALL  
8 THAT PORTION OF THE STATE HIGHWAY SYSTEM KNOWN AS STATE ROUTE TWO  
9 HUNDRED FOURTEEN IN THE TOWN OF HUNTER, GREENE COUNTY, BEGINNING AT THE  
10 BOUNDARY OF THE TOWN OF HUNTER AND THE TOWN OF SHANDAKEN, CONTINUING  
11 NORTHERLY TO ITS TERMINUS AT STATE ROUTE TWENTY-THREE-A; AND ALL THAT  
12 PORTION OF THE LOCAL HIGHWAY SYSTEM KNOWN AS COUNTY ROUTE EIGHTEEN IN  
13 THE TOWN OF HUNTER, GREENE COUNTY, BEGINNING AT THE INTERSECTION OF  
14 COUNTY ROUTE EIGHTEEN AND STATE ROUTE TWENTY-THREE-A, CONTINUING EASTER-  
15 LY TO ITS TERMINUS AT THE NYSDEC NORTH-SOUTH LAKE CAMPGROUNDS; AND ALL  
16 THAT PORTION OF THE LOCAL HIGHWAY SYSTEM KNOWN AS COUNTY ROUTE SIXTEEN  
17 BEGINNING AT THE INTERSECTION OF COUNTY ROUTE SIXTEEN AND STATE ROUTE  
18 TWENTY-THREE-A AND CONTINUING SOUTHEASTERLY ON COUNTY ROUTE SIXTEEN AND  
19 CONTINUING ON PLATTE CLOVE ROAD UNTIL THE EASTERN BOUNDARY OF THE TOWN  
20 OF HUNTER, GREENE COUNTY AND THE TOWN OF SAUGERTIES, ULSTER COUNTY; AND  
21 ALL THAT PORTION OF THE LOCAL HIGHWAY SYSTEM KNOWN AS COUNTY ROUTE TWEN-  
22 TY-FIVE IN THE TOWN OF HUNTER, GREENE COUNTY, BEGINNING AT THE INTER-  
23 SECTION OF COUNTY ROUTE TWENTY-FIVE AND STATE ROUTE TWENTY-THREE-A,  
24 CONTINUING NORTHERLY TO ITS TERMINUS AT COUNTY ROUTE TWENTY-THREE-C; AND  
25 ALL THAT PORTION OF THE LOCAL HIGHWAY SYSTEM KNOWN AS COUNTY ROUTE TWEN-
