AN ACT to amend the vehicle and traffic law, in relation to evaluating and ensuring the safety of driving with regard to wearing glasses or contacts capable of accessing the internet and mobile technology; in relation to prohibiting the use of such glasses or contacts while driving

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new
2 section 397-c to read as follows:

3 S 397-C. EVALUATING THE SAFETY OF DRIVING WHILE WEARING GLASSES OR
4 CONTACT LENSES CAPABLE OF ACCESSING THE INTERNET AND MOBILE TECHNOLOGY.
5 1. THE DEPARTMENT AND THE GOVERNOR'S TRAFFIC SAFETY COMMITTEE SHALL
6 EVALUATE THE SAFETY OF DRIVING WHILE WEARING GLASSES OR CONTACTS CAPABLE
7 OF ACCESSING THE INTERNET AND MOBILE TECHNOLOGY, INCLUDING BUT NOT
8 LIMITED TO, TEXTING, VIDEO, CELL PHONE ADDRESS BOOKS AND DATABASES.

9 2. ENTITIES SHALL SUBMIT A REPORT AND RECOMMENDATIONS INCLUDING WHETH-
10 ER SUCH TECHNOLOGY SHOULD BE BANNED FROM BEING WORN WHEN DRIVING; WHETH-
11 ER THE STATE SHOULD BAN THE ISSUANCE OF AUTO INSURANCE TO A DRIVER WHO
12 DOES NOT CERTIFY WITH HIS OR HER AUTOMOBILE INSURANCE CARRIER THAT SUCH
13 GLASSES WILL NOT BE WORN WHEN DRIVING; WHETHER THE VIOLATION OF SUCH
14 CERTIFICATION CAN BE USED TO PERMANENTLY DENY AUTO INSURANCE TO SUCH A
15 DRIVER; WHAT PENALTIES AND FINES SHOULD BE IMPOSED ON THOSE DRIVING WITH
16 SUCH A DISTRACTION FOR THE ROAD; AND WHAT LIMITS ON YOUNG AND NEW DRIV-
17 ERS SHOULD BE PUT IN PLACE WITH REGARD TO SUCH TECHNOLOGY; AND ANY OTHER
18 SUGGESTIONS THAT WILL IMPROVE TRAFFIC SAFETY IN THE STATE. THE REPORT IS
19 DUE NO LATER THAN FEBRUARY FIRST, TWO THOUSAND FIFTEEN.

20 S 2. The vehicle and traffic law is amended by adding a new section
21 397-d to read as follows:

22 S 397-D. DRIVING WHILE WEARING GLASSES OR CONTACTS CAPABLE OF ACCESS-
23 ING THE INTERNET AND MOBILE TECHNOLOGY PROHIBITED. 1. GLASSES OR
24 CONTACTS CAPABLE OF ACCESSING THE INTERNET ARE PROHIBITED WHILE DRIVING

1 A MOTOR VEHICLE UNTIL THE DEPARTMENT AND THE GOVERNOR'S TRAFFIC SAFETY
2 COMMITTEE ISSUE THE REPORT REQUIRED BY SECTION THREE HUNDRED NINETY-SEV-
3 EN-C OF THIS ARTICLE.

4 2. WEARING SUCH GLASSES OR CONTACTS WHILE PROHIBITED PURSUANT TO THIS
5 SECTION SHALL RESULT IN AN AUTOMATIC SIX MONTH SUSPENSION OF A DRIVER'S
6 LICENSE ISSUED PURSUANT TO THIS CHAPTER.

7 3. NO DRIVER UNDER THE AGE OF TWENTY-ONE SHALL WEAR SUCH GLASSES OR
8 CONTACTS, REGARDLESS OF THE AFOREMENTIONED STUDY GROUP'S RECOMMENDA-
9 TIONS.

10 4. ANY DRIVER ISSUED A LICENSE WITHIN THE PAST YEAR, PURSUANT TO THIS
11 CHAPTER, SHALL BE PROHIBITED FROM THE USE OF SUCH TECHNOLOGY WHILE DRIV-
12 ING; SUCH A VIOLATION SHALL RESULT IN THE AUTOMATIC SUSPENSION OF SUCH A
13 LICENSE FOR ONE YEAR.

14 5. A PERSON WHO HAS BEEN INJURED BY REASON OF ANY VIOLATION OF THIS
15 SECTION MAY BRING AN ACTION IN HIS OR HER OWN NAME AGAINST THE MANUFAC-
16 Turer OF SUCH TECHNOLOGY.

17 S 3. This act shall take effect immediately; provided however, section
18 two of this act shall take effect on the thirtieth day after it shall
19 have become a law.
