AN ACT to amend the highway law, in relation to the "St. Lawrence Wine Trail"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The section heading of section 343-k of the highway law, as
2 separately amended by chapters 344, 360 and 365 of the laws of 2013, is
3 amended, and a new subdivision 10 is added to read as follows:

4 Portions of the state highway system to be designated as the "Lake
5 Erie Wine Country Trail", the "Canandaigua Wine Trail", the "Cayuga Wine
6 Trail East", the "Cayuga Wine Trail West", the "Seneca Lake Wine Trail
7 East", the "Seneca Lake Wine Trail West", the "Keuka Lake Wine Trail",
8 the "Shawangunk Wine Trail", the "Dutchess Wine Trail", the "North Fork
9 Wine Trail", the "Hamptons Wine Trail", the "Long Island Wine Region",
10 the "Niagara Wine Trail Ridge", the "Niagara Wine Trail Lake", the "Lake
11 Ontario Wine Trail" [and], the "Adirondack Coast Wine Trail" AND THE
12 "ST. LAWRENCE WINE TRAIL".

13 10. ALL THAT PORTION OF THE STATE HIGHWAY SYSTEM BEGINNING AT THE
14 INTERSECTION OF STATE ROUTE 37 AND COUNTY ROUTE 6 IN THE TOWN OF
15 HAMMOND, AND CONTINUING NORTH ON COUNTY ROUTE 6 TO ITS INTERSECTION WITH
16 STATE ROUTE 37 IN THE CITY OF OGDENSBURG, AND CONTINUING EAST ON STATE
17 ROUTE 37 TO ITS INTERSECTION WITH COUNTY ROUTE 27 IN THE TOWN OF LISBON,
18 AND CONTINUING SOUTH ON COUNTY ROUTE 27 TO ITS INTERSECTION WITH COUNTY
19 ROUTE 10 IN THE TOWN OF LISBON, AND CONTINUING SOUTH ON COUNTY ROUTE 10
20 TO ITS INTERSECTION WITH STATE ROUTE 68 IN THE TOWN OF CANTON, AND
21 CONTINUING SOUTH ON STATE ROUTE 68 TO ITS INTERSECTION WITH UNITED
22 STATES ROUTE 11 IN THE VILLAGE OF CANTON, AND CONTINUING NORTH ON UNITED
23 STATES ROUTE 11 TO ITS INTERSECTION WITH STATE ROUTE 11-C IN THE UNIN-
24 CORPORATED AREA OF STOCKHOLM CENTER IN THE TOWN OF STOCKHOLM, AND
25 CONTINUING NORTH ON STATE ROUTE 11-C TO ITS INTERSECTION WITH COUNTY
26 ROUTE 53 IN THE UNINCORPORATED AREA OF WINTHROP IN THE TOWN OF STOCKHOLM
27 SHALL BE DESIGNATED AND KNOWN AS THE "ST. LAWRENCE WINE TRAIL".

28 S 2. This act shall take effect immediately.
