AN ACT to establish a temporary state commission to study child abuse prevention and make recommendations for the implementation of child abuse prevention programs across the state; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Legislative findings. The legislature hereby acknowledges 1 2 that child abuse is a continuing societal problem in the state affecting least 80,000 children each year. In recent years, there has been 3 at 4 research on the long-term effects of child abuse on the individual as 5 well as society. The vast majority of research has demonstrated that the б consequences of child abuse are grave, damaging and often spill over 7 into a person's adult life. Adverse effects have been identified in 8 maltreated children's physical, cognitive, emotional and social develop-9 ment.

Furthermore, the legislature finds that the failure to address child abuse through preventive measures not only harms a million children each year in this country, it imposes a tremendous cost to society. Like most states, New York spends a considerable amount of fiscal and human resources to treat the numerous consequences of child abuse and maltreatment. The failure to invest in prevention results in a significantly greater amount of resources needed to treat the outcomes.

17 S 2. A temporary state commission, to be known as the "commission of child abuse prevention", is hereby established to examine, evaluate and 18 19 make recommendations concerning child abuse prevention efforts in the 20 state. The commission shall consider the need for additional legislation as well as a stable source of funding for child abuse prevention 21 programs. Specific issues to be addressed by the commission shall 22 23 include home visitation programs and screening for families at risk of 24 child maltreatment.

25 S 3. The commission shall consist of thirteen members, to be appointed 26 as follows: three members to be appointed by the governor; three members

1 to be appointed by the temporary president of the senate; three members 2 to be appointed by the speaker of the assembly; two members to be 3 appointed by the minority leader of the senate; and two members to be 4 appointed by the minority leader of the assembly. The members shall have 5 demonstrated expertise in and experience with the field of child abuse 6 prevention. A chairperson and vice-chairperson of such commission shall 7 be elected by the majority of its members, all members being present.

8 S 4. The members of the commission shall receive no compensation for 9 their services, but shall be allowed their actual and necessary expenses 10 incurred in the performance of their duties hereunder.

11 S 5. The commission may employ and at pleasure remove such personnel 12 as it may deem necessary for the performance of its functions. Such 13 commission may meet and hold public and/or private hearings within or 14 without the state, and shall have all the powers of a legislative 15 committee pursuant to the legislative law.

16 S 6. For the accomplishment of its purposes, the commission shall be 17 authorized and empowered to undertake any studies, inquiries, surveys or 18 analyses it may deem relevant in cooperation with or by agreement with 19 any other public or private agency.

S 7. The commission shall make a report of its findings, including any recommendations for legislative action as it may deem necessary and appropriate, to the governor, the temporary president of the senate and the speaker of the assembly no later than one year after the effective date of this act.

25 S 8. This act shall take effect immediately and shall expire and be 26 deemed repealed two years after such effective date.
