AN ACT to amend the state finance law and the executive law, in relation to enacting the "American made flag act of 2014"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. This act shall be known and may be cited as the "American  
2     made flag act of 2014".  
3     S 2. Section 165 of the state finance law is amended by adding a new  
4     subdivision 9 to read as follows:  
5     9. FLAGS. ONLY FLAGS, REGARDLESS OF SIZE, THAT ARE ONE HUNDRED PERCENT  
6     MANUFACTURED IN THE UNITED STATES, FROM ARTICLES, MATERIALS, OR  
7     SUPPLIES, ONE HUNDRED PERCENT OF WHICH ARE GROWN, PRODUCED OR MANUFAC-  
8     TURED IN THE UNITED STATES, MAY BE PURCHASED FOR USE BY THE STATE  
9     GOVERNMENT. FOR THE PURPOSES OF THIS SUBDIVISION, THE TERM "FLAG" SHALL  
10    HAVE THE SAME MEANING AS PROVIDED IN SUBDIVISION ONE OF SECTION FOUR  
11    HUNDRED ONE OF THE EXECUTIVE LAW.  
12    S 3. Section 403 of the executive law is amended by adding a new  
13    subdivision 22 to read as follows:  
14    22. ALL FLAGS PURCHASED AND DISPLAYED AT ANY PUBLIC BUILDING SHALL BE  
15    MADE IN THE UNITED STATES FROM AMERICAN MATERIALS, AS PROVIDED IN SUBDI-  
16    VISION NINE OF SECTION ONE HUNDRED SIXTY-FIVE OF THE STATE FINANCE LAW.  
17    S 4. This act shall take effect on the one hundred eightieth day after  
18    it shall have become a law.
