AN ACT to amend the public authorities law and the executive law, in relation to database and reporting requirements for contracts with minority and women-owned businesses

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The public authorities law is amended by adding a new 2 section 2807 to read as follows:

- S 2807. DATABASE AND REPORTING REQUIREMENTS FOR CONTRACTS WITH MINORI-AND WOMEN-OWNED BUSINESSES. EVERY STATE AUTHORITY CONTINUED OR CREATED BY THIS CHAPTER OR ANY OTHER CHAPTER OF THE LAWS OF THE STATE OF 5 6 NEW YORK SHALL CREATE AND MAINTAIN A DATABASE TO TRACK THE ISSUANCE 7 TO MINORITY AND WOMEN-OWNED ENTERPRISES. FOR PURPOSES OF THIS 8 SECTION, A MINORITY OR WOMEN-OWNED BUSINESS ENTERPRISE SHALL BE DEFINED 9 IN SECTION THREE HUNDRED FOURTEEN OF THE EXECUTIVE LAW. EVERY STATE 10 AUTHORITY CONTINUED OR CREATED BY THIS CHAPTER OR ANY OTHER CHAPTER LAWS OF THE STATE OF NEW YORK SHALL COMPILE REPORTS ON THE ISSUANCE 11 OF SUCH CONTRACTS AND THE TOTAL NUMBER OF CONTRACTS 12 AWARDED. SHALL BE FILED ON A YEARLY BASIS WITH THE AUTHORITIES, BUDGET 13 REPORTS OFFICE, DEPARTMENT OF ECONOMIC DEVELOPMENT, AND OFFICE OF 14 AND BE DISPLAYED ON THE PUBLIC AUTHORITIES OR 15 WOMEN-OWNED BUSINESSES PUBLIC BENEFIT CORPORATION'S WEBSITE AND THE WEBSITE OF THE AUTHORITIES' 16 BUDGET OFFICE, PROVIDED, HOWEVER THAT ALL PROPRIETARY INFORMATION SHALL 17 18 BE KEPT OFFLINE.
 - S 2. The executive law is amended by adding a new section 315-a to read as follows:

21 S 315-A. DATABASE AND REPORTING REQUIREMENTS FOR CONTRACTS WITH MINOR-22 ITY AND WOMEN-OWNED BUSINESSES. ALL STATE AGENCIES SHALL CREATE MAINTAIN A DATABASE TO TRACK THE ISSUANCE OF CONTRACTS TO MINORITY AND 23 24 WOMEN-OWNED ENTERPRISES. FOR PURPOSES OF THIS SECTION, A MINORITY OR 25 WOMEN-OWNED BUSINESS ENTERPRISE SHALL BE DEFINED AS IN SECTION THREE 26 HUNDRED FOURTEEN OF THIS ARTICLE. STATE AGENCIES SHALL COMPILE 27 THE ISSUANCE OF SUCH CONTRACTS AND THE TOTAL NUMBER OF CONTRACTS

AWARDED. SUCH REPORTS SHALL BE FILED ON A YEARLY BASIS WITH THE DEPARTMENT OF ECONOMIC DEVELOPMENT, OFFICE OF MINORITY AND WOMEN-OWNED BUSINESSES AND BE DISPLAYED ON THE STATE AGENCIES' WEBSITE, PROVIDED HOWEVER, ALL PROPRIETARY INFORMATION SHALL BE KEPT OFFLINE.

S 3. This act shall take effect on the ninetieth day after it shall have become a law; provided, however, that the amendment made to article 7 15-A of the executive law by section two of this act shall not affect the expiration of such article and shall be deemed repealed therewith.
