AN ACT to amend the criminal procedure law, in relation to the methods of fixing bail

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Paragraphs (a) and (b) of subdivision 2 of section 520.10  
2     of the criminal procedure law, as amended by chapter 784 of the laws of  
3     1972, are amended to read as follows:  
4     (a) A court may designate the amount of the bail without designating  
5     the [form or] forms in which it may be posted. In such case, the bail  
6     may be posted in either of the forms specified in paragraphs (g) and (h)  
7     of subdivision one OF THIS SECTION;  
8     (b) The court may direct that the bail be posted in [any one of] two  
9     or more of the forms specified in subdivision one OF THIS SECTION,  
10    designated in the alternative, and may designate different amounts vary-  
11    ing with the forms[;].  
12    S 2. This act shall take effect immediately.
