- AN ACT to amend the election law and the public officers law, in relation to the delegate selection process for a constitutional convention

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as 2 the "People's Convention Reform Act".

3 S 2. Legislative findings and declaration. The legislature hereby 4 finds that it is only at constitutional conventions that ordinary citizens have the opportunity to reconsider the fundamental structure of 5 state government and to assess its effectiveness in light of the current 6 7 social, economic and political conditions of the day. In providing for 8 periodic constitutional conventions, the framers of our current document acknowledged the need to have a dynamic, living and breathing statement 9 how government should operate and what limits or controls it should 10 of have on our individual pursuit of life, liberty and happiness. 11

12 Unfortunately the last two constitutional conventions were dominated 13 the politically connected (two-thirds of the delegates to the 1938 by convention and about 83% of the 1967 delegates were present or 14 former 15 elected or party officials). To ensure the success of future conventions, we must limit the participation of elected and party offi-16 cials so that the conventions can be "People's Conventions" and so the 17 18 voices of all New Yorkers, not just those of special interests, can be 19 heard.

20 The legislature further finds and declares, in furtherance of estab-21 lishing a meaningful convention process, that:

(a) delegates to the convention should be involved and concerned citizens and not elected officials, lobbyists, or party chairmen;

(b) prior to the convening of the convention, and solely as an aid to delegates, there should be appointed a preparatory commission with adequate time to study the issues, establish a proposed initial agenda

and procedures, and prepare position papers, with ongoing information to 1 2 and participation of the public; 3 (C) insofar as possible, procedures should be established in both the 4 selection of delegates and in the running of the convention that will 5 reduce partisanship; and 6 (d) reasonable time limits should be placed on the length of the 7 convention and its costs, so as to assure that the operations of the convention are not a burden on taxpayers, and that the convention may 8 9 enjoy maximum citizen participation. 10 To ensure that future constitutional conventions are truly People's Conventions, we hereby find and declare that the statutory reforms of 11 12 the delegate selection process contained in this act must be enacted. S 3. Section 1-104 of the election law is amended by adding a new 13 subdivision 38 to read as follows: 14 15 38. THE TERM "NONPARTISAN ELECTION" MEANS A PRIMARY, GENERAL OR SPECIAL ELECTION IN WHICH CANDIDATES SHALL RUN WITHOUT PARTY LABEL, AND 16 17 ARE PROHIBITED FROM DESIGNATING OR NOMINATING CANDI-POLITICAL PARTIES 18 DATES. 19 S 4. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, 23 IN THE EVENT THAT A PERSON SERVING AS CHAIRMAN, SECRETARY, OR TREASURER 24 STATE OR COUNTY COMMITTEE OF A POLITICAL PARTY IS ELECTED TO AND OF А 25 SWORN AS A DELEGATE TO A STATE CONSTITUTIONAL CONVENTION, SUCH PERSON 26 SHALL BE DEEMED TO HAVE RESIGNED FROM HIS OR HER POLITICAL PARTY POSI-27 TION AND THE PROVISIONS OF THIS ARTICLE FOR THE FILLING OF VACANCIES IN 28 SUCH POSITION SHALL APPLY. 29 S 5. NOTWITHSTANDING THE PROVISIONS OF SECTION 6-136 OF THIS ARTICLE OR OTHER PROVISION OF LAW, ALL PETITIONS FOR THE DESIGNATION FOR NOMI-41 ANY 42 NATION OF A CONSTITUTIONAL CONVENTION DELEGATE FROM A SENATE DISTRICT 43 SIGNED BY NOT LESS THAN ONE THOUSAND ENROLLED VOTERS OF SUCH MUST BE44 SENATE DISTRICT AND ALL PETITIONS FOR THE DESIGNATION FOR NOMINATION OF 45 STATEWIDE, AT-LARGE CONSTITUTIONAL CONVENTION DELEGATE MUST BE SIGNED Α BY NOT LESS THAN TEN THOUSAND ENROLLED VOTERS OF THE STATE, OF WHOM NOT 46 47 ONE HUNDRED MUST RESIDE IN EACH OF TEN OF THE CONGRESSIONAL LESS THAN 48 DISTRICTS OF THE STATE. 49 4. THE FORM OF THE DESIGNATING PETITION USED TO MAKE A DESIGNATION IN50 PRIMARY SHALL BE SUBSTANTIALLY IN THE FORM PRESCRIBED IN NONPARTISAN Α 51 SECTION 6-132 OF THIS ARTICLE, EXCEPT THAT NO REFERENCE SHALL BE MADE TO 52 ANY POLITICAL PARTY THEREIN. 53 5. UNLESS OTHERWISE PROVIDED IN THIS SECTION, THE SECTIONS OF LAW 54 APPLICABLE TO DESIGNATING PETITIONS FOR NONPARTISAN PRIMARY ELECTIONS 55 SHALL BE THOSE PRESCRIBED BY THIS ARTICLE.

6. ALL REGISTERED VOTERS, REGARDLESS OF PARTY AFFILIATION OR LACK
 THEREOF, SHALL BE PERMITTED TO VOTE IN THE NONPARTISAN PRIMARY ELECTION
 FOR THE NOMINATION OF CANDIDATES FOR THE OFFICE OF DELEGATE TO THE
 CONSTITUTIONAL CONVENTION. SUITABLE PROVISIONS MUST BE MADE SO THAT EACH
 ELECTOR MAY VOTE FOR UP TO THREE OF ANY SENATE DISTRICT CONSTITUTIONAL
 CONVENTION DELEGATE CANDIDATES AND UP TO FIFTEEN OF ANY STATEWIDE,
 AT-LARGE CONSTITUTIONAL CONVENTION DELEGATE CANDIDATES.

8 7. UPON THE CANVASS OF VOTES IN A NONPARTISAN PRIMARY THE NINE CONSTI-9 TUTIONAL CONVENTION DELEGATE CANDIDATES RECEIVING THE HIGHEST NUMBER OF 10 VOTES IN EACH SENATE DISTRICT AND THE THIRTY CANDIDATES RECEIVING THE 11 HIGHEST NUMBER OF VOTES AS STATEWIDE, AT-LARGE CONSTITUTIONAL CONVENTION 12 DELEGATES SHALL BE CERTIFIED AS NOMINATED AND SHALL RUN IN THE GENERAL 13 ELECTION HELD SUBSEQUENT TO THE PRIMARY WITHOUT PARTY IDENTIFICATION.

14 8. NO CANDIDATE FOR DELEGATE TO A CONSTITUTIONAL CONVENTION SHALL IN 15 ANY WAY USE OR ALLOW HIMSELF OR HERSELF TO BE ASSOCIATED WITH A PARTY 16 LABEL IN EITHER THE PRIMARY OR GENERAL ELECTION.

9. ONCE A PERSON ANNOUNCES HIS OR HER INTENTION TO BE A CANDIDATE FOR 17 ELECTION TO THE POSITION OF DELEGATE TO THE CONSTITUTIONAL CONVENTION 18 19 AND UNTIL SUCH TIME AS THAT PERSON IS NO LONGER A CANDIDATE OR UNTIL HIS 20 OR HER SERVICE AS A DELEGATE ENDS, WHICHEVER OCCURS LATER, SUCH CANDI-21 DATE FOR DELEGATE TO A CONSTITUTIONAL CONVENTION SHALL NOT (A) PARTIC-IPATE IN ANY PARTISAN POLITICAL PARTY ACTIVITIES, EXCEPT 22 THAT SUCH CANDIDATE MAY REGISTER TO VOTE AS A MEMBER OF ANY POLITICAL PARTY AND 23 MAY VOTE IN ANY PARTY PRIMARY FOR CANDIDATES FOR NOMINATION OF THE PARTY 24 25 IN WHICH HE OR SHE IS REGISTERED TO VOTE; (B) CAMPAIGN OR PUBLICLY REPRESENT OR ADVERTISE HIMSELF OR HERSELF AS A MEMBER OF ANY POLITICAL 26 PARTY; (C) ENDORSE ANY CANDIDATE OR POLITICAL PARTY; (D) ACCEPT THE 27 ENDORSEMENT OF ANY POLITICAL PARTY; OR (E) SOLICIT OR ACCEPT CONTRIB-28 UTIONS FROM ANY POLITICAL PARTY COMMITTEE, POLITICAL ACTION COMMITTEE OR 29 30 POLITICAL COMMITTEE PURSUANT TO SUBDIVISION ELEVEN OF SECTION 14-114 OF 31 THIS CHAPTER.

10. WITHIN ONE HUNDRED EIGHTY DAYS OF THE EFFECTIVE DATE OF THIS SECTION, THE STATE BOARD OF ELECTIONS SHALL PROMULGATE RULES AND REGU-LATIONS CONSISTENT WITH THIS SECTION TO EFFECTUATE THE PURPOSES AND POLICIES HEREOF.

36 S 6. Section 14-100 of the election law is amended by adding a new 37 subdivision 15 to read as follows:

15. "POLITICAL ACTION COMMITTEE" MEANS ANY COMMITTEE ESTABLISHED, FINANCED, MAINTAINED OR CONTROLLED BY ANY PERSON, GROUP OR ENTITY FOR THE PURPOSE OF SUPPORTING CANDIDATES FOR ELECTED POLITICAL OFFICE AND/OR OTHER POLITICAL PARTY OR POLITICAL COMMITTEES BY MAKING CONTRIBUTIONS TO SUCH CANDIDATES AND/OR THEIR POLITICAL CAMPAIGN COMMITTEES OR BY MAKING CONTRIBUTIONS TO OTHER POLITICAL PARTY OR OTHER POLITICAL COMMITTEES, AND DOES NOT MAKE DIRECT EXPENDITURES ON BEHALF OF CANDIDATES.

45 S 7. Section 14-114 of the election law is amended by adding a new 46 subdivision 11 to read as follows:

11. NO POLITICAL PARTY COMMITTEE, POLITICAL ACTION COMMITTEE OR POLITICAL COMMITTEE SHALL CONTRIBUTE TO ANY CANDIDATE FOR DELEGATE TO A
CONSTITUTIONAL CONVENTION FOR EITHER THE PRIMARY OR GENERAL ELECTION.
NOR SHALL ANY CANDIDATE FOR DELEGATE TO A CONSTITUTIONAL CONVENTION
SOLICIT OR ACCEPT CONTRIBUTIONS FROM ANY POLITICAL PARTY COMMITTEE,
POLITICAL ACTION COMMITTEE OR POLITICAL COMMITTEE FOR EITHER THE PRIMARY
OR GENERAL ELECTION.

IT SHALL BE THE DUTY OF THE SECRETARY OF STATE TO PROVIDE A DOCKET 24 2. 25 TO BE KNOWN AS THE DOCKET OF CONSTITUTIONAL CONVENTION APPEARANCES, WITH 26 APPROPRIATE BLANKS AND INDICES, AND TO FORTHWITH ENTER THEREIN THE NAMES 27 OF THE PERSONS SO RETAINED OR EMPLOYED AND OF THE PERSONS, FIRMS, CORPO-28 RATIONS OR ASSOCIATIONS RETAINING OR EMPLOYING THEM, TOGETHER WITH А 29 BRIEF DESCRIPTION OF THE PROPOSED CONSTITUTIONAL AMENDMENT OR AMENDMENTS REFERENCE TO WHICH THE SERVICE IS TO BE RENDERED, WHICH DOCKET SHALL 30 IN 31 BE OPEN TO PUBLIC INSPECTION.

UPON THE TERMINATION OF SUCH RETAINER OR EMPLOYMENT THE FACT OF 33 SUCH TERMINATION, WITH THE DATE THEREOF, SHALL BE ENTERED IN THE DOCKET 34 BY THE SECRETARY OF STATE UPON RECEIVING WRITTEN NOTICE TO THAT EFFECT 35 FROM SUCH PERSON OR FROM THE PERSON, FIRM, CORPORATION OR ASSOCIATION IN 36 WHOSE BEHALF SUCH SERVICE HAS BEEN RENDERED.

4. NO PERSON RETAINED OR EMPLOYED TO PROMOTE OR OPPOSE, DIRECTLY OR

AMENDMENTS BY A CONSTITUTIONAL CONVENTION SHALL BE ELIGIBLE TO SERVE AS

5. NO PERSON, FIRM, CORPORATION OR ASSOCIATION SHALL RETAIN OR EMPLOY
ANY PERSON TO PROMOTE OR OPPOSE ANY PROPOSED CONSTITUTIONAL AMENDMENT OR
AMENDMENTS FOR COMPENSATION CONTINGENT IN WHOLE OR IN PART UPON THE
ADOPTION OR DEFEAT OF ANY SUCH AMENDMENT OR AMENDMENTS BY THE CONSTITUTIONAL CONVENTION, AND NO PERSON SHALL ACCEPT ANY SUCH EMPLOYMENT OR
RENDER ANY SUCH SERVICE FOR COMPENSATION CONTINGENT UPON SUCH ADOPTION
OR DEFEAT.

6. NO PERSON SHALL FOR COMPENSATION ENGAGE IN PROMOTING OR OPPOSING ANY PROPOSED CONSTITUTIONAL AMENDMENT OR AMENDMENTS BY SUCH CONSTITU-TIONAL CONVENTION EXCEPT UPON APPEARANCE ENTERED IN ACCORDANCE WITH THE FOREGOING PROVISIONS OF THIS SECTION.

IT SHALL BE THE DUTY OF EVERY PERSON, FIRM, CORPORATION, PUBLIC OR 53 PRIVATE, OR ASSOCIATION, (WHETHER OR NOT REQUIRED TO FILE PURSUANT TO 54 THE PROVISIONS OF SUBDIVISION ONE OF THIS SECTION), NOT LATER THAN APRIL 55 FIFTEENTH, IN ANY YEAR IN WHICH A CONSTITUTIONAL CONVENTION IS CONVENED 56 AND IN WHICH A PROPOSED CONSTITUTIONAL AMENDMENT OR AMENDMENTS BY A

CONSTITUTIONAL CONVENTION IS PUT TO THE VOTERS, TO FILE IN THE OFFICE OF 1 2 THE SECRETARY OF STATE AN ITEMIZED STATEMENT VERIFIED BY THE OATH OF 3 SUCH PERSON, OR IN CASE OF A FIRM BY THE OATH OF A MEMBER THEREOF, OR IN CASE OF A DOMESTIC CORPORATION OR ASSOCIATION BY THE OATH OF AN OFFICER 4 5 THEREOF, OR IN CASE OF A FOREIGN CORPORATION OR ASSOCIATION BY THE OATH 6 AN OFFICER OR AGENT THEREOF, SHOWING IN DETAIL ALL EXPENSES PAID, OF 7 INCURRED OR PROMISED DIRECTLY OR INDIRECTLY IN EACH YEAR THROUGH THE 8 CONCLUSION OF THE YEAR IN WHICH ANY PROPOSED CONSTITUTIONAL AMENDMENT OR 9 AMENDMENTS BY A CONSTITUTIONAL CONVENTION HAVE BEEN PUT TO THE VOTERS, 10 IN CONNECTION WITH PROMOTING OR OPPOSING ANY CONSTITUTIONAL AMENDMENT OR 11 AMENDMENTS WHICH MAY BE PROPOSED AT SUCH CONSTITUTIONAL CONVENTION, WITH THE NAMES OF THE PAYEES AND THE AMOUNT PAID TO EACH, 12 INCLUDING ALL PAID, INCURRED OR PROMISED TO PERSONS EMPLOYED OR 13 DISBURSEMENTS 14 RETAINED, AND ALSO SPECIFYING THE NATURE OF SUCH CONSTITUTIONAL AMEND-15 MENT OR AMENDMENTS, AND THE INTEREST THEREIN OF SUCH PERSON, FIRM, CORPORATION OR ASSOCIATION; PROVIDED, HOWEVER, NO SUCH ITEMIZED STATE-16 MENT NEED BE FILED IF THE TOTAL OF SUCH ITEMIZED EXPENSES IS LESS THAN 17 18 TWO HUNDRED FIFTY DOLLARS.

19 8. THE PROVISIONS OF THIS SECTION SHALL NOT APPLY TO THE STATE NOR 20 SHALL SUBDIVISIONS ONE, FIVE AND NINE OF THIS SECTION APPLY TO A COUNTY, 21 CITY, TOWN, VILLAGE, PUBLIC BOARD OR INSTITUTION, OR THEIR AGENTS OR 22 EMPLOYEES; NOR SHALL THE PROVISIONS OF THIS SECTION BE CONSTRUED AS 23 AFFECTING PROFESSIONAL SERVICES IN DRAFTING A PROPOSED CONSTITUTIONAL 24 AMENDMENT OR AMENDMENTS OR IN ADVISING CLIENTS OR IN RENDERING OPINIONS 25 THE CONSTRUCTION AND EFFECT OF ANY CONSTITUTIONAL AMENDMENT OR AS TO 26 AMENDMENTS WHICH MAY BE PROPOSED AT SUCH CONVENTION WHERE SUCH PROFES-27 SIONAL SERVICE IS NOT OTHERWISE CONNECTED WITH CONSTITUTIONAL CONVENTION 28 ACTION.

9. ON OR BEFORE APRIL TWENTY-FOURTH IN ANY YEAR IN WHICH A CONSTITUTIONAL CONVENTION IS CONVENED, THE SECRETARY OF STATE SHALL FURNISH TO
EACH DELEGATE TO SUCH CONVENTION A SUMMARY OF THE INFORMATION CONTAINED
IN THE DOCKET OF CONSTITUTIONAL CONVENTION APPEARANCES, AND ON OR BEFORE
SUCH DATE SHALL ALSO TRANSMIT TO THE PRESIDENT OF SUCH CONSTITUTIONAL
CONVENTION A COPY OF EVERY STATEMENT FILED IN HIS OR HER OFFICE UP TO
AND INCLUDING SUCH DATE PURSUANT TO SUBDIVISION SIX OF THIS SECTION.

10. EVERY PERSON, EVERY MEMBER OF ANY FIRM, AND EVERY ASSOCIATION OR 36 37 CORPORATION VIOLATING ANY PROVISION OF THIS SECTION AND EVERY PERSON 38 CAUSING OR PARTICIPATING IN A VIOLATION THEREOF SHALL BE GUILTY OF A 39 MISDEMEANOR AND, IN CASE OF AN INDIVIDUAL, SHALL BE PUNISHABLE BY IMPRI-40 SONMENT IN A PENITENTIARY OR COUNTY JAIL FOR NOT MORE THAN ONE YEAR OR BY A FINE OF NOT MORE THAN ONE THOUSAND DOLLARS OR BY BOTH, AND, IN CASE 41 OF AN ASSOCIATION OR CORPORATION, BY A FINE OF NOT MORE THAN ONE THOU-42 43 SAND DOLLARS. IN ADDITION TO THE PENALTIES HEREINBEFORE IMPOSED ANY 44 CORPORATION OR ASSOCIATION FAILING TO FILE THE STATEMENT OF EXPENSES 45 PRESCRIBED BY THIS SECTION SHALL FORFEIT TO THE PEOPLE OF THE STATE OF NEW YORK THE SUM OF ONE HUNDRED DOLLARS PER DAY FOR EACH DAY FOLLOWING 46 47 THE EXPIRATION OF THIRTY DAYS AFTER THE TIME FIXED BY SUBDIVISION SIX OF 48 THIS SECTION FOR FILING SUCH STATEMENT, TO BE RECOVERED IN AN ACTION TO 49 BE BROUGHT BY THE ATTORNEY GENERAL.

50 S 9. Section 30 of the public officers law is amended by adding a new 51 subdivision 1-a to read as follows:

52 1-A. WHENEVER ANY STATE OR LOCAL OFFICER, AS THOSE TERMS ARE DEFINED 53 IN SECTION TWO OF THIS CHAPTER, IS ELECTED AND SWORN AS A DELEGATE TO A 54 STATE CONSTITUTIONAL CONVENTION, SUCH OFFICIAL WILL BE DEEMED TO HAVE 55 VACATED HIS OR HER STATE OR LOCAL OFFICE AND THE SAID OFFICE WILL BE 1 DEEMED VACANT FOR PURPOSES OF THE NOMINATION AND APPOINTMENT OF A 2 SUCCESSOR.

3 10. No later than 180 days prior to the convening of the constitu-S 4 tional convention, and solely as an aid to delegates, there shall be appointed a constitutional convention preparatory commission whose purpose shall be to study the issues, establish a proposed initial agen-5 6 7 da and procedures, and prepare position papers, with ongoing information 8 to and participation of the public. Members of the commission shall be appointed as follows: two each by the governor, the majority leader of 9 10 the senate and the speaker of the assembly, and one each by the minority leader of the senate and the minority leader of the assembly. 11 The 12 members shall elect a chair.

13 Severability. If any provision of this act, or the application S 11. 14 thereof to any person or circumstance, shall be adjudged by any court of 15 competent jurisdiction to be invalid or unconstitutional, such judgment 16 shall not affect, impair or invalidate the remainder thereof, but shall 17 be confined in its operation to the provision of this act, or in its application to the person or circumstance, directly involved in the 18 19 controversy in which such judgment shall have been rendered.

20 S 12. This act shall take effect immediately.
