



1 OF THE MINOR CHILD. THE WRITTEN INSTRUMENT APPOINTING A SHORT-TERM MILI-  
2 TARY SERVICE GUARDIAN SHALL BE DATED AND SHALL IDENTIFY THE APPOINTING  
3 PARENT, THE OTHER LIVING PARENT, THE MINOR, AND THE PERSON APPOINTED TO  
4 BE THE SHORT-TERM MILITARY SERVICE GUARDIAN. THE WRITTEN INSTRUMENT  
5 SHALL BE SIGNED BY, OR AT THE DIRECTION OF, THE APPOINTING PARENT IN THE  
6 PRESENCE OF AT LEAST TWO CREDIBLE WITNESSES, AT LEAST EIGHTEEN YEARS OF  
7 AGE, NEITHER OF WHOM IS RELATED TO THE PARENT NOR THE PERSON APPOINTED  
8 AS THE SHORT-TERM MILITARY SERVICE GUARDIAN. THE PERSON APPOINTED AS THE  
9 SHORT-TERM MILITARY SERVICE GUARDIAN SHALL ALSO SIGN THE WRITTEN INSTRU-  
10 MENT, BUT NEED NOT SIGN AT THE SAME TIME AS THE APPOINTING PARENT.

11 2. A PARENT SHALL NOT APPOINT A SHORT-TERM MILITARY SERVICE GUARDIAN  
12 OF A MINOR CHILD IF THE CHILD HAS ANOTHER LIVING PARENT, ADOPTIVE PARENT  
13 OR ADJUDICATED PARENT:

14 (A) WHO HAS JOINT CUSTODY OF THE CHILD,  
15 (B) WHOSE PARENTAL RIGHTS HAVE NOT BEEN TERMINATED,  
16 (C) WHOSE WHEREABOUTS ARE KNOWN, AND  
17 (D) WHO IS WILLING AND ABLE TO MAKE AND CARRY OUT DAY-TO-DAY CHILD  
18 CARE DECISIONS CONCERNING THE MINOR, UNLESS THE NON-APPOINTING PARENT  
19 CONSENTS TO THE APPOINTMENT BY SIGNING THE WRITTEN INSTRUMENT OF  
20 APPOINTMENT.

21 3. THE APPOINTING PARENT SHALL ATTACH TO THE WRITTEN INSTRUMENT HIS OR  
22 HER SWORN STATEMENT OF MAILING THAT STATES HE OR SHE SENT, NO LATER THAN  
23 TWO DAYS AFTER THE WRITTEN INSTRUMENT WAS COMPLETED, COPIES OF HIS OR  
24 HER SWORN STATEMENT OF MAILING AND THE WRITTEN INSTRUMENT CONTAINING ALL  
25 REQUIRED SIGNATURES AND DATES BY CERTIFIED OR REGISTERED MAIL, RETURN  
26 RECEIPT REQUESTED TO:

27 (A) THE LAST KNOWN ADDRESS OF THE OTHER LIVING PARENT,  
28 (B) THE COURT WHICH ISSUED THE ORDER THAT AWARDED PHYSICAL CUSTODY OF  
29 THE CHILD TO THE APPOINTING PARENT,  
30 (C) THE COURT (IF DIFFERENT FROM THE COURT THAT AWARDED PHYSICAL  
31 CUSTODY OF THE CHILD TO THE APPOINTING PARENT) WHICH ISSUED THE LAST  
32 ORDER THAT CONCERNS THE CHILD, THE CHILD'S SUPPORT, OR CUSTODY OF OR  
33 VISITATION WITH THE CHILD, AND  
34 (D) IF THERE IS NO COURT ORDER, THEN TO THE COURT CLERK IN THE COUNTY  
35 IN WHICH THE CHILD RESIDES.

36 4. THE APPOINTMENT OF THE SHORT-TERM MILITARY SERVICE GUARDIAN IS  
37 EFFECTIVE IMMEDIATELY UPON THE DATE THE WRITTEN INSTRUMENT IS EXECUTED,  
38 UNLESS THE WRITTEN INSTRUMENT PROVIDES FOR THE APPOINTMENT TO BECOME  
39 EFFECTIVE UPON A LATER SPECIFIED DATE OR EVENT. THE APPOINTMENT IS  
40 EFFECTIVE WITHOUT COURT APPROVAL. THE SHORT-TERM MILITARY SERVICE GUARD-  
41 IAN SHALL HAVE AUTHORITY TO ACT AS GUARDIAN OF THE MINOR AS PROVIDED IN  
42 ARTICLE SIX OF THIS CHAPTER FOR A PERIOD OF ONE HUNDRED EIGHTY DAYS FROM  
43 THE DATE THE APPOINTMENT IS EFFECTIVE UNLESS THE WRITTEN INSTRUMENT  
44 PROVIDES FOR THE APPOINTMENT TO TERMINATE UPON AN EARLIER SPECIFIED DATE  
45 OR EVENT. ONLY ONE WRITTEN INSTRUMENT APPOINTING A SHORT-TERM MILITARY  
46 SERVICE GUARDIAN MAY BE IN FORCE AT ANY GIVEN TIME, BUT A WRITTEN  
47 INSTRUMENT PREPARED IN ACCORDANCE WITH THE SAME REQUIREMENTS OF THIS  
48 SECTION MAY REAPPOINT THE SHORT-TERM MILITARY SERVICE GUARDIAN OR NAME A  
49 DIFFERENT SUCCESSOR SHORT-TERM MILITARY SERVICE GUARDIAN FOR AN ADDI-  
50 TIONAL PERIOD OF ONE HUNDRED EIGHTY DAYS. A REAPPOINTMENT OR THE  
51 APPOINTMENT OF A SUCCESSOR SHORT-TERM MILITARY SERVICE GUARDIAN MAY BE  
52 ACCOMPLISHED BY A WRITTEN INSTRUMENT COMPLETED BEFORE THE EXPIRATION OF  
53 THE FIRST WRITTEN INSTRUMENT.

54 5. EVERY APPOINTMENT OF A SHORT-TERM MILITARY SERVICE GUARDIAN MAY BE  
55 AMENDED OR REVOKED BY THE APPOINTING PARENT OF THE MINOR AT ANY TIME AND  
56 IN ANY MANNER COMMUNICATED TO THE SHORT-TERM MILITARY SERVICE GUARDIAN

OR TO ANY OTHER PERSON. ANY PERSON OTHER THAN THE SHORT-TERM MILITARY SERVICE GUARDIAN TO WHOM A REVOCATION OR AMENDMENT IS COMMUNICATED OR DELIVERED SHALL MAKE ALL REASONABLE EFFORTS TO INFORM THE SHORT-TERM MILITARY SERVICE GUARDIAN OF THAT FACT AS PROMPTLY AS POSSIBLE.

6. THE APPOINTMENT OF A SHORT-TERM MILITARY SERVICE GUARDIAN OR SUCCESSOR SHORT-TERM MILITARY SERVICE GUARDIAN DOES NOT AFFECT THE RIGHTS OF THE OTHER PARENT IN THE MINOR.

7. THE WRITTEN INSTRUMENT APPOINTING A SHORT-TERM MILITARY SERVICE GUARDIAN MAY, BUT NEED NOT, BE IN THE FOLLOWING FORM:

APPOINTMENT OF SHORT-TERM MILITARY SERVICE GUARDIAN

IT IS IMPORTANT TO READ THE FOLLOWING INSTRUCTIONS

BY PROPERLY COMPLETING THIS FORM, A PARENT OF THE MINOR CHILD IS APPOINTING A SHORT-TERM MILITARY SERVICE GUARDIAN OF A CHILD OF THE PARENT FOR A PERIOD OF UP TO ONE HUNDRED EIGHTY (180) DAYS. A SEPARATE FORM SHOULD BE COMPLETED FOR EACH CHILD. THE PERSON APPOINTED AS THE SHORT-TERM MILITARY SERVICE GUARDIAN MUST SIGN THE FORM, BUT NEED NOT DO SO AT THE SAME TIME AS THE PARENT OR PARENTS. THIS FORM MAY BE USED TO REAPPOINT A SHORT-TERM MILITARY SERVICE GUARDIAN OR TO APPOINT A SUCCESSOR SHORT-TERM MILITARY SERVICE GUARDIAN SO AS TO EXTEND THE ENTIRE TIME OF THE GUARDIANSHIP TO A PERIOD OF THREE HUNDRED SIXTY (360) DAYS. BOTH LIVING PARENTS OF A CHILD MAY TOGETHER APPOINT A SHORT-TERM MILITARY SERVICE GUARDIAN OF THE CHILD FOR A PERIOD OF UP TO THREE HUNDRED SIXTY (360) DAYS THROUGH THE USE OF THIS FORM. IF THE SHORT-TERM MILITARY SERVICE GUARDIAN IS APPOINTED BY BOTH LIVING PARENTS OF THE CHILD, THE PARENTS NEED NOT SIGN THE FORM AT THE SAME TIME.

55 S 92. DUTIES OF A SHORT-TERM MILITARY SERVICE GUARDIAN OF A MINOR. 1.  
56 IMMEDIATELY UPON THE EFFECTIVE DATE OR THE APPOINTMENT OF A SHORT-TERM

1 MILITARY SERVICE GUARDIAN, THE SHORT-TERM MILITARY SERVICE GUARDIAN  
2 SHALL ASSUME ALL DUTIES AS SHORT-TERM MILITARY SERVICE GUARDIAN OF THE  
3 MINOR AS PROVIDED IN THIS SECTION. THE SHORT-TERM MILITARY SERVICE GUAR-  
4 DIAN OF THE PERSON SHALL HAVE AUTHORITY TO ACT AS SHORT-TERM MILITARY  
5 SERVICE GUARDIAN WITHOUT DIRECTION OF COURT, FOR THE DURATION OF THE  
6 APPOINTMENT WHICH IN NO CASE SHALL EXCEED A PERIOD OF ONE HUNDRED EIGHTY  
7 DAYS. THE AUTHORITY OF THE SHORT-TERM MILITARY SERVICE GUARDIAN MAY BE  
8 LIMITED OR TERMINATED BY A COURT OF COMPETENT JURISDICTION.

9 2. UNLESS FURTHER SPECIFICALLY LIMITED BY THE INSTRUMENT APPOINTING  
10 THE SHORT-TERM MILITARY SERVICE GUARDIAN, A SHORT-TERM MILITARY SERVICE  
11 GUARDIAN SHALL HAVE THE AUTHORITY TO ACT AS A GUARDIAN OF THE PERSON OF  
12 A MINOR AS PRESCRIBED IN ARTICLE SIX OF THIS CHAPTER, BUT SHALL NOT HAVE  
13 ANY AUTHORITY TO ACT AS GUARDIAN OF THE ESTATE OF A MINOR, EXCEPT THAT A  
14 SHORT-TERM MILITARY SERVICE GUARDIAN SHALL HAVE THE AUTHORITY TO APPLY  
15 FOR AND RECEIVE ON BEHALF OF THE MINOR BENEFITS TO WHICH THE CHILD MAY  
16 BE ENTITLED FROM OR UNDER FEDERAL, STATE OR LOCAL ORGANIZATIONS OR  
17 PROGRAMS.

18 S 2. The military law is amended by adding a new section 255 to read  
19 as follows:

20 S 255. SHORT-TERM MILITARY SERVICE GUARDIAN. NOTWITHSTANDING ANY LAW,  
21 RULE OR REGULATION TO THE CONTRARY, CHILD CUSTODY PROCEEDINGS FILED IN A  
22 COURT OF COMPETENT JURISDICTION IN THIS STATE, INVOLVING A SHORT-TERM  
23 MILITARY SERVICE GUARDIAN SHALL BE GOVERNED BY ARTICLE SIX-A OF THE  
24 DOMESTIC RELATIONS LAW.

25 S 3. This act shall take effect on the one hundred twentieth day after  
26 it shall have become a law.
