AN ACT to amend the public service law and the public authorities law, in relation to requiring that the public service commission ensure equitable treatment of all retail customers of electric corporations and municipal electric utilities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 21 of section 66 of the public service law, as added by chapter 718 of the laws of 1980, is amended to read as follows: 21. The commission shall require every electric corporation to submit storm plans to the commission for review and approval at such times and in such detail and form as the commission shall require, provided, however, that the same shall be filed at least annually. TO ENSURE THE EQUITABLE TREATMENT OF ALL RETAIL CUSTOMERS IN NEW YORK, THE COMMISSION THE ELECTRIC CORPORATION'S SHALL REOUIRE THATSTORM PLAN RESTORES SERVICE TO RETAIL CUSTOMERS OF ADJACENT ELECTRIC CORPORATIONS AND MUNIC-IPAL ELECTRIC UTILITIES THAT DEPEND ON THE ELECTRIC CORPORATION'S FACIL-ITIES FOR ELECTRIC SERVICE ON A BASIS COMPARABLE TO ITS RETAIL CUSTOM-ERS.

S 2. Section 1020-cc of the public authorities law, as amended by chapter 413 of the laws of 2011, is amended to read as follows:

S 1020-cc. Authority subject to certain provisions contained in the state finance law, the public service law, the social services law and the general municipal law. All contracts of the authority shall be subject to the provisions of the state finance law relating to contracts made by the state. The authority shall also establish rules and regulations with respect to providing to its residential gas, electric and steam utility customers those rights and protections provided in article
