AN ACT to amend the public authorities law, the public service law, and the executive law, in relation to reforming the telecommunications sector of the New York economy, by creating a broadband authority, authorizing statewide cable franchises for the purposes of competitive cable service, promoting the wide-spread development of high-capacity broadband internet access, and increasing the availability and quality of services in this key economic development area and ensuring the safety, reliability and affordability of telecommunications services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as  
2 the "omnibus telecommunications reform act of 2014".  
3 S 2. Legislative findings. 1. a. It is and has been the long-standing  
4 policy of the state of New York that every resident and business in the  
5 state of New York has a right to have equal physical and social access  
6 to adequate telecommunications services at just and reasonable rates,  
7 because universal access to the benefits of telephony is fundamental to  
8 effective communication, quality of life, economic development, public  
9 safety and security, and democratic participation. Telecommunications,  
10 however, is undergoing dramatic changes with new technologies driving  
11 the ways people communicate with one another. No matter the source or  
12 vehicle by which people communicate with each other, the people of this  
13 state have the right to adequate service at just and reasonable rates.  
14 Therefore, all telecommunications services must meet the highest stand-  
15 ards of quality, reliability, and safety--including protecting and

1 expanding the system of emergency 911 service--which requires sufficient  
2 investment in telecommunications infrastructure and, as many years of  
3 experience have shown, adequate staffing provided by trained, career  
4 employees operating under the applicable safety codes and regulations.

5 b. While the state's long-standing mission has been to provide  
6 universal, affordable and reliable service to all New Yorkers, all citi-  
7 zens of the state do not have equal access to communications technolo-  
8 gies that are becoming the standard bearers for the 21st century. In  
9 fact, the state lags behind in deploying communication networks that are  
10 the foundation of modern telecommunications. The lack of deployment of  
11 high-capacity telecommunications infrastructure services ("broadband")  
12 in rural, underserved, unserved, economically distressed and other areas  
13 of the state is affected with a public interest; the rates, services and  
14 operations of cable television companies are affected with a public  
15 interest and it is imperative that the state fairly regulate cable tele-  
16 vision services in the interest of the public, and; the public interest  
17 is furthered by comprehensive action in the area of telecommunications,  
18 and by the state's continued promotion of universally available telecom-  
19 munications services of adequate service quality and at affordable  
20 rates, particularly in rural, high-cost and low income areas, and the  
21 state's entry into promoting the universal availability and physical and  
22 social access to high-quality broadband and advanced communications  
23 services at affordable rates.

24 c. The deployment of high-capacity broadband telecommunications  
25 networks and advanced communications networks throughout New York will  
26 promote improvements in healthcare, public safety, education, consumer  
27 choice, and the economy.

28 d. State action and public-private partnerships will be needed to  
29 deepen investment in, promote demand for, stimulate adoption of, and  
30 remove barriers to the development of universally deployed world-class  
31 high-capacity broadband networks, providing services to business and  
32 residential consumers in all areas of the state at competitive prices  
33 with adequate service quality.

34 e. Reasonably unfettered access of the citizenry to the maximally  
35 diverse Internet is in the public interest, consistent however with the  
36 need or company choice of telecommunications providers to block, limit  
37 or otherwise restrict the passage of electronic mail messages or other  
38 content that transmit, portray, describe, represent or otherwise contain  
39 matters such as child pornography or similar obscenity, other unlawful  
40 material, threats of serious bodily harm, threats to the public safety  
41 and homeland security, threats of death to individuals or groups of  
42 individuals, viruses or similar computer generated programs or codes  
43 that have the potential to harm computer hardware and/or software and/or  
44 networks, excessive unsolicited commercial email that degrades or inter-  
45 feres with or harms the normal operation of broadband networks, and  
46 other similar types or forms of material or software (the foregoing  
47 examples are illustrative, not exhaustive of such threats to users  
48 and/or the network).

49 2. a. New cable television services regulation is necessary to: (i)  
50 promote adequate, affordable and efficient cable television service to  
51 the citizens and residents of the state; (ii) encourage the optimum  
52 development of the educational, government and community-service poten-  
53 tials of the cable television medium; (iii) provide just and reasonable  
54 rates for cable television service without geographic discrimination;  
55 (iv) protect the interests of the municipalities of this state in  
56 relation to the issuance of municipal consents for the operations of

1 cable television companies in those jurisdictions; (v) to protect the  
2 right of consumers to access the lawful internet content of their  
3 choice, to run applications and use services of their choice, subject to  
4 the requirements of law enforcement, and to connect their choice of  
5 legal devices that do not harm the network; and (vi) cooperate with  
6 other states and with the federal government in promoting and coordinat-  
7 ing efforts to regulate cable television effectively in the public  
8 interest.

9 b. Competition in the provisioning of cable service is emerging with  
10 the convergence of preexisting and new technologies for providing voice,  
11 video and data services, which results in increased investment in the  
12 state, lower prices and improved service offerings for consumers.

13 c. Increased investment and the potential for competition in the cable  
14 service market through the provisioning of new communications services  
15 and deployment of advanced communications infrastructure further  
16 enhances economic opportunities, public safety, and the overall health  
17 and well-being of the residents of the state.

18 d. State-issued franchises for the provision of cable service will  
19 promote and facilitate the deployment of advanced technologies and new  
20 services to all classes of communities and protect New York's ability to  
21 compete in the national and international marketplace for industry and  
22 jobs.

23 e. Modifying existing cable service regulation through the enactment  
24 of new standards and procedures that provide consumers with access to a  
25 competitive facilities-based cable market and also preserves munici-  
26 palities historic authority to manage public rights-of-way, collect a  
27 franchise fee up to five percent of gross revenue, administer public  
28 educational and government access channels, enforce consumer protections  
29 and ensure competitive cable services are delivered in a nondiscrimina-  
30 tory manner is warranted in this state.

31 f. Nothing in this act shall be seen to limit or reduce the protection  
32 afforded to cable television customers, broadband internet services  
33 customers, telephone customers, and customers of advanced communications  
34 services generally, and it is in the public interest to ensure that  
35 customers continue to be provided a high level of customer protection  
36 and customer service in a more competitive market.

37 3. Therefore, the legislature declares that the state needs to funda-  
38 mentally reform the three key pillars of its vast telecommunications  
39 system--telephone, broadband internet access and cable television--to  
40 provide 21st Century technology to all New Yorkers that is safe, reli-  
41 able and affordable.

42 S 3. Article 11 and sections 4000, 4001 and 4002 of the public

21 S 4100. SHORT TITLE. THIS ARTICLE SHALL BE KNOWN AND MAY BE CITED AS  
22 THE "BROADBAND DEVELOPMENT AUTHORITY ACT".

23 S 4101. BROADBAND DEVELOPMENT AUTHORITY. 1. THE NEW YORK STATE BROAD-  
24 BAND DEVELOPMENT AUTHORITY IS ESTABLISHED IN ORDER TO ENCOURAGE THE  
25 PROVISION OF AFFORDABLE AND RELIABLE BROADBAND SERVICES AND NETWORKS  
26 THAT WILL:

27 (A) ENSURE THE LONG TERM GROWTH OF AND THE ENHANCEMENT AND DELIVERY OF  
28 SERVICES BY BUSINESS, EDUCATIONAL, MEDICAL, COMMERCIAL, NONPROFIT, AND  
29 GOVERNMENTAL ENTITIES IN UNSERVED, UNDERSERVED AND DISTRESSED AREAS IN  
30 NEW YORK;

31 (B) BENEFIT RESIDENTIAL, COMMERCIAL, PUBLIC, GOVERNMENTAL, AND NONPRO-  
32 FIT ENTITIES IN UNSERVED, UNDERSERVED AND DISTRESSED AREAS IN NEW YORK;  
33 AND

34 (C) TO ADVANCE THE AVAILABILITY OF, AND PROMOTE THE PHYSICAL AND  
35 SOCIAL ACCESS TO, BROADBAND AND OTHER ADVANCED COMMUNICATIONS SERVICES  
36 TO ALL CONSUMERS, INCLUDING THOSE IN LOW INCOME, RURAL, INSULAR, AND  
37 HIGH COST AREAS AT RATES THAT ARE REASONABLY COMPARABLE TO THOSE CHARGED  
38 IN HIGH-DENSITY URBAN AREAS AND/OR IN THE AREA OF THE STATE WHERE SUCH  
39 SERVICES ARE MOST COMPETITIVELY PRICED; AND TO INCREASE ACCESS TO, AND  
40 THE UBIQUITY OF, ADVANCED TELECOMMUNICATIONS SERVICES AVAILABLE TO THE  
41 PUBLIC IN AN EQUITABLE AND NONDISCRIMINATORY MANNER.

42 2. THE AUTHORITY SHALL ADMINISTER THE BROADBAND DEVELOPMENT PROGRAM,  
43 AND SHALL, THROUGH THE BROADBAND DEVELOPMENT AND DEPLOYMENT COUNCIL  
44 CREATED IN SECTION FORTY-ONE HUNDRED FIVE OF THIS ARTICLE, WORK TO BUILD  
45 AND FACILITATE LOCAL TECHNOLOGY AND SOCIAL ACCESS PLANNING ENTITIES, AND  
46 PARTNERSHIPS WITH BROADBAND INTERNET SERVICES PROVIDERS AND TECHNOLOGY  
47 COMPANIES, AND THE PRIVATE AND NONPROFIT SECTORS GENERALLY, AND SUCH  
48 OTHER PROGRAMS AS ARE REASONABLY CALCULATED TO FACILITATE THE AUTHORI-  
49 TY'S ACHIEVEMENT OF ITS STATUTORY DUTIES.

50 S 4102. DEFINITIONS. 1. "AUTHORITY" MEANS THE NEW YORK STATE BROADBAND  
51 DEVELOPMENT AUTHORITY CREATED UNDER SECTION FORTY-ONE HUNDRED ONE OF  
52 THIS ARTICLE.

53 2. "UNSERVED AREA" MEANS ANY PART OF A MUNICIPALITY WITHOUT READILY  
54 AND GENERALLY AVAILABLE RETAIL CONSUMER ACCESS TO A FACILITIES-BASED OR  
55 FIXED WIRELESS BROADBAND SERVICES PROVIDER. FOR THE PURPOSES OF THIS

1 SECTION, THE DEFINITION OF WIRELESS BROADBAND SERVICES PROVIDERS SHALL  
2 NOT INCLUDE SUBSCRIPTION SATELLITE SERVICE.

3 3. "UNDERSERVED AREA" MEANS ANY PART OF A MUNICIPALITY WITHOUT READILY  
4 AND GENERALLY AVAILABLE RETAIL CONSUMER ACCESS TO AT LEAST TWO OR MORE  
5 NONAFFILIATED FACILITIES-BASED OR FIXED WIRELESS BROADBAND TELECOMMUNI-  
6 CATIONS SERVICES PROVIDERS. WIRELESS SHALL NOT INCLUDE SUBSCRIPTION  
7 SATELLITE SERVICE.

8 4. "BROADBAND" MEANS THE TRANSMISSION OF INFORMATION, BETWEEN OR AMONG  
9 POINTS SPECIFIED BY THE USER, WITH OR WITHOUT CHANGE IN THE FORM OR  
10 CONTENT OF THE INFORMATION AS SENT AND RECEIVED, AT MINIMUM RATES OF  
11 TRANSMISSION OF TWO MEGABITS PER SECOND DOWNSTREAM AND ONE MEGABIT PER  
12 SECOND UPSTREAM, OR ONE HUNDRED FIFTY PERCENT OF THOSE TRANSMISSION  
13 RATES DEFINED BY THE FEDERAL COMMUNICATIONS COMMISSION AS "BROADBAND,"  
14 OR AT THOSE SYNCHRONOUS UPSTREAM AND DOWNSTREAM TRANSMISSION RATES AS  
15 MAY BE RECOMMENDED BY THE BROADBAND COUNCIL FROM TIME TO TIME, WHICHEVER  
16 IS FASTEST IN SPEED.

17 5. "BROADBAND CARRIER" MEANS ANY PROVIDER OF BROADBAND SERVICES,  
18 EXCEPT AGGREGATORS OF BROADBAND SERVICES, AS DEFINED IN SECTION TWO  
19 HUNDRED TWENTY-SIX OF THE NINETEEN HUNDRED NINETY-SIX TELECOMMUNICATIONS  
20 ACT.

21 6. "BROADBAND INFRASTRUCTURE" MEANS ALL EQUIPMENT AND FACILITIES,  
22 INCLUDING ALL CHANGES, MODIFICATIONS, AND EXPANSIONS TO EXISTING FACILI-  
23 TIES, AS WELL AS THE CUSTOMER PREMISES EQUIPMENT USED TO PROVIDE BROAD-  
24 BAND, AND ANY SOFTWARE INTEGRAL TO OR RELATED TO THE OPERATIONS,  
25 SUPPORT, FACILITATION, OR INTERCONNECTION OF SUCH EQUIPMENT, INCLUDING  
26 UPGRADES, AND ANY INSTALLATION, OPERATIONS AND SUPPORT, MAINTENANCE, AND  
27 OTHER FUNCTIONS REQUIRED TO SUPPORT THE DELIVERY OF BROADBAND.

28 7. "BROADBAND SERVICE" MEANS THE OFFERING OF BROADBAND FOR A FEE  
29 DIRECTLY TO THE PUBLIC, OR TO SUCH CLASSES OF USERS AS TO BE READILY  
30 AVAILABLE DIRECTLY TO THE PUBLIC, REGARDLESS OF THE FACILITIES USED.

31 8. "OPEN NETWORK" MEANS ANY BROADBAND INFRASTRUCTURE WHICH IS OPEN TO  
32 ANY THIRD PARTY USERS IN A NONDISCRIMINATORY MANNER ON A FAIR AND EQUI-  
33 TABLE BASIS USING PUBLICLY AVAILABLE ACCESS TARIFFS FOR SERVICES.

34 9. "OPEN NETWORK INTERFACES" MEANS THE TECHNICAL AND OPERATIONAL  
35 MEANS, MANNERS, AND METHODS FOR ANY THIRD PARTY ACCESS TO THE BROADBAND  
36 INFRASTRUCTURE, WHICH SHALL BE PROVIDED ON THE BASIS OF GENERALLY  
37 ACCEPTABLE INDUSTRY STANDARDS AVAILABLE AT THE TIME OF ACCESS.

38 10. "DISTRESSED AREA" MEANS:

39 (A) A CENSUS TRACT OR TRACTS OR BLOCK NUMBERING AREA OR AREAS OR SUCH  
40 CENSUS TRACT OR BLOCK NUMBERING AREA CONTIGUOUS THERETO WHICH, ACCORDING  
41 TO THE MOST RECENT CENSUS DATA AVAILABLE, HAS:

42 (I) A POVERTY RATE OF AT LEAST TWENTY PERCENT FOR THE YEAR TO WHICH  
43 THE DATA RELATES OR AT LEAST TWENTY PERCENT OF HOUSEHOLDS RECEIVING  
44 PUBLIC ASSISTANCE; AND

45 (II) AN UNEMPLOYMENT RATE OF AT LEAST ONE AND A QUARTER TIMES THE  
46 STATEWIDE UNEMPLOYMENT RATE FOR THE YEAR TO WHICH THE DATA RELATES; OR

47 (B) A CITY, TOWN, VILLAGE OR COUNTY WITHIN A CITY WITH A POPULATION OF  
48 ONE MILLION OR MORE FOR WHICH:

49 (I) THE RATIO OF THE FULL VALUE PROPERTY WEALTH, AS DETERMINED BY THE  
50 COMPTROLLER FOR THE YEAR NINETEEN HUNDRED NINETY, PER RESIDENT TO THE  
51 STATEWIDE AVERAGE FULL VALUE PROPERTY WEALTH PER RESIDENT; AND

52 (II) THE RATIO OF THE INCOME PER RESIDENT; AS SHOWN IN THE NINETEEN  
53 HUNDRED NINETY CENSUS TO THE STATEWIDE AVERAGE INCOME PER RESIDENT; ARE  
54 EACH FIFTY-FIVE PERCENT OR LESS OF THE STATEWIDE AVERAGE; OR

55 (C) AN AREA WHICH WAS DESIGNATED AN EMPIRE ZONE PURSUANT TO ARTICLE  
56 EIGHTEEN-B OF THE GENERAL MUNICIPAL LAW.

1 11. "DARK FIBER" MEANS FIBER OPTIC CABLE THAT IS NOT LIGHTED BY LASERS  
2 OR OTHER ELECTRONIC EQUIPMENT.

3 12. "COMPTROLLER" MEANS THE COMPTROLLER OF THE STATE OF NEW YORK.

4 13. "BOARD" MEANS THE BOARD OF DIRECTORS CREATED UNDER SECTION FORTY-  
5 ONE HUNDRED FOUR OF THIS ARTICLE.

6 14. "FUND" MEANS THE BROADBAND AND ADVANCED COMMUNICATIONS DEVELOPMENT  
7 FUND CREATED UNDER SECTION FORTY-ONE HUNDRED THIRTEEN OF THIS ARTICLE.

8 15. "BROADBAND COUNCIL" MEANS THE BROADBAND DEVELOPMENT AND DEPLOYMENT  
9 COUNCIL AS CREATED UNDER SECTION FORTY-ONE HUNDRED FIVE OF THIS ARTICLE.

10 16. "CURRENT GENERATION BROADBAND SERVICE" MEANS THE TRANSMISSION OF  
11 SIGNALS AT A RATE OF AT LEAST ONE MILLION FIVE HUNDRED THOUSAND BITS PER  
12 SECOND TO THE SUBSCRIBER AND AT LEAST TWO HUNDRED THOUSAND BITS PER  
13 SECOND FROM THE SUBSCRIBER.

14 17. "NEXT GENERATION BROADBAND SERVICE" MEANS THE TRANSMISSION OF  
15 SIGNALS AT A RATE OF AT LEAST TWENTY-TWO MILLION BITS PER SECOND TO THE  
16 SUBSCRIBER AND AT LEAST TEN MILLION BITS PER SECOND FROM THE SUBSCRIBER.

17 18. "QUALIFIED EQUIPMENT" MEANS EQUIPMENT CAPABLE OF PROVIDING CURRENT  
18 GENERATION BROADBAND SERVICES OR NEXT GENERATION BROADBAND SERVICES AT  
19 ANY TIME TO EACH SUBSCRIBER WHO IS UTILIZING SUCH SERVICES.

20 19. "QUALIFIED EXPENDITURE" MEANS ANY AMOUNT CHARGEABLE TO THE CAPITAL  
21 ACCOUNT WITH RESPECT TO THE PURCHASE AND INSTALLATION OF QUALIFIED  
22 EQUIPMENT, INCLUDING ANY UPGRADES THERETO, FOR WHICH DEPRECIATION IS  
23 ALLOWABLE UNDER SECTION 168 OF THE INTERNAL REVENUE CODE.

24 20. "UNDERSERVED SUBSCRIBER" MEANS A RETAIL CONSUMER RESIDING IN A  
25 DWELLING LOCATED IN AN UNSERVED OR UNDERSERVED AREA.

26 21. "UNDERSERVED STRUCTURE" MEANS A MULTI-FAMILY HOUSING UNIT OR A  
27 MULTIPLE-DWELLING HOUSING UNIT LOCATED IN AN UNSERVED OR UNDERSERVED  
28 AREA.

29 S 4103. POWERS OF THE AUTHORITY. 1. THE GENERAL POWERS OF THE AUTHORI-  
30 TY UNDER THIS ARTICLE INCLUDE ALL THOSE NECESSARY TO CARRY OUT AND  
31 EFFECTUATE THE PURPOSES OF THIS ARTICLE, INCLUDING, BUT NOT LIMITED TO,  
32 THE FOLLOWING:

33 (A) TO INVEST ANY MONEY OF THE AUTHORITY AT THE AUTHORITY'S  
34 DISCRETION, IN ANY OBLIGATIONS DETERMINED PROPER BY THE AUTHORITY, AND  
35 TO NAME AND USE DEPOSITORIES FOR THE AUTHORITY'S MONEY;

36 (B) TO RECEIVE AND DISTRIBUTE FEDERAL, STATE OR LOCAL FUNDING, INCLUD-  
37 ING GRANTS, LOANS, AND APPROPRIATIONS;

38 (C) TO MAKE EXPENDITURES NECESSARY TO CARRY OUT THE AUTHORITY'S DUTIES  
39 UNDER THIS ARTICLE, INCLUDING PAYING THE AUTHORITY'S OPERATING EXPENSES;

40 (D) TO SUE AND BE SUED, IMPLEAD AND BE IMPLEADED, COMPLAIN AND DEFEND  
41 IN ALL COURTS;

42 (E) TO ADOPT, USE AND ALTER AT WILL A CORPORATE SEAL;

43 (F) TO ACQUIRE, PURCHASE, HOLD, USE, LEASE OR OTHERWISE DISPOSE OF ANY  
44 PROJECT AND PROPERTY, REAL, PERSONAL OR MIXED, TANGIBLE OR INTANGIBLE,  
45 OR ANY INTEREST THEREIN NECESSARY OR DESIRABLE FOR CARRYING OUT THE  
46 PURPOSES OF THE AUTHORITY, AND, WITHOUT LIMITATION OF THE FOREGOING, TO  
47 LEASE AS LESSEE, ANY PROJECT AND ANY PROPERTY, REAL, PERSONAL OR MIXED,  
48 OR ANY INTEREST THEREIN, AT SUCH ANNUAL RENTAL AND ON SUCH TERMS AND  
49 CONDITIONS AS MAY BE DETERMINED BY THE BOARD AND TO LEASE AS LESSOR TO  
50 ANY PERSON, ANY PROJECT AND ANY PROPERTY, REAL, PERSONAL OR MIXED,

3 (G) TO PLAN, DEVELOP, UNDERTAKE, CARRY OUT, CONSTRUCT, IMPROVE, REHA-

5 (H) TO ADOPT BYLAWS FOR THE MANAGEMENT AND REGULATION OF ITS AFFAIRS

32 (N) TO EMPLOY, IN ITS DISCRETION, CONSULTANTS, ATTORNEYS, ARCHITECTS,

33 SOCIAL ACCESS TO GENERALLY AVAILABLE RETAIL BROADBAND SERVICES OF  
34 ADEQUATE QUALITY, AT AFFORDABLE PRICES, FOR UNDERSERVED STRUCTURES AND  
35 UNDERSERVED SUBSCRIBERS; AND

36 (F) TO DO ALL ACTS AND THINGS NECESSARY OR CONVENIENT TO CARRY OUT THE  
37 POWERS GRANTED TO IT BY LAW.

38 S 4104. BOARD OF DIRECTORS. 1. THE AUTHORITY SHALL BE GOVERNED BY A  
39 BOARD OF DIRECTORS CONSISTING OF SEVENTEEN MEMBERS, INCLUDING: THE  
40 COMMISSIONERS OF THE DEPARTMENT OF ECONOMIC DEVELOPMENT, THE EMPIRE  
41 STATE DEVELOPMENT CORPORATION, THE PUBLIC SERVICE COMMISSION AND THE

44 DESIGNEES. TWO MEMBERS OF THE BOARD SHALL BE PROPOSED BY THE RESPECTIVE  
45 UNIONS OF THE WIRELINE AND WIRELESS TELECOMMUNICATIONS INDUSTRIES OF NEW  
46 YORK. THE REMAINING MEMBERS OF THE BOARD SHALL BE APPOINTED BY THE  
47 GOVERNOR WITH THE ADVICE AND CONSENT OF THE SENATE, FROM A LIST OF INDI-  
48 VIDUALS NOMINATED BY THE PRINCIPAL ESTABLISHED INDUSTRY GROUPS, TECHNICAL  
49 COUNSELS, OR ACADEMIC PROFESSIONAL GROUPS OF NEW YORK. THE APPOINT-  
50 EES SHALL BE THE FOLLOWING: ONE MEMBER FROM EACH TELECOMMUNICATIONS

54 INTERNET PROVIDER INDUSTRY; THE PRESIDENT OF THE STATE UNIVERSITY SYSTEM  
55 OF NEW YORK, TWO PRESIDENTS OF MAJOR NEW YORK RESEARCH UNIVERSITIES, ONE  
56 OF WHOM SHALL REPRESENT PRIVATE RESEARCH UNIVERSITIES AND ONE OF WHOM

1 SHALL REPRESENT PUBLIC RESEARCH UNIVERSITIES; AND ONE MEMBER WHO SHALL  
2 BE NOMINATED BY NEW YORK'S FINANCIAL SERVICES COMMUNITY.

3 2. THE GOVERNMENT MEMBERS SHALL SERVE ON THE BOARD FOR TERMS COINCI-  
4 DENT WITH THEIR TERMS OF OFFICE. THE INITIAL TERM OF THE NON-GOVERNMEN-  
5 TAL MEMBERS SHALL EXPIRE ON DECEMBER THIRTY-FIRST, TWO THOUSAND SIXTEEN,  
6 AND ALL SUBSEQUENT NONGOVERNMENTAL MEMBER TERMS SHALL BE COINCIDENT WITH  
7 THE TERM OF THE GOVERNOR WHO APPOINTED SUCH MEMBERS. VACANCIES IN THE

47 2. (A) WITHIN SIXTY DAYS OF THE EFFECTIVE DATE OF THIS SECTION, THE  
48 BROADBAND COUNCIL SHALL CREATE, COORDINATE, OR LIAISE WITH EXISTING,  
49 MUNICIPAL AND/OR COUNTY-LEVEL SOCIAL ACCESS COUNCILS TO STUDY, AND  
50 SUBSEQUENTLY REPORT TO THE AUTHORITY UPON: (I) THE LOCATION, SIZE AND

56 (IV) SUCH OTHER MATTERS AS THE BROADBAND COUNCIL AND LOCAL BROADBAND

1 DEVELOPMENT COUNCILS BELIEVE NECESSARY TO EFFECTUATING THE MISSION OF  
2 THE AUTHORITY.

3 (B) WITHIN NINETY DAYS OF THE EFFECTIVE DATE OF THIS SECTION, THE  
4 BROADBAND COUNCIL SHALL STUDY AND REPORT TO THE AUTHORITY UPON:

5 (I) THE AVAILABILITY OF ANY EXISTING FEDERAL, STATE AND LOCAL FUNDS  
6 THAT CAN BE USED OR RE-PURPOSED TO FUND BROADBAND DEVELOPMENT AND  
7 PROMOTE UNIVERSAL ACCESS TO BROADBAND AND ADVANCED COMMUNICATIONS  
8 SERVICES IN UNSERVED, UNDERSERVED AND DISTRESSED AREAS;

9 (II) COMMERCIALY REASONABLE INVESTMENT BENCHMARKS THAT IT BELIEVES  
10 ARE NECESSARY TO DETERMINE BETWEEN REASONABLY EQUALLY VALUABLE AND  
11 IMPERATIVE BROADBAND DEVELOPMENT PROJECTS;

12 (III) AN APPROPRIATE SET OF METRICS BY WHICH TO DETERMINE THE QUALITY  
13 OF A BROADBAND BUILDOUT PROJECT, AND WHETHER SUCH BUILDOUT WAS BEING  
14 COMPLETED WITHIN THE TIME SPAN UPON WHICH THE AUTHORITY CONDITIONED THE  
15 GRANT OF ANY FUNDS TOWARD SUCH BUILDOUT;

16 (IV) THE AVAILABILITY, DESIRABILITY AND UTILITY OF A SET OF STANDARD-  
17 IZED METRICS FOR SERVICE QUALITY, SPEED, AND RELIABILITY THAT SHALL BE  
18 APPLIED TO THE NETWORKS BUILT WITH FUNDS FROM THE AUTHORITY; AND

19 (V) THE AVAILABILITY OF SURPLUS COMPUTERS AND OTHER BROADBAND TELECOM-  
20 MUNICATIONS EQUIPMENT IN THE INVENTORIES OF STATE AND LOCAL AUTHORITIES

41 TISAN MANNER, WITH GOOD FAITH, AND WITH THAT DEGREE OF DILIGENCE, CARE  
42 AND SKILL THAT AN ORDINARY PRUDENT PERSON WOULD EXERCISE UNDER SIMILAR

48 OF THE AUTHORITY REPRESENTED TO THE MEMBER OF THE BOARD OR OFFICER,  
49 EMPLOYEE, OR AGENT OF THE AUTHORITY TO BE CORRECT BY THE PRESIDENT OR  
50 THE OFFICER OF THE AUTHORITY HAVING CHARGE OF ITS BOOKS OR ACCOUNT, OR  
51 STATED IN A WRITTEN REPORT BY A CERTIFIED PUBLIC ACCOUNTANT OR FIRM OF  
52 CERTIFIED PUBLIC ACCOUNTANTS TO FAIRLY REFLECT THE FINANCIAL CONDITION  
53 OF THE AUTHORITY.

54 (B) A MEMBER OF THE BROADBAND DEVELOPMENT COUNCIL SHALL DISCHARGE THE  
55 DUTIES OF HIS OR HER POSITION IN A NONPARTISAN MANNER, WITH GOOD FAITH,  
56 AND WITH THAT DEGREE OF DILIGENCE, CARE AND SKILL THAT AN ORDINARY

1 PRUDENT PERSON WOULD EXERCISE UNDER SIMILAR CIRCUMSTANCES IN A LIKE

3 (C) A MEMBER OF A SOCIAL ACCESS COUNCIL SHALL DISCHARGE THE DUTIES OF  
4 HIS OR HER POSITION IN A NONPARTISAN MANNER, WITH GOOD FAITH, AND WITH  
5 THAT DEGREE OF DILIGENCE, CARE AND SKILL THAT AN ORDINARY PRUDENT PERSON  
6 WOULD EXERCISE UNDER SIMILAR CIRCUMSTANCES IN A LIKE POSITION.

7 S 4106. APPLICATIONS FOR BROADBAND DEPLOYMENT FINANCING; RESPONSIBIL-  
8 ITIES OF THE APPLICANT TO PROVIDE SAFE, RELIABLE AND AFFORDABLE SERVICE.  
9 IN ADDITION TO RULES PROMULGATED BY THE AUTHORITY AS WELL AS THE OTHER  
10 REQUIREMENTS ESTABLISHED IN THIS ARTICLE, AS PART OF AN APPLICATION FOR  
11 FINANCING UNDER THIS CHAPTER, A BROADBAND DEVELOPER OR BROADBAND OPERA-  
12 TOR MUST FILE WITH THE AUTHORITY:

13 1. A PARTICIPATION PLAN FOR MINORITY AND WOMAN-OWNED BUSINESSES;  
14 2. A COMMUNITY WIDE OUTREACH PLAN TO EDUCATE THE PUBLIC WITH RESPECT  
15 TO THE AVAILABILITY OF BROADBAND SERVICES;

17 OF ANY BROADBAND NETWORK OR NETWORKS BUILT WITH FUNDING FROM THE AUTHOR-  
18 ITY, AND WHETHER SUCH NETWORKS SHALL MAINTAIN FULL UPLOAD AND DOWNLOAD  
19 SPEEDS WHEN SUBSCRIBED TO ONE HUNDRED PERCENT OF CAPACITY;

20 4. A DETAILED PLAN SHOWING HOW SUCH BUILDOUT FUNDED BY THE AUTHORITY  
21 SHALL ADDRESS OR EXCEED THE CURRENT AGGREGATE DEMAND FOR BROADBAND  
22 SERVICES IN THE AREA OF PROPOSED BUILDOUT AS DETERMINED BY THE AUTHORI-

26 5. SUCH OTHER REQUIREMENTS AS MAY BE RECOMMENDED TO THE AUTHORITY BY  
27 THE COUNCIL AND THE PUBLIC SERVICE COMMISSION;

28 6. A PLAN FOR FOLLOWING THE PRINCIPLES OF NEUTRAL NETWORKS AS REQUIRED  
29 IN SECTION FORTY-ONE HUNDRED THIRTEEN OF THIS ARTICLE; AND

30 7. A PLAN CONTAINING DETAILED METRICS SETTING FORTH TIME TO COMPLETION  
31 FOR EACH STAGE OF ITS PROPOSED BUILDOUT, THE SPEEDS TO BE OFFERED ON AND  
32 ACROSS ITS NETWORK, AND SUCH OTHER METRICS AS THE BROADBAND COUNCIL OR  
33 BOARD MAY PROPOSE. THE AUTHORITY MAY NOT APPROVE AN APPLICATION UNLESS A  
34 PLAN IS SUBMITTED UNDER THIS SECTION AND UNLESS THE REQUIREMENTS OF THIS  
35 SECTION ARE MET.

36 S 4107. BONDS AND NOTES OF THE AUTHORITY. 1. THE AUTHORITY SHALL HAVE  
37 THE POWER AND IS HEREBY AUTHORIZED FROM TIME TO TIME TO ISSUE NEGOTIABLE  
38 BONDS OR NOTES FOR ANY OF ITS CORPORATE PURPOSES FOR UP TO ONE HUNDRED  
39 FIFTY MILLION DOLLARS ANNUALLY FOR FIVE YEARS TO DO ALL OF THE FOLLOW-

47 (D) PAY THE INTEREST ON BONDS AND NOTES OF THE AUTHORITY;

48 (E) ESTABLISH RESERVES TO SECURE THE BONDS AND NOTES OF THE AUTHORITY;  
49 AND

50 (F) MAKE OTHER EXPENDITURES NECESSARY TO CARRY OUT THE AUTHORITY'S  
51 DUTIES UNDER THIS ARTICLE, INCLUDING THE PAYMENT OF THE AUTHORITY'S  
52 OPERATING EXPENSES.

53 THE BONDS AND NOTES SHALL BE IN A FORM, BEAR INTEREST AT A RATE OR

13 (C) PLEDGING ANY LOAN, GRANT, OR CONTRIBUTION FROM A GOVERNMENT ENTI-  
14 TY;

15 (D) THE USE AND DISPOSITION OF THE GROSS INCOME FROM CONTRACTS AND  
16 LEASES OF THE AUTHORITY;

17 (E) LIMITATIONS ON THE PURPOSE TO WHICH THE PROCEEDS OF SALE OF NOTES  
18 OR BONDS MAY BE APPLIED AND PLEDGING PROCEEDS TO SECURE THE PAYMENT OF  
19 THE NOTES OR BONDS;

20 (F) LIMITATIONS ON THE ISSUANCE OF ADDITIONAL NOTES OR BONDS, THE  
21 TERMS UPON WHICH ADDITIONAL NOTES OR BONDS MAY BE ISSUED AND SECURED,  
22 AND THE REFUNDING OF OUTSTANDING OR OTHER NOTES OR BONDS;

23 (G) THE PROCEDURE, IF ANY, BY WHICH THE TERMS OF ANY CONTRACT WITH  
24 NOTEHOLDERS OR BONDHOLDERS MAY BE AMENDED OR ABROGATED, THE AMOUNT OF  
25 NOTES OR BONDS THE HOLDERS OF WHICH SHALL CONSENT TO THE AMENDMENT OR  
26 ABROGATION, AND THE MANNER IN WHICH THE CONSENT IS TO BE GIVEN;

27 (H) VESTING IN A TRUSTEE OR TRUSTEES PROPERTY, RIGHTS, POWERS, AND  
28 DUTIES IN TRUST AS THE AUTHORITY MAY DETERMINE, WHICH MAY INCLUDE ANY OF  
29 THE RIGHTS, POWERS, AND DUTIES OF THE TRUSTEE APPOINTED BY THE BONDHOLD-  
30 ERS UNDER THIS ARTICLE AND LIMITING OR ABROGATING THE RIGHT OF THE BOND-

42 S 4108. BONDS AND NOTES; PERSONAL LIABILITY. THE MEMBERS OF THE BOARD  
43 OR ANY PERSON EXECUTING THE NOTES OR BONDS UNDER THIS ARTICLE ARE NOT  
44 LIABLE PERSONALLY ON THE NOTES OR BONDS OR SUBJECT TO ANY PERSONAL  
45 LIABILITY OR ACCOUNTABILITY BY REASON OF THE ISSUANCE.

46 S 4109. RIGHTS OF AUTHORITY TO FULFILL TERMS OF AGREEMENT NOT LIMITED,  
47 ALTERED, OR IMPAIRED. THIS STATE PLEDGES AND AGREES WITH THE HOLDERS OF  
48 ANY NOTES OR BONDS ISSUED UNDER THIS ARTICLE, THAT THE STATE WILL NOT  
49 LIMIT OR ALTER THE RIGHTS VESTED IN THE AUTHORITY TO FULFILL THE TERMS

16 PERMANENT ACCOUNT IN THE SPECIAL REVENUE FUND, TO BE CALLED THE ADVANCED  
17 COMMUNICATIONS ASSISTANCE FUND, TO BE ADMINISTERED BY THE AUTHORITY.

27 (B) HELP IN FINANCING THE COSTS OF PLANNING, DESIGNING, PURCHASING,  
28 LEASING, INSTALLING, OR MAINTAINING DARK FIBER TO THE EXTENT PERMITTED,  
29 SUBJECT HOWEVER TO ALL DUTIES AND RESTRICTIONS THAT EXIST WITHIN THIS

31 (C) TO ADVANCE THE PHYSICAL AND SOCIAL AVAILABILITY OF BROADBAND AND

47 FROM THE FUND, WHICH MAY CONSIST OF GRANTS OR LOANS, SHALL BE MADE BY  
48 THE COMPTROLLER UPON WRITTEN REQUEST BEARING THE SIGNATURE OF THE CHAIR  
49 OR THE VICE-CHAIR OF THE AUTHORITY, OR, IF SO AUTHORIZED BY THE AUTHORI-  
50 TY, BEARING HIS OR HER FACSIMILE SIGNATURE, AND THE OFFICIAL SEAL OF THE  
51 AUTHORITY.

52 4. THE RECEIPT OF MONIES FROM THE FUND SHALL BE CONDITIONED UPON THE  
53 ACCEPTANCE BY PUBLIC AND PRIVATE TELECOMMUNICATIONS SERVICES PROVIDER  
54 RECIPIENTS OF THE IMPORTANT STATE POLICY THAT THE REASONABLY UNFETTERED  
55 ACCESS OF THE CITIZENRY TO THE MAXIMALLY DIVERSE INTERNET IS IN THE  
56 PUBLIC INTEREST, WITH THE EXPRESS UNDERSTANDING THAT TELECOMMUNICATIONS

1 PROVIDERS MAY CHOOSE TO BLOCK, LIMIT OR OTHERWISE RESTRICT THE PASSAGE  
2 OF ELECTRONIC MAIL MESSAGE OR OTHER CONTENT THAT TRANSMIT, PORTRAY,  
3 DESCRIBE, REPRESENT OR OTHERWISE CONTAIN MATTERS SUCH AS CHILD PORNOGRA-  
4 PHY OR SIMILAR OBSCENITY, OTHER UNLAWFUL MATERIAL, THREATS OF SERIOUS  
5 BODILY HARM, THREATS TO THE PUBLIC SAFETY AND HOMELAND SECURITY, THREATS  
6 OF DEATH TO INDIVIDUALS OR GROUPS OF INDIVIDUALS, VIRUSES OR SIMILAR  
7 COMPUTER GENERATED PROGRAMS OR CODE THAT HAVE THE POTENTIAL TO HARM  
8 COMPUTER HARDWARE AND/OR SOFTWARE AND/OR NETWORKS, EXCESSIVE UNSOLICITED  
9 COMMERCIAL EMAIL THAT DEGRADES OR INTERFERES WITH OR HARMS THE NORMAL  
10 OPERATION OF BROADBAND NETWORKS, AND OTHER SIMILAR TYPES OR FORMS OF  
11 MATERIAL OR SOFTWARE (THE FOREGOING EXAMPLES ARE ILLUSTRATIVE, NOT  
12 EXHAUSTIVE OF SUCH THREATS TO USERS AND/OR THE NETWORK). EACH RECIPIENT  
13 OF MONIES FROM THE FUND SHALL PROVIDE TO THE AUTHORITY ON AN ANNUAL  
14 BASIS A WRITTEN REPORT DESCRIBING EVERY INSTANCE IN WHICH SUCH RECIPIENT  
15 BLOCKS, LIMITS OR OTHERWISE RESTRICTS SUBSCRIBERS OR OTHER PURCHASERS OF  
16 BROADBAND SERVICES FROM THE RECIPIENT FROM ACCESSING ANY PARTICULAR  
17 INTERNET SITE OR CATEGORY OR TYPE OF INTERNET SITE OR ANY SPECIFIC ELEC-  
18 TRONIC MAIL MESSAGE OR CATEGORY OR TYPE OF ELECTRONIC MAIL ("NEUTRALITY  
19 REPORT"). SUCH NEUTRALITY REPORT SHALL CONTAIN DETAIL OF A SPECIFICITY  
20 LEVEL TO BE DETERMINED BY THE AUTHORITY, AND SHALL CONTAIN SUFFICIENT  
21 DETAIL TO ALLOW THE AUTHORITY TO ASCERTAIN THE NATURE OF ANY BLOCKING,  
22 LIMITATION OR OTHER RESTRICTIONS, AND THE REASON FOR THE RECIPIENT  
23 TAKING SUCH ACTION, BUT SHALL BE PROVIDED IN A MANNER REASONABLY CALCU-  
24 LATED TO PROTECT SUBSCRIBER AND PURCHASER PRIVACY OR THE LEGITIMATE  
25 NEEDS OF LAW ENFORCEMENT. NO RECIPIENT OF FUNDS SHALL BE RESPONSIBLE OR  
26 LIABLE FOR ANY EFFORTS BY OR POLICIES, PRACTICES OR PROCEDURES OF AN  
27 UNAFFILIATED TELECOMMUNICATIONS SERVICES PROVIDER OR INTERNET SERVICES  
28 PROVIDER OR INTERNET PROTOCOL TRAFFIC ROUTING ENTITY TO BLOCK SUBSCRIB-  
29 ERS FROM ACCESSING ANY INTERNET SITE OR ANY CATEGORY OR TYPE OF INTERNET  
30 SITE OR ANY SPECIFIC ELECTRONIC MAIL MESSAGE OR ANY CATEGORY OR TYPE OF  
31 ELECTRONIC MAIL.

32 5. ANY PLEDGE MADE BY THE AUTHORITY IS VALID AND BINDING FROM THE DATE  
33 THAT THE PLEDGE IS MADE. THE MONEY OR PROPERTY PLEDGED AND RECEIVED BY  
34 THE AUTHORITY SHALL IMMEDIATELY BE SUBJECT TO THE LIEN OF THE PLEDGE  
35 WITHOUT ANY PHYSICAL DELIVERY OR FURTHER ACT AND THE LIEN OF THE PLEDGE  
36 IS VALID AND BINDING AGAINST ALL PARTIES HAVING CLAIMS IN TORT,  
37 CONTRACT, OR OTHERWISE AGAINST THE AUTHORITY, IRRESPECTIVE OF WHETHER  
38 THE PARTIES HAVE NOTICE OF THE LIEN. THE RESOLUTION OR ANY OTHER INSTRU-  
39 MENT BY WHICH A PLEDGE IS CREATED NEED NOT BE RECORDED.

40 S 4114. APPROPRIATIONS BY ANY GOVERNMENT OR MUNICIPAL CORPORATION. ANY  
41 GOVERNMENT OR MUNICIPAL CORPORATION MAY MAKE APPROPRIATIONS FOR THE  
42 ACQUISITION, CONSTRUCTION, IMPROVEMENT, MAINTENANCE OR OPERATION OF ANY  
43 PROJECT ACQUIRED, CONSTRUCTED, IMPROVED, MAINTAINED OR OPERATED BY THE  
44 AUTHORITY.

45 S 4115. CONVEYANCE, LEASE OR TRANSFER OF PROPERTY BY A CITY OR COUNTY  
46 TO THE AUTHORITY. ANY CITY OR COUNTY WITHIN NEW YORK STATE IN ORDER TO  
47 PROVIDE FOR THE CONSTRUCTION, RECONSTRUCTION, IMPROVEMENT, REPAIR OR  
48 MANAGEMENT OF ANY PROJECT, OR IN ORDER TO ACCOMPLISH ANY OF THE PURPOSES  
49 OF THIS ARTICLE MAY, WITH OR WITHOUT CONSIDERATION OR FOR A NOMINAL  
50 CONSIDERATION, LEASE, SELL, CONVEY OR OTHERWISE TRANSFER TO THE AUTHORI-  
51 TY ANY REAL, PERSONAL OR MIXED PROPERTY LOCATED WITHIN SUCH CITY OR  
52 COUNTY.

53 S 4116. ACTIONS AGAINST THE AUTHORITY. 1. IN EVERY ACTION AGAINST THE  
54 AUTHORITY FOR DAMAGES, FOR INJURIES TO REAL OR PERSONAL PROPERTY, OR FOR  
55 THE DESTRUCTION THEREOF, OR FOR PERSONAL INJURIES, THE COMPLAINT SHALL  
56 CONTAIN AN ALLEGATION THAT AT LEAST THIRTY DAYS HAVE ELAPSED SINCE THE

1 DEMAND, CLAIM OR CLAIMS UPON WHICH SUCH ACTION IS FOUNDED WERE PRESENTED  
2 TO A MEMBER OF THE AUTHORITY, OR TO ITS SECRETARY, OR TO ITS CHIEF EXEC-  
3 UTIVE OFFICER AND THAT THE AUTHORITY HAS NEGLECTED OR REFUSED TO MAKE AN  
4 ADJUSTMENT OR PAYMENT THEREOF FOR THIRTY DAYS AFTER SUCH PRESENTMENT.

5 2. AN ACTION AGAINST THE AUTHORITY FOR DAMAGES FOR INJURIES TO REAL OR  
6 PERSONAL PROPERTY, OR FOR THE DESTRUCTION THEREOF, OR FOR PERSONAL INJU-  
7 RIES, ALLEGED TO HAVE BEEN SUSTAINED SHALL NOT BE COMMENCED MORE THAN  
8 ONE YEAR AND NINETY DAYS AFTER THE CAUSE OF ACTION THEREFOR SHALL HAVE  
9 ACCRUED, NOR UNLESS A NOTICE OF INTENTION TO COMMENCE SUCH ACTION AND OF  
10 THE TIME WHEN AND PLACE WHERE THE DAMAGES WERE INCURRED OR SUSTAINED,  
11 TOGETHER WITH A VERIFIED STATEMENT SHOWING IN DETAIL THE PROPERTY  
12 ALLEGED TO HAVE BEEN DAMAGED OR DESTROYED AND THE VALUE THEREOF, OR THE  
13 PERSONAL INJURIES ALLEGED TO HAVE BEEN SUSTAINED AND BY WHOM, SHALL HAVE  
14 BEEN FILED IN THE PRINCIPAL OFFICE OF THE AUTHORITY WITHIN NINETY DAYS  
15 AFTER SUCH CAUSE OF ACTION SHALL HAVE ACCRUED.

16 3. AN ACTION AGAINST THE AUTHORITY FOR WRONGFUL DEATH SHALL BE  
17 COMMENCED IN ACCORDANCE WITH THE NOTICE OF CLAIM AND TIME LIMITATION  
18 PROVISIONS OF TITLE ELEVEN OF ARTICLE NINE OF THIS CHAPTER.

19 S 4117. AUDIT POWER AND CONTRACT APPROVAL BY THE COMPTROLLER. 1. THE  
20 COMPTROLLER, OR HIS OR HER LEGALLY AUTHORIZED REPRESENTATIVES, SHALL  
21 HAVE THE AUTHORITY TO EXAMINE THE ACCOUNTS AND FINANCES OF THE AUTHORITY  
22 AND TO CONDUCT MANAGEMENT AUDITS OF THE STAFF AND BOARD OF THE AUTHORI-  
23 TY.

24 2. THE PROCUREMENT, PUBLIC WORK, CONSTRUCTION, AND REVENUE CONTRACTS  
25 OF THE AUTHORITY SHALL BE SUBJECT TO PRIOR REVIEW AND APPROVAL BY THE  
26 COMPTROLLER, IF THE COMPTROLLER, IN HIS OR HER DISCRETION, DETERMINES  
27 THAT SUCH REVIEW AND APPROVAL SHALL BE REQUIRED. IF THE COMPTROLLER  
28 DETERMINES THAT ANY CONTRACT OR CATEGORY OF CONTRACTS OF A STATE AUTHOR-  
29 ITY REQUIRES DIRECT SUPERVISION IN THE FORM OF PRE-APPROVAL OF  
30 CONTRACTS, AND THE COMPTROLLER SO NOTIFIES SUCH STATE AUTHORITY OF SUCH  
31 DETERMINATION, THEN SUBJECT TO SUBDIVISION THREE OF THIS SECTION, NO  
32 SUCH CONTRACT OR AGREEMENT BY SUCH STATE AUTHORITY SELECTED FOR REVIEW  
33 BY THE COMPTROLLER SHALL BE A VALID ENFORCEABLE CONTRACT UNLESS SUCH  
34 CONTRACT SHALL FIRST BE APPROVED BY THE COMPTROLLER. IN THE EVENT THAT  
35 THE COMPTROLLER NOTIFIES THE AUTHORITY THAT APPROVAL SHALL BE REQUIRED  
36 AS PROVIDED IN THIS SECTION, THEN THE AUTHORITY SHALL INCLUDE A  
37 PROVISION IN ALL SUCH CONTRACTS SELECTED FOR REVIEW AS STATED IN ANY  
38 SUCH NOTICE INFORMING THE OTHER PARTIES TO SUCH CONTRACTS THAT THE SAME  
39 ARE NOT VALID AND ENFORCEABLE WITHOUT THE COMPTROLLER'S APPROVAL.

40 3. ANY CONTRACT SELECTED BY THE COMPTROLLER FOR REVIEW AND APPROVAL  
41 PURSUANT TO SUBDIVISION TWO OF THIS SECTION SHALL BE A VALID ENFORCEABLE  
42 CONTRACT ONLY IF THE COMPTROLLER (A) APPROVES THE CONTRACT, OR (B) HAS  
43 NOT DISAPPROVED THE CONTRACT WITHIN FORTY-FIVE DAYS OF THE SUBMISSION OF  
44 SUCH CONTRACT TO HIS OR HER OFFICE, UNLESS THE STATE AUTHORITY SHALL  
45 AGREE WITH THE COMPTROLLER ON AN EXTENSION FOR A REASONABLE PERIOD OF  
46 TIME.

47 S 4118. ANNUAL REPORT. THE AUTHORITY SHALL SUBMIT AN ANNUAL REPORT NO  
48 LATER THAN MARCH FIRST OF EACH YEAR, INCLUDING THE RECOMMENDATIONS MADE  
49 BY THE BROADBAND DEVELOPMENT AND DEPLOYMENT COUNCIL UNDER SECTION  
50 FORTY-ONE HUNDRED FIVE OF THIS ARTICLE, RELATING TO ITS ACTIVITIES FOR  
51 THE PRECEDING CALENDAR YEAR TO THE GOVERNOR, THE SPEAKER OF THE ASSEM-  
52 BLY, THE TEMPORARY PRESIDENT OF THE SENATE, THE MINORITY LEADER OF THE  
53 ASSEMBLY, THE MINORITY LEADER OF THE SENATE, THE CHAIR OF THE ASSEMBLY  
54 STANDING COMMITTEE ON CORPORATIONS, AUTHORITIES AND COMMISSIONS, AND THE  
55 CHAIR OF THE SENATE STANDING COMMITTEE ON ENERGY AND TELECOMMUNICATIONS.

1 S 4119. EFFECT OF INCONSISTENT PROVISIONS. INsofar AS THE PROVISIONS  
2 OF THIS ARTICLE ARE INCONSISTENT WITH THE PROVISIONS OF ANY OTHER ACT,  
3 GENERAL OR SPECIAL, THE PROVISIONS OF THIS TITLE SHALL BE CONTROLLING.

4 S 4120. SEVERABILITY. IF ANY PROVISION OF ANY SECTION OF THIS ARTICLE  
5 OR THE APPLICATION THEREOF TO ANY PERSON OR CIRCUMSTANCE SHALL BE  
6 ADJUDGED INVALID BY A COURT OF COMPETENT JURISDICTION, SUCH ORDER OR  
7 JUDGMENT SHALL BE CONFINED IN ITS OPERATION TO THE CONTROVERSY IN WHICH  
8 IT WAS RENDERED, AND SHALL NOT AFFECT OR INVALIDATE THE REMAINDER OF ANY  
9 PROVISION OF ANY SECTION OF THIS ARTICLE OR THE APPLICATION OF ANY PART  
10 THEREOF TO ANY OTHER PERSON OR CIRCUMSTANCE AND TO THIS END THE

17 UNIVERSAL SERVICE, ALSO REFERRED TO IN THIS SECTION AS THE "HIGH COST  
18 SUPPORT MECHANISM", WHICH SHALL OPERATE IN ACCORDANCE WITH RULES ADOPTED  
19 BY THE COMMISSION. THE PURPOSE OF THE HIGH COST SUPPORT MECHANISM IS TO  
20 PROVIDE FINANCIAL ASSISTANCE TO TELECOMMUNICATIONS SERVICES PROVIDERS TO  
21 HELP MAKE BASIC LOCAL EXCHANGE AND BROADBAND SERVICES UNIVERSALLY AVAIL-  
22 ABLE, AT JUST AND REASONABLE RATES AND ALLOW SUCH PROVIDERS TO BE FULLY  
23 REIMBURSED FOR THE DIFFERENCE BETWEEN THE REASONABLE COSTS INCURRED IN  
24 MAKING BASIC SERVICE AVAILABLE TO THEIR CUSTOMERS WITHIN A RURAL, HIGH  
25 COST GEOGRAPHIC SUPPORT AREA AND THE PRICE CHARGED FOR SUCH SERVICE,  
26 AFTER TAKING INTO ACCOUNT ANY AMOUNTS RECEIVED BY SUCH PROVIDERS UNDER  
27 PRICE SUPPORT MECHANISMS ESTABLISHED BY THE FEDERAL GOVERNMENT AND BY  
28 THIS STATE. THE COMMISSION SHALL ENSURE THAT NO TELECOMMUNICATIONS  
29 SERVICES PROVIDER IS RECEIVING FUNDS FROM THIS OR ANY OTHER SOURCE THAT,  
30 TOGETHER WITH LOCAL EXCHANGE SERVICE REVENUES, EXCEEDS THE COST OF  
31 PROVIDING LOCAL EXCHANGE SERVICE TO CUSTOMERS OF SUCH PROVIDER. THE HIGH  
32 COST SUPPORT MECHANISM SHALL BE SUPPORTED AND DISTRIBUTED EQUITABLY AND  
33 ON A NONDISCRIMINATORY, COMPETITIVELY NEUTRAL BASIS THROUGH A RATE  
34 ELEMENT ASSESSED ON ALL TELECOMMUNICATIONS SERVICE PROVIDERS IN NEW  
35 YORK. A PROVIDER THAT OFFERS BASIC LOCAL EXCHANGE SERVICE OR BROADBAND  
36 SERVICE THROUGHOUT AN ENTIRE SUPPORT AREA THROUGH USE OF ITS OWN FACILI-  
37 TIES OR ON A RESALE BASIS MAY BE QUALIFIED AS A PROVIDER OF LAST RESORT  
38 OR MAY BE ELIGIBLE TO RECEIVE UNIVERSAL SERVICE SUPPORT, AS DETERMINED  
39 BY THE COMMISSION. A PROVIDER THAT FAILS TO PAY AN ASSESSMENT DUE AND  
40 PAYABLE UNDER THIS SECTION SHALL BE SUBJECT TO THE REVOCATION OF CERTIF-  
41 ICATE AFTER NOTICE AND THE OPPORTUNITY FOR A HEARING AS PROVIDED IN THIS  
42 CHAPTER. IN ALL RELEVANT GEOGRAPHIC AREAS OF THE STATE, AS DEFINED BY  
43 THE COMMISSION, THE COMMISSION SHALL DESIGNATE AT LEAST ONE PROVIDER AS  
44 THE PROVIDER OF LAST RESORT AND ADOPT PROCEDURES FOR CHANGING OR TERMI-  
45 NATING SUCH DESIGNATIONS. A PROVIDER OF LAST RESORT DESIGNATION CARRIES  
46 THE RESPONSIBILITY TO OFFER BASIC LOCAL EXCHANGE SERVICE AND BROADBAND  
47 SERVICE TO ALL CONSUMERS WHO REQUEST IT. A PERSON HOLDING A CERTIFICATE  
48 OF PUBLIC CONVENIENCE AND NECESSITY TO PROVIDE BASIC SERVICE SHALL BE  
49 SUBJECT TO THE EVOLVING DEFINITION OF BASIC SERVICE DEVELOPED BY THE  
50 COMMISSION UNDER THIS CHAPTER AND THE SYSTEM OF FINANCIAL SUPPORT FOR  
51 UNIVERSAL SERVICE ESTABLISHED BY THE COMMISSION UNDER THIS SECTION. IF  
52 AND WHEN ADDITIONAL ELEMENTS ARE INCLUDED IN THE DEFINITION OF BASIC  
53 SERVICE AS A RESULT OF REVIEW BY THE COMMISSION, PRICES MAY INCREASE AS  
54 IS DETERMINED BY THE COMMISSION TO BE REASONABLY NECESSARY TO COVER THE  
55 COST AND ACCOUNT FOR THE INCLUSION OF SUCH ADDITIONAL ELEMENTS.

1 2. ON OR BEFORE DECEMBER FIRST OF EACH YEAR, THE COMMISSION SHALL  
2 SUBMIT A WRITTEN REPORT TO THE GOVERNOR, TEMPORARY PRESIDENT OF THE  
3 SENATE, SPEAKER OF THE ASSEMBLY, MINORITY LEADERS OF THE SENATE AND  
4 ASSEMBLY, CHAIRPERSON AND RANKING MINORITY MEMBER OF THE SENATE ENERGY  
5 AND TELECOMMUNICATIONS COMMITTEE, AND THE CHAIRPERSON AND RANKING MINOR-  
6 ITY MEMBER OF THE ASSEMBLY CORPORATIONS, AUTHORITIES AND COMMISSIONS  
7 COMMITTEE, ACCOUNTING FOR THE OPERATION OF THE HIGH COST SUPPORT MECH-  
8 ANISM DURING THE PRECEDING CALENDAR YEAR AND CONTAINING THE FOLLOWING  
9 INFORMATION, AT A MINIMUM:

10 (A) THE TOTAL AMOUNT OF MONEY THAT THE COMMISSION DETERMINED SHOULD  
11 CONSTITUTE THE HIGH COST SUPPORT MECHANISM FROM WHICH DISTRIBUTIONS  
12 WOULD BE MADE;

13 (B) THE TOTAL AMOUNT OF MONEY ORDERED TO BE CONTRIBUTED THROUGH A RATE  
14 ELEMENT ASSESSMENT COLLECTED BY EACH TELECOMMUNICATIONS SERVICE PROVID-  
15 ER;

16 (C) THE BASIS ON WHICH THE CONTRIBUTION OF EACH TELECOMMUNICATIONS  
17 SERVICE PROVIDER WAS CALCULATED;

18 (D) THE BENCHMARKS USED AND THE BASIS ON WHICH THE BENCHMARKS WERE  
19 DETERMINED;

20 (E) THE TOTAL AMOUNT OF MONEY THAT THE COMMISSION DETERMINED SHOULD BE  
21 DISTRIBUTED FROM THE HIGH COST SUPPORT MECHANISM;

22 (F) THE TOTAL AMOUNT OF MONEY DISTRIBUTED TO EACH TELECOMMUNICATIONS  
23 SERVICE PROVIDER FROM THE HIGH COST SUPPORT MECHANISM;

24 (G) THE BASIS ON WHICH THE DISTRIBUTION TO TELECOMMUNICATIONS SERVICE  
25 PROVIDERS WAS CALCULATED;

26 (H) AS TO EACH TELECOMMUNICATIONS SERVICE PROVIDER RECEIVING A  
27 DISTRIBUTION, THE AMOUNT RECEIVED BY GEOGRAPHIC SUPPORT AREA AND TYPE OF  
28 CUSTOMER, THE WAY IN WHICH THE BENEFIT OF THE DISTRIBUTION WAS APPLIED  
29 OR ACCOUNTED FOR;

30 (I) THE PROPOSED BENCHMARKS, THE PROPOSED CONTRIBUTIONS TO BE  
31 COLLECTED THROUGH A RATE ELEMENT ASSESSMENT BY EACH TELECOMMUNICATIONS  
32 SERVICE PROVIDER, AND THE PROPOSED TOTAL AMOUNT OF THE HIGH COST SUPPORT  
33 MECHANISM FROM WHICH DISTRIBUTIONS ARE TO BE MADE FOR THE FOLLOWING  
34 CALENDAR YEAR; AND

35 (J) THE TOTAL AMOUNT OF DISTRIBUTIONS MADE FROM THE HIGH COST FUND,  
36 DIRECTLY OR INDIRECTLY, AND HOW THEY ARE BALANCED BY RATE REDUCTIONS BY  
37 ALL PROVIDERS FOR THE SAME PERIOD AND A FULL ACCOUNTING OF AND JUSTI-  
38 FICATION FOR ANY DIFFERENCE. IF THE REPORT SUBMITTED PURSUANT TO THIS  
39 SUBDIVISION CONTAINS A PROPOSAL FOR AN INCREASE IN ANY OF THE AMOUNTS  
40 LISTED IN PARAGRAPH (B) OF THIS SUBDIVISION, SUCH INCREASE SHALL BE  
41 SUSPENDED UNTIL MARCH THIRTY-FIRST OF THE FOLLOWING YEAR.

42 SUCH REPORT MUST ALSO DETERMINE WHAT AMOUNT OF UNEXPENDED FUNDS, IF  
43 ANY, AT THE END OF EACH FISCAL YEAR, COULD BE REFUNDED TO THE CONTRIBUT-  
44 ING TELECOMMUNICATIONS SERVICES PROVIDERS ON A BASIS THAT IS PROPOR-  
45 TIONAL TO THE AMOUNTS CONTRIBUTED BY SUCH TELECOMMUNICATIONS SERVICES  
46 PROVIDERS.

47 3. THERE IS HEREBY CREATED, IN THE STATE TREASURY, THE NEW YORK HIGH  
48 COST ADMINISTRATION FUND, REFERRED TO IN THIS SECTION AS THE "FUND",  
49 WHICH SHALL BE USED TO REIMBURSE THE COMMISSION AND, IF APPLICABLE, ITS  
50 CONTRACTORS, FOR REASONABLE EXPENSES INCURRED IN THE ADMINISTRATION OF  
51 THE HIGH COST SUPPORT MECHANISM AS DETERMINED BY RULES OF THE COMMIS-  
52 SION, AND SHALL BE AUDITED IN A MANNER AND FREQUENCY TO BE DETERMINED BY  
53 THE COMPTROLLER. THE MONEYS IN THE FUND THAT ARE TO BE USED FOR THE  
54 DIRECT AND INDIRECT ADMINISTRATIVE COSTS INCURRED BY THE COMMISSION AND  
55 ITS CONTRACTORS SHALL BE APPROPRIATED ANNUALLY BY THE LEGISLATURE. AT  
56 THE END OF ANY FISCAL YEAR, ALL UNEXPENDED AND UNENCUMBERED MONEYS IN

1 THE FUND SHALL REMAIN THEREIN AND SHALL NOT BE CREDITED OR TRANSFERRED  
 2 TO THE GENERAL FUND OR ANY OTHER FUND. BASED UPON THE BALANCE REMAINING  
 3 IN THE FUND AND THE AMOUNT APPROPRIATED ANNUALLY BY THE LEGISLATURE FOR  
 4 USE BY THE COMMISSION, EACH YEAR THE COMMISSION SHALL DETERMINE THE  
 5 NONDISCRIMINATORY, COMPETITIVELY NEUTRAL ASSESSMENT ON ALL TELECOMMUNI-  
 6 CATIONS SERVICE PROVIDERS IN NEW YORK THAT WILL BE NECESSARY TO COVER  
 7 THE COST OF IMPLEMENTING THE HIGH COST SUPPORT MECHANISM. ONLY THE  
 8 MONEYS FROM SUCH ASSESSMENT SHALL BE TRANSMITTED TO THE STATE TREASURER,

32 S 231. DEFINITIONS. THE WORDS AND PHRASES USED IN THIS ARTICLE SHALL  
 33 HAVE THE FOLLOWING MEANINGS UNLESS A DIFFERENT MEANING CLEARLY APPEARS  
 34 IN THE CONTEXT.

35 1. "CABLE SERVICE" SHALL MEAN THE ONE-WAY TRANSMISSION TO SUBSCRIBERS  
 36 OF VIDEO PROGRAMMING; OR OTHER PROGRAMMING SERVICE, AND SUBSCRIBER  
 37 INTERACTION, IF ANY, WHICH IS REQUIRED FOR THE SELECTION OR USE OF SUCH  
 38 VIDEO PROGRAMMING OR OTHER PROGRAMMING SERVICE, REGARDLESS OF THE TECH-  
 39 NOLOGY UTILIZED BY A CABLE TELEVISION COMPANY TO ENABLE SUCH SELECTION  
 40 OR USE.

41 2. "CABLE OPERATOR" SHALL MEAN ANY PERSON OR GROUP OF PERSONS (A) WHO  
 42 PROVIDES CABLE SERVICE OVER A CABLE SYSTEM AND DIRECTLY OR THROUGH ONE  
 43 OR MORE AFFILIATES OWNS A SIGNIFICANT INTEREST IN SUCH CABLE SYSTEM, OR  
 44 (B) WHO OTHERWISE CONTROLS OR IS RESPONSIBLE FOR, THROUGH ANY ARRANGE-  
 45 MENT, THE MANAGEMENT AND OPERATION OF SUCH A CABLE SYSTEM, AS SET FORTH  
 46 IN 47 U.S.C. S 522(5).

47 3. "CABLE SYSTEM" SHALL MEAN ANY FACILITY, CONSISTING OF A SET OF  
 48 CLOSED TRANSMISSION PATHS AND ASSOCIATED SIGNAL GENERATION, RECEPTION  
 49 AND CONTROL EQUIPMENT THAT IS DESIGNED TO PROVIDE CABLE SERVICE WHICH  
 50 INCLUDES VIDEO PROGRAMMING, WITHOUT REGARD TO THE TECHNOLOGY USED TO  
 51 DELIVER SUCH VIDEO PROGRAMMING, INCLUDING INTERNET PROTOCOL TECHNOLOGY  
 52 OR ANY SUCCESSOR TECHNOLOGY AND WHICH IS PROVIDED TO MULTIPLE SUBSCRIB-  
 53 ERS WITHIN A COMMUNITY, AS SET FORTH IN 47 U.S.C. S 522(7), BUT SUCH  
 54 TERM DOES NOT INCLUDE:

55 (A) A FACILITY THAT SERVES ONLY TO RETRANSMIT THE TELEVISION SIGNALS  
 56 OF ONE OR MORE TELEVISION BROADCAST STATIONS;

1 (B) A FACILITY THAT SERVES SUBSCRIBERS WITHOUT USING ANY PUBLIC  
2 RIGHT-OF-WAY;

3 (C) A FACILITY OF A COMMON CARRIER WHICH IS SUBJECT, IN WHOLE OR IN  
4 PART, TO THE PROVISIONS OF TITLE II OF THE COMMUNICATIONS ACT OF 1934,  
5 47 U.S.C. S 201 ET SEQ., EXCEPT THAT SUCH FACILITY SHALL BE CONSIDERED A  
6 CABLE SYSTEM (OTHER THAN FOR PURPOSES OF 47 U.S.C. S 541(C)) TO THE  
7 EXTENT SUCH FACILITY IS USED IN THE TRANSMISSION OF VIDEO PROGRAMMING  
8 DIRECTLY TO SUBSCRIBERS, UNLESS THE EXTENT OF SUCH USE IS SOLELY TO  
9 PROVIDE INTERACTIVE ON-DEMAND SERVICES;

10 (D) AN OPEN VIDEO SYSTEM THAT COMPLIES WITH 47 U.S.C. S 573; OR

11 (E) ANY FACILITIES OF ANY ELECTRIC UTILITY USED SOLELY FOR OPERATING  
12 ITS ELECTRIC UTILITY SYSTEM.

13 4. "CATV COMPANY" SHALL MEAN ANY PERSON OR GROUP OF PERSONS (A) WHO  
14 PROVIDES CABLE SERVICE OVER A CABLE SYSTEM AND DIRECTLY OR THROUGH ONE  
15 OR MORE AFFILIATES OWNS A SIGNIFICANT INTEREST IN SUCH CABLE SYSTEM, OR  
16 (B) WHO OTHERWISE CONTROLS OR IS RESPONSIBLE FOR, THROUGH ANY ARRANGE-  
17 MENT, THE MANAGEMENT AND OPERATION OF SUCH A CABLE SYSTEM.

18 5. "CATV SYSTEM" SHALL MEAN ANY FACILITY WHICH RECEIVES AND AMPLIFIES  
19 THE SIGNALS BROADCAST BY ONE OR MORE TELEVISION STATIONS AND REDISTRIB-  
20 UTES SUCH SIGNALS BY WIRE, CABLE OR OTHER MEANS, OR WHICH DISTRIBUTES  
21 SIGNALS IT ORIGINATES OR WHICH ARE ORIGINATED BY ANOTHER FOR VIEWING BY  
22 SUBSCRIBERS, WHETHER THE WIRE, CABLE OR OTHER FACILITIES ARE OWNED OR  
23 LEASED. A "CATV SYSTEM" SHALL NOT INCLUDE:

24 (A) THE POLES OR OTHER FACILITIES OF ANY TELEPHONE CORPORATION USED TO  
25 PROVIDE CHANNEL SERVICE AS A COMMON CARRIER,

26 (B) A SYSTEM SERVING NOT MORE THAN TWO HUNDRED FIFTY SUBSCRIBERS, OR

27 (C) A MASTER ANTENNA SYSTEM SERVICING SUBSCRIBERS SITUATED ON PROPERTY  
28 UNDER COMMON OWNERSHIP.

29 6. "COMMISSION" SHALL MEAN THE PUBLIC SERVICE COMMISSION OR ANY  
30 SUCCESSOR AGENCY.

31 7. "FRANCHISE" SHALL MEAN AN INITIAL AUTHORIZATION, OR RENEWAL OF AN  
32 AUTHORIZATION, ISSUED BY A FRANCHISING AUTHORITY, REGARDLESS OF WHETHER  
33 THE AUTHORIZATION IS DESIGNATED AS A FRANCHISE, PERMIT, LICENSE, RESOL-  
34 UTION, CONTRACT, CERTIFICATE, AGREEMENT, OR OTHERWISE, THAT AUTHORIZES  
35 THE CONSTRUCTION AND OPERATION OF A CABLE SYSTEM IN THE PUBLIC  
36 RIGHTS-OF-WAY.

37 8. "FRANCHISE HOLDER" OR "HOLDER" SHALL MEAN A PERSON WHO HAS RECEIVED  
38 A STATE-WIDE FRANCHISE, BUT HAS NOT TRANSFERRED OR TERMINATED SUCH FRAN-  
39 CHISE AUTHORIZATION, IN ACCORDANCE WITH THE PROVISIONS OF THIS ARTICLE.

40 9. "FRANCHISING AUTHORITY" SHALL MEAN THE PUBLIC SERVICE COMMISSION  
41 AND MUNICIPALITIES WHICH ARE ENTITLED TO REQUIRE FRANCHISES AND IMPOSE  
42 FEES IN ACCORDANCE WITH 47 U.S.C. SS 522(10) AND 542, RESPECTIVELY.

43 10. "GROSS REVENUES" SHALL MEAN ANY AND ALL REVENUES, INCLUDING CASH,  
44 CREDITS, PROPERTY OR OTHER CONSIDERATION OF ANY KIND OR NATURE ARISING  
45 FROM, ATTRIBUTABLE TO, OR IN ANY WAY DERIVED DIRECTLY OR INDIRECTLY FROM  
46 THE OPERATION OF THE FRANCHISEE'S CABLE SYSTEM (INCLUDING THE STUDIOS  
47 AND OTHER FACILITIES ASSOCIATED THEREWITH) TO PROVIDE CABLE SERVICES.  
48 GROSS REVENUES INCLUDE, BY WAY OF ILLUSTRATION AND NOT LIMITATION,  
49 MONTHLY FEES CHARGED SUBSCRIBERS FOR ANY BASIC, OPTIONAL, PREMIUM, PER-  
50 CHANNEL, PER-PROGRAM SERVICE, OR CABLE PROGRAMMING SERVICE; INSTALLA-  
51 TION, DISCONNECTION, RECONNECTION, AND CHANGE-IN-SERVICE FEES; LEASED  
52 CHANNEL FEES; LATE FEES AND ADMINISTRATIVE FEES, PAYMENTS, OR OTHER  
53 CONSIDERATION RECEIVED FROM PROGRAMMERS FOR CARRIAGE OF PROGRAMMING ON  
54 THE SYSTEM; REVENUES FROM RENTALS OR SALES OF CONVERTERS OR OTHER EQUIP-  
55 MENT; ANY STUDIO RENTAL, PRODUCTION EQUIPMENT, AND PERSONNEL FEES;  
56 ADVERTISING REVENUES; BARTER; REVENUES FROM PROGRAM GUIDES; REVENUES

1 FROM THE SALE OR CARRIAGE OF OTHER CABLE SERVICES; AND REVENUES FROM  
2 HOME SHOPPING CHANNELS AND OTHER REVENUE SHARING ARRANGEMENTS. GROSS  
3 REVENUES SHALL INCLUDE REVENUES RECEIVED BY ANY ENTITY OTHER THAN THE  
4 FRANCHISEE, AN AFFILIATE, OR ANOTHER ENTITY THAT OPERATES THE SYSTEM  
5 WHERE NECESSARY TO PREVENT EVASION OR AVOIDANCE OF THE OBLIGATION UNDER  
6 THIS STATUTE TO PAY THE FRANCHISE FEE. GROSS REVENUES SHALL NOT INCLUDE:

7 (A) AMOUNTS NOT ACTUALLY RECEIVED, EVEN IF BILLED, SUCH AS BAD DEBT;  
8 REFUNDS, REBATES OR DISCOUNTS TO SUBSCRIBERS OR THIRD PARTIES; OR REVENUE  
9 IMPUTED FROM THE PROVISION OF CABLE SERVICES FOR FREE OR AT REDUCED  
10 RATES TO ANY PERSON AS REQUIRED OR ALLOWED BY LAW, INCLUDING, WITHOUT  
11 LIMITATION, THE PROVISION OF SUCH SERVICES TO PUBLIC INSTITUTIONS,  
12 PUBLIC SCHOOLS, GOVERNMENTAL ENTITIES, OR EMPLOYEES, OTHER THAN FORGONE  
13 REVENUE CHOSEN NOT TO BE RECEIVED IN EXCHANGE FOR TRADES, BARTERS,  
14 SERVICES, OR OTHER ITEMS OF VALUE; OR

15 (B) ANY REVENUE FROM ANY CHARGES OR FEES DERIVED FROM SERVICES CLASSI-  
16 FIED AS NON-CABLE SERVICES AND INFORMATION SERVICES AND ANY OTHER REVEN-  
17 UES ATTRIBUTED BY THE HOLDER OF A CERTIFICATE OF APPROVAL OR SYSTEMWIDE  
18 FRANCHISE TO NON-CABLE SERVICES IN ACCORDANCE WITH FEDERAL COMMUNI-  
19 CATIONS COMMISSIONS RULES, REGULATIONS, STANDARDS, OR ORDERS.

20 IN THE CASE OF CABLE SERVICE THAT MAY BE BUNDLED OR INTEGRATED FUNC-  
21 TIONALLY WITH OTHER SERVICES, CAPABILITIES OR APPLICATIONS, THE GROSS  
22 REVENUES SHALL ONLY INCLUDE THOSE CHARGES OR FEES DERIVED FROM OR  
23 ATTRIBUTABLE TO THE PROVISION OF CABLE SERVICE, AS REFLECTED ON THE  
24 BOOKS AND RECORDS OF THE HOLDER OF A CERTIFICATE OF APPROVAL OR A  
25 SYSTEMWIDE FRANCHISE, AS THE CASE MAY BE, IN ACCORDANCE WITH THE RULES,  
26 REGULATIONS, STANDARDS AND ORDERS OF THE FEDERAL COMMUNICATIONS COMMIS-  
27 SION.

28 11. "INCUMBENT CABLE OPERATOR" SHALL MEAN THE CABLE OPERATOR SERVING  
29 THE LARGEST NUMBER OF CABLE SUBSCRIBERS IN A PARTICULAR MUNICIPAL FRAN-  
30 CHISE AREA ON THE EFFECTIVE DATE OF THIS ARTICLE.

31 12. "MUNICIPALITY" SHALL MEAN A CITY OR TOWN WITHIN THE STATE.

32 13. "PERSON" SHALL MEAN AN INDIVIDUAL, PARTNERSHIP, ASSOCIATION, JOINT  
33 STOCK COMPANY, TRUST, CORPORATION, GOVERNMENT ENTITY, LIMITED LIABILITY  
34 COMPANY OR ANY OTHER ENTITY.

35 14. "PUBLIC RIGHT-OF-WAY" SHALL MEAN THE AREA ON, BELOW OR ABOVE A  
36 PUBLIC ROADWAY, HIGHWAY, STREET, PUBLIC SIDEWALK, ALLEY, WATERWAY, OR  
37 UTILITY EASEMENT IN WHICH A MUNICIPALITY HAS AN INTEREST.

38 15. "VIDEO PROGRAMMING" SHALL MEAN PROGRAMMING PROVIDED BY, OR GENER-  
39 ALLY CONSIDERED COMPARABLE TO, PROGRAMMING PROVIDED BY A TELEVISION  
40 BROADCAST STATION, AS SET FORTH IN 47 U.S.C. S 522(20).

41 S 232. AUTHORIZATION TO PROVIDE CABLE SERVICE. 1. NOTWITHSTANDING ANY  
42 OTHER LAW TO THE CONTRARY AND SUBJECT TO THE PROVISIONS OF THIS ARTICLE,  
43 A PERSON SEEKING TO PROVIDE CABLE SERVICE IN THE STATE AFTER THE EFFEC-  
44 TIVE DATE OF THIS ARTICLE MAY FILE AN APPLICATION FOR A STATEWIDE FRAN-  
45 CHISE WITH THE COMMISSION AS REQUIRED BY THIS SECTION. THIS ARTICLE DOES  
46 NOT PRECLUDE CABLE OPERATORS FROM FILING INDIVIDUAL APPLICATIONS UNDER  
47 ARTICLE ELEVEN OF THIS CHAPTER, PROVIDED HOWEVER THAT A PERSON FILING AN  
48 APPLICATION FOR A STATEWIDE FRANCHISE WITH THE COMMISSION SHALL BE  
49 REQUIRED UPON RECEIPT OF SUCH FRANCHISE TO COMPLY WITH SECTIONS TWO  
50 HUNDRED FORTY-TWO AND TWO HUNDRED FORTY-THREE OF THIS ARTICLE WITH  
51 REGARD TO ALL IN-STATE BROADBAND AND BROADBAND-CAPABLE FACILITIES AND  
52 LINES BUILT DURING THE INITIAL BUILD-OUT PERIOD PURSUANT TO THE AUTHORI-  
53 ZATION PROVIDED BY SUCH FRANCHISE, AND FOR THE PERIOD OF THE INITIAL  
54 BUILD-OUT PERIOD WITH REGARD TO SUCH PERSON'S IN-STATE BROADBAND AND  
55 BROADBAND-CAPABLE FACILITIES AND LINES IN EXISTENCE WHEN SUCH FRANCHISE  
56 BECOMES EFFECTIVE.

1 2. A PERSON, INCLUDING AN INCUMBENT CABLE OPERATOR, PROVIDING CABLE  
2 SERVICE UNDER A FRANCHISE AGREEMENT WITH A FRANCHISING AUTHORITY WHICH  
3 EXISTED PRIOR TO THE EFFECTIVE DATE OF THIS ARTICLE IS NOT SUBJECT TO  
4 THIS SECTION UNTIL THE FRANCHISE AGREEMENT EXPIRES AT THE END OF ITS  
5 ORIGINAL OR ANY MUTUALLY AGREEABLE RENEWAL TERM, OR UNLESS AND UNTIL THE  
6 FRANCHISING AUTHORITY AND ENTITY PROVIDING CABLE SERVICE MUTUALLY AGREE  
7 TO TERMINATE THE EXISTING FRANCHISE AGREEMENT.

8 3. NOTHING IN THIS SECTION SHALL RESTRICT A CABLE OPERATOR FROM APPLY-  
9 ING TO THE COMMISSION FOR A STATEWIDE FRANCHISE TO PROVISION CABLE  
10 SERVICES IN TERRITORIES OF THE STATE FOR WHICH IT DOES NOT HAVE AN  
11 EXISTING FRANCHISE AGREEMENT WITH A FRANCHISING AUTHORITY. FOR PURPOSES  
12 OF THIS SECTION, A CABLE OPERATOR WILL BE DEEMED TO HAVE A FRANCHISE TO  
13 PROVIDE CABLE SERVICE IN THE JURISDICTION OF A SPECIFIC FRANCHISING  
14 AUTHORITY IF ANY AFFILIATE, PREDECESSOR OR SUCCESSOR ENTITY OF THE CABLE  
15 OPERATOR MAINTAINS A FRANCHISE GRANTED BY THAT FRANCHISING AUTHORITY.  
16 THE TERMS "AFFILIATE, PREDECESSOR OR SUCCESSOR ENTITY" IN THIS SECTION  
17 SHALL INCLUDE BUT NOT BE LIMITED TO ANY ENTITY RECEIVING, OBTAINING OR  
18 OPERATING UNDER A FRANCHISE FROM A FRANCHISING ENTITY FOR CABLE SERVICE  
19 THROUGH THE GRANT OF A FRANCHISE, MERGER, SALE, ASSIGNMENT, RESTRUCTUR-  
20 ING, OR ANY OTHER TYPE OF TRANSACTION.

21 4. THE COMMISSION SHALL HAVE THE FRANCHISING AUTHORITY TO ISSUE STATE-  
22 WIDE FRANCHISES FOR THE PROVISIONING OF CABLE SERVICE UNDER THIS ARTI-  
23 CLE. NEITHER THE COMMISSION NOR ANY MUNICIPALITY IN THE STATE MAY  
24 REQUIRE THE FRANCHISE HOLDER TO OBTAIN ANY SEPARATE OR ADDITIONAL FRAN-  
25 CHISE OR OTHERWISE IMPOSE ANY FEE OR OTHER REQUIREMENT, INCLUDING BUT  
26 NOT LIMITED TO THE REGULATION OF CABLE SERVICE RATES, ON ANY FRANCHISE  
27 HOLDER AS A CONDITION OF PROVIDING CABLE SERVICE, EXCEPT AS PROVIDED IN  
28 THIS ARTICLE.

29 5. 16 NYCRR S 895.3, AS AMENDED FROM TIME TO TIME, SHALL NOT APPLY TO  
30 THIS ARTICLE.

31 S 233. PUBLIC SERVICE COMMISSION RESPONSIBILITIES. 1. THE COMMISSION  
32 SHALL ASSIGN EXISTING PERMANENT STAFF OF SUCH LEGAL, TECHNICAL AND OTHER  
33 EMPLOYEES OF THE COMMISSION AS MAY BE REQUIRED FOR THE PROPER CONDUCT OF  
34 ITS CABLE FRANCHISING RESPONSIBILITIES UNDER THIS ARTICLE. THE POWERS  
35 AND DUTIES OF THE PUBLIC SERVICE COMMISSION WITH RESPECT TO STATEWIDE  
36 FRANCHISES SHALL NOT EXCEED THOSE PRESCRIBED IN THIS ARTICLE.

37 2. THE COMMISSION SHALL BE RESPONSIBLE FOR ESTABLISHING ADDITIONAL  
38 ADMINISTRATIVE PROCEDURES AND REGULATIONS NOT EXPLICITLY GRANTED IN THIS  
39 ARTICLE FOR THE ISSUANCE OF STATEWIDE FRANCHISES IN ACCORDANCE WITH THE

43 (A) DEVELOPMENT OF PROCEDURES TO SUBMIT, REVIEW AND DOCUMENT APPLICA-  
44 TIONS FILED WITH THE COMMISSION;

45 (B) REVIEW OF THE INITIAL SUBMISSION AND ANY UPDATES OF THE GENERAL  
46 DESCRIPTION OF THE SERVICE AREA FOOTPRINT TO BE SERVED OR EXPANDED,  
47 INCLUDING, IF APPLICABLE, ANY AREA WITHIN A MUNICIPALITY TO BE SERVED BY  
48 AN APPLICANT;

49 (C) DETERMINATION AND NOTICE OF INCOMPLETE APPLICATIONS;

50 (D) APPROVAL OF APPLICATIONS AND AMENDED APPLICATIONS, OR DENIAL OF  
51 SUCH APPLICATIONS, WITHIN THE PERIODS DESIGNATED UNDER THE PROVISIONS OF  
52 THIS ARTICLE;

53 (E) ISSUANCE TO APPLICANTS WHOSE APPLICATIONS ARE APPROVED FOR STATE-  
54 WIDE FRANCHISES TO PROVIDE CABLE SERVICE IN THE SERVICE AREA FOOTPRINT  
55 DESCRIBED IN THE APPLICATION; TO CONSTRUCT, UPGRADE, OPERATE OR MAINTAIN

1 A NETWORK CAPABLE OF PROVIDING SUCH SERVICE, AND TO USE AND OCCUPY THE  
2 PUBLIC RIGHTS-OF-WAY IN THE DELIVERY OF THAT SERVICE;

3 (F) DEVELOPMENT OF PROCEDURES TO REVIEW AND DOCUMENT THE TRANSFER OR  
4 TERMINATION OF A STATEWIDE FRANCHISE;

5 (G) ESTABLISH GUIDELINES IN ADDITION TO THOSE DEVELOPED BY MUNICI-  
6 PALITIES UNDER SECTION TWO HUNDRED THIRTY-EIGHT OF THIS ARTICLE, TO DEAL  
7 WITH ANY CONSUMER COMPLAINTS OR COMPLAINTS ALLEGING VIOLATIONS OF ANY  
8 PROVISIONS OF THIS ARTICLE. SUCH GUIDELINES SHALL BE EASILY ACCESSIBLE  
9 TO RESIDENTS OF THE STATE AND SHALL BE POSTED ON THE INTERNET. THE  
10 COMMISSION SHALL ALSO PROVIDE CONSUMER COMPLAINT FORMS ON THE INTERNET  
11 EVEN IF MUNICIPALITIES ESTABLISH THEIR OWN COMPLAINT FORMS. IN SUCH  
12 CASES, MUNICIPALITIES AND THE COMMISSION WILL WORK COOPERATIVELY TO  
13 ADDRESS CONSUMER COMPLAINTS.

14 S 234. APPLICATION FOR STATEWIDE CABLE FRANCHISE. 1. ANY PERSON WISH-  
15 ING TO PROVIDE CABLE SERVICE IN THE STATE AFTER THE EFFECTIVE DATE OF  
16 THIS ARTICLE MAY FILE AN APPLICATION FOR A STATEWIDE FRANCHISE WITH THE  
17 COMMISSION AS REQUIRED BY THIS SECTION. A STATEWIDE FRANCHISE APPLICA-  
18 TION SHALL BE ACCOMPANIED BY AN APPLICATION FEE OF TEN THOUSAND DOLLARS  
19 THAT SHALL BE USED BY THE COMMISSION TO CARRY OUT THE PURPOSES OF THIS  
20 ARTICLE. NOTHING IN THIS SECTION REQUIRES THAT ANY PERSON OR ENTITY FILE  
21 AN APPLICATION FOR A STATEWIDE FRANCHISE.

22 2. APPLICATIONS FOR A STATEWIDE FRANCHISE SHALL CONTAIN BUT NOT BE  
23 LIMITED TO:

24 (A) A STATEMENT THAT THE APPLICANT HAS FILED OR WILL TIMELY FILE WITH  
25 THE FEDERAL COMMUNICATIONS COMMISSION ALL FORMS REQUIRED BY THAT AGENCY  
26 IN ADVANCE OF OFFERING CABLE SERVICE IN THIS STATE;

27 (B) A STATEMENT THAT THE APPLICANT AGREES TO COMPLY WITH ALL OTHER  
28 APPLICABLE FEDERAL, STATE STATUTES AND REGULATIONS AND ALL GENERALLY  
29 APPLICABLE MUNICIPAL ORDINANCES AND REGULATIONS, INCLUDING WITHOUT LIMITATION  
30 MUNICIPAL ORDINANCES AND REGULATIONS REGARDING THE TIME, PLACE  
31 AND MANNER OF USING AND OCCUPYING PUBLIC RIGHTS-OF-WAY ADOPTED IN  
32 ACCORDANCE WITH STATE AND FEDERAL LAW;

33 (C) A GENERAL DESCRIPTION OF THE SERVICE AREA FOOTPRINT TO BE SERVED,  
34 INCLUDING, IF APPLICABLE, ANY AREA WITHIN A MUNICIPALITY TO BE SERVED BY  
35 THE APPLICANT. SUCH DESCRIPTION MAY BE SET FORTH ON ONE OR MORE MAPS. IF  
36 THE APPLICANT IS A TELEPHONE CORPORATION OR AN AFFILIATE OF A TELEPHONE

43 STATE-ISSUED FRANCHISE AREA AND ANY SERVICE AREA WITHIN THE FRANCHISE  
44 AREA MAY EXTEND BEYOND THE AREA OR AREAS WHERE THE APPLICANT HAS PRE-EXISTING  
45 AUTHORITY TO OCCUPY THE PUBLIC RIGHTS-OF-WAY;

46 (D) THE LOCATION OF THE APPLICANT'S PRINCIPAL PLACE OF BUSINESS, THE  
47 NAMES OF THE APPLICANT'S PRINCIPAL EXECUTIVE OFFICERS, AND THE NAME,  
48 ADDRESS AND TELEPHONE NUMBER OF AN OFFICER, GENERAL PARTNER OR OTHER  
49 EMPLOYEE OF THE APPLICANT WHO WILL BE RESPONSIBLE FOR ONGOING COMMUNICATIONS  
50 WITH THE COMMISSION;

51 (E) THE NAME AND LOCATION OF THE PRINCIPAL PLACE OF BUSINESS OF THE  
52 APPLICANT'S PARENT COMPANY, IF ANY;

53 (F) THE SIGNATURE OF AN OFFICER OR GENERAL PARTNER OF THE APPLICANT  
54 VERIFYING THE INFORMATION SET FORTH IN THE APPLICATION;

55 (G) DEMONSTRATE THE FINANCIAL, TECHNICAL, MANAGERIAL AND LEGAL CHARACTER  
56 AND OTHER QUALIFICATIONS NEEDED TO CONSTRUCT, OPERATE, AND MAINTAIN

1 THE NECESSARY PLANT AND TO PROVIDE SERVICE IN A SAFE, ADEQUATE AND PROP-  
2 ER MANNER;

3 (H) PROVIDE A RECORD OF COMPLIANCE WITH LOCAL, STATE AND FEDERAL LAWS;  
4 AND

5 (I) PROVIDE ADDITIONAL INFORMATION AS NEEDED BY THE COMMISSION.

6 3. UPON FILING AN APPLICATION WITH THE COMMISSION FOR A SYSTEMWIDE  
7 FRANCHISE AGREEMENT PURSUANT TO SUBDIVISION TWO OF THIS SECTION, THE  
8 APPLICANT SHALL INCLUDE A LIST OF THE SPECIFIC MUNICIPALITIES TO WHICH  
9 CATV SERVICE WILL BE PROVIDED OR EXTENDED, THE ANTICIPATED CONSTRUCTION  
10 AND DEPLOYMENT DATES, AND THE ANTICIPATED DATE ON WHICH SERVICE WILL BE  
11 OFFERED AND A CERTIFIED STATEMENT THAT SUCH DEPLOYMENT WILL MEET THE  
12 REQUIREMENTS OF SECTION TWO HUNDRED FORTY-FOUR OF THIS ARTICLE. THE  
13 APPLICANT WILL CONCURRENTLY PROVIDE A COPY OF THE APPLICATION TO EACH

15 4. WITHIN FIFTEEN BUSINESS DAYS AFTER IT RECEIVES THE APPLICATION, THE  
16 COMMISSION SHALL:

17 (A) DETERMINE WHETHER AN APPLICATION SUBMITTED IS INCOMPLETE; AND

18 (B) IF SO, THE COMMISSION SHALL NOTIFY THE APPLICANT THAT THE APPLICA-

20 RECEIVE FROM THE APPLICANT TO MAKE THE APPLICATION COMPLETE.

21 5. WITHIN SIXTY BUSINESS DAYS AFTER IT RECEIVES THE COMPLETED APPLICA-  
22 TION, THE COMMISSION SHALL APPROVE THE APPLICATION AND ISSUE A STATEWIDE  
23 FRANCHISE TO THE APPLICANT, OR DENY THE APPLICATION. WITHIN SIXTY DAYS  
24 OF THE RECEIPT THEREOF, THE COMMISSION SHALL SCHEDULE THREE PUBLIC HEAR-  
25 INGS TO BE HELD IN DIFFERENT GEOGRAPHICAL AREAS OF THE STATE TO GAIN  
26 PUBLIC COMMENT IN CONSIDERATION OF THE APPLICATION. ON OR BEFORE THE  
27 EXPIRATION OF THE SIXTY-DAY PERIOD, THE COMMISSION SHALL ISSUE AN ORDER  
28 IN WRITING APPROVING THE APPLICATION IF THE APPLICANT HAS COMPLIED WITH  
29 THE REQUIREMENTS FOR A STATEWIDE FRANCHISE, OR THE COMMISSION SHALL  
30 DISAPPROVE THE APPLICATION IN WRITING CITING THE REASONS FOR DISAPPROVAL  
31 IF THE BOARD DETERMINES THAT THE APPLICATION FOR A STATEWIDE FRANCHISE  
32 DOES NOT COMPLY WITH THE REQUIREMENTS FOR A STATEWIDE FRANCHISE. THE  
33 COMMISSION MAY DENY THE APPLICATION IF THE APPLICANT HAS FAILED TO STATE  
34 IN THE APPLICATION THE INFORMATION AND REPRESENTATIONS REQUIRED BY  
35 SUBDIVISION TWO OF THIS SECTION. IF THE COMMISSION DENIES THE APPLICA-  
36 TION, IT MUST SPECIFY WITH PARTICULARITY THE REASON OR REASONS FOR THE  
37 DENIAL, AND THE APPLICANT MAY AMEND ITS APPLICATION TO CURE ANY DEFI-  
38 CIENCY. THE COMMISSION SHALL DECIDE SUCH AMENDED APPLICATION WITHIN TEN  
39 BUSINESS DAYS OF ITS SUBMISSION TO THE COMMISSION BY THE APPLICANT. IF  
40 THE COMMISSION DENIES THE APPLICATION, THE COMMISSION SHALL SCHEDULE A  
41 PUBLIC MEETING WITH THE APPLICANT TO EXPLAIN TO THE APPLICANT THE  
42 REASONS FOR THE COMMISSION'S DISAPPROVAL. SUCH MEETING SHALL BE SCHED-  
43 ULED NO LATER THAN THIRTY DAYS FOLLOWING THE EXPIRATION OF THE SIXTY-DAY  
44 REVIEW PERIOD AS REQUIRED BY THIS SECTION. THE APPLICANT SHALL HAVE  
45 THIRTY DAYS FOLLOWING THE DATE OF THE MEETING WITH THE COMMISSION TO

47 SCHEDULE AN ADMINISTRATIVE HEARING NOT LATER THAN THE THIRTIETH DAY  
48 FOLLOWING THE DATE OF THE FILING OF THE APPLICANT'S APPEAL IN ORDER TO  
49 CONSIDER THE APPLICANT'S APPEAL. THE COMMISSION SHALL ISSUE A FINAL  
50 DECISION IN WRITTEN FORM ON THE APPLICANT'S APPEAL NOT LATER THAN THE  
51 SIXTIETH DAY FOLLOWING THE ADMINISTRATIVE HEARING, REQUIRED BY THIS  
52 SUBDIVISION, ON THE APPLICANT'S APPEAL. AFTER AN ADMINISTRATIVE PERIOD  
53 AN APPLICANT MAY CHALLENGE A DENIAL OF ITS APPLICATION OR AMENDED APPLI-  
54 CATION IN ANY COURT OF COMPETENT JURISDICTION.

55 6. A STATEWIDE FRANCHISE AUTHORIZATION ISSUED BY THE COMMISSION SHALL  
56 CONTAIN:

1 (A) A GRANT OF A FRANCHISE TO PROVIDE CABLE SERVICE IN THE SERVICE  
2 AREA FOOTPRINT DESCRIBED IN THE APPLICATION; TO CONSTRUCT, UPGRADE,  
3 OPERATE OR MAINTAIN A NETWORK CAPABLE OF PROVIDING SUCH SERVICE, EXCEPT  
4 WHERE THIS GRANT IS NOT REQUIRED AND TO USE AND OCCUPY THE PUBLIC  
5 RIGHTS-OF-WAY IN THE DELIVERY OF THAT SERVICE; AND

6 (B) A STATEMENT THAT THE FRANCHISE GRANT IN SUBDIVISION ONE OF THIS  
7 SECTION IS SUBJECT TO LAWFUL OPERATION OF THE CABLE SERVICE BY THE  
8 APPLICANT OR ITS SUCCESSOR IN INTEREST.

9 7. AN APPLICANT HAVING PRE-EXISTING AUTHORITY TO UTILIZE THE PUBLIC  
10 RIGHTS-OF-WAY IS REQUIRED TO OBTAIN A STATEWIDE FRANCHISE PRIOR TO THE  
11 ACTUAL PROVISION OF CABLE SERVICE ON A COMMERCIAL BASIS DIRECTLY TO  
12 SUBSCRIBERS. HOWEVER, SUCH AN APPLICANT IS NOT REQUIRED TO OBTAIN A  
13 STATEWIDE FRANCHISE OR ANY MUNICIPALITY AUTHORIZATION, EXCEPT FOR BEING

19 S 235. LENGTH OF STATEWIDE FRANCHISE. A STATEWIDE FRANCHISE ISSUED BY  
20 THE COMMISSION SHALL BE VALID FOR TEN YEARS FROM THE DATE OF ISSUANCE.  
21 RENEWAL OF A SYSTEMWIDE FRANCHISE SHALL BE VALID FOR A PERIOD OF FIFTEEN  
22 YEARS FROM THE DATE OF THE RENEWAL ISSUANCE, AND THE COMMISSION SHALL  
23 ESTABLISH RULES GOVERNING THE RENEWAL OF A SYSTEMWIDE FRANCHISE.

24 S 236. TERMINATION OF A STATEWIDE FRANCHISE. 1. A FRANCHISE SHALL  
25 TERMINATE AT THE EXPIRATION OF ITS TERM OR OTHERWISE IN ACCORDANCE WITH  
26 THE PROVISIONS THEREOF, UNLESS, PRIOR THERETO, THE COMMISSION OTHERWISE  
27 ORDERS. THE COMMISSION MAY SO ORDER ONLY IF IT FINDS, AFTER PUBLIC  
28 NOTICE AND OPPORTUNITY FOR A HEARING, THAT THE FRANCHISEE:

29 (A) HAS COMMITTED A MATERIAL BREACH OF ITS FRANCHISE OR ANY APPLICABLE  
30 PROVISION OF THIS ARTICLE OR OF THE REGULATIONS PROMULGATED HEREUNDER  
31 AND HAS FAILED, WITHOUT REASONABLE JUSTIFICATION, TO CURE SAID BREACH  
32 WITHIN SIXTY DAYS AFTER HAVING RECEIVED WRITTEN NOTICE THEREOF FROM THE  
33 COMMISSION; OR

34 (B) HAS NOT MET THE REQUIREMENTS OF SECTIONS TWO HUNDRED FORTY-THREE  
35 AND TWO HUNDRED FORTY-FOUR OF THIS ARTICLE;

36 (C) HAS ENGAGED IN BLOCKING OF LAWFUL CONTENT ON WEB SITES OR SERVICES  
37 OF COMPETITORS, OR REFUSED TO INTERCONNECT ITS FACILITIES WITH THE  
38 FACILITIES OF ANOTHER PROVIDER OF BROADBAND NETWORK SERVICES ON REASON-  
39 ABLE AND NONDISCRIMINATORY TERMS OR CONDITIONS; OR

40 (D) HAS BEEN ADJUDICATED A BANKRUPT OR HAS FILED A VOLUNTARY PETITION  
41 FOR BANKRUPTCY OR REORGANIZATION OR FOR AN ORDER PROTECTING ITS ASSETS  
42 FROM THE CLAIMS OF CREDITORS AND THE COMMISSION FINDS THAT TERMINATION  
43 OF THE FRANCHISE OR CERTIFICATE OF CONFIRMATION UNDER SUCH CONDITIONS IS  
44 IN THE BEST INTEREST OF THE PUBLIC.

45 2. UPON TERMINATION OF A FRANCHISE OR CERTIFICATE OF CONFIRMATION, THE  
46 CABLE OPERATOR SHALL DISPOSE OF ITS FACILITIES IN ACCORDANCE WITH THE  
47 PROVISIONS OF THE FRANCHISE OR CERTIFICATE. HOWEVER, ON MOTION OF ANY  
48 INTERESTED PARTY OR UPON ITS OWN MOTION, AND AFTER PUBLIC NOTICE AND  
49 OPPORTUNITY FOR HEARING, IF THE COMMISSION FINDS THAT THE CONTINUED  
50 PRESENCE OF THE FACILITIES IN ANY PUBLIC THOROUGHFARE WOULD POSE A  
51 NUISANCE TO THE MUNICIPALITY OR ITS RESIDENTS, THE OPERATOR SHALL REMOVE  
52 ITS FACILITIES WITHIN SUCH PERIOD AS THE COMMISSION SHALL ORDER. IN THE  
53 ABSENCE OF ANY APPLICABLE FRANCHISE OR CERTIFICATE PROVISION OR ORDER BY  
54 THE COMMISSION TO THE CONTRARY, THE CABLE TELEVISION COMPANY MAY ABANDON  
55 ITS FACILITIES.

1 S 237. ABANDONMENT OF SERVICE. 1. NO CABLE OPERATOR MAY ABANDON ANY  
2 SERVICE OR PORTION THEREOF WITHOUT GIVING SIX MONTHS' PRIOR WRITTEN  
3 NOTICE TO THE COMMISSION AND TO THE FRANCHISOR, IF ANY, AND TO THE MUNI-  
4 CIPALITIES IT SERVES.

5 2. WHEN ABANDONMENT OF ANY SERVICE IS PROHIBITED BY A FRANCHISE, NO  
6 CABLE OPERATOR MAY ABANDON SUCH SERVICE WITHOUT WRITTEN CONSENT OF THE  
7 COMMISSION. IN GRANTING SUCH CONSENT, THE COMMISSION MAY IMPOSE SUCH  
8 TERMS, CONDITIONS OR REQUIREMENTS AS IN ITS JUDGMENT ARE NECESSARY TO  
9 PROTECT THE PUBLIC INTEREST.

10 S 238. MUNICIPAL POWER AND REGULATION OVER FRANCHISE HOLDERS. A MUNI-  
11 CIPALITY MAY:

12 1. EXERCISE ITS PUBLIC RIGHTS-OF-WAY AUTHORITY OVER FRANCHISE HOLDERS,  
13 INCLUDING REQUIRING FRANCHISE HOLDERS TO FOLLOW MUNICIPAL ORDINANCES AS  
14 WELL AS ALL APPLICABLE LOCAL, STATE AND FEDERAL LAWS;

15 2. RECEIVE, MEDIATE, AND RESOLVE CABLE SERVICE QUALITY COMPLAINTS FROM  
16 A FRANCHISE HOLDER'S CUSTOMERS WITHIN THE MUNICIPALITY;

17 3. REQUIRE A FRANCHISE HOLDER WHO IS PROVIDING CABLE SERVICE WITHIN  
18 THE MUNICIPALITY TO REGISTER WITH THE MUNICIPALITY, MAINTAIN A POINT OF  
19 CONTACT, AND PROVIDE NOTICE OF ANY FRANCHISE AUTHORIZATION TRANSFER TO  
20 THE MUNICIPALITY WITHIN FOURTEEN BUSINESS DAYS AFTER THE COMPLETION OF  
21 THE TRANSFER;

22 4. ESTABLISH REASONABLE GUIDELINES REGARDING THE USE OF PUBLIC, EDUCA-  
23 TIONAL, AND GOVERNMENTAL ACCESS CHANNELS WITHIN THE MUNICIPALITY IN  
24 ADDITION TO THOSE ESTABLISHED IN SECTION TWO HUNDRED FORTY-ONE OF THIS  
25 ARTICLE.

26 S 239. PAYMENT AND REMITTANCE OF FRANCHISE FEE. 1. THE FRANCHISE HOLD-  
27 ER WHO OFFERS CABLE SERVICE WITHIN THE JURISDICTION OF A MUNICIPALITY  
28 SHALL CALCULATE AND REMIT TO THE MUNICIPALITY AT THE END OF EACH CALEN-  
29 DAR YEAR QUARTER A FRANCHISE FEE, AS PROVIDED IN THIS SECTION. THE OBLI-

40 3. NO FEE UNDER THIS SECTION WILL BECOME DUE UNTIL THE MUNICIPALITY  
41 CERTIFIES AND PROVIDES DOCUMENTATION TO THE FRANCHISE HOLDER SUPPORTING  
42 THE PERCENTAGE PAID BY ANY INCUMBENT CABLE OPERATOR SERVING THE AREA  
43 WITHIN THE MUNICIPALITY'S JURISDICTION.

44 4. NO MUNICIPALITY OR ANY OTHER POLITICAL SUBDIVISION OF THIS STATE  
45 MAY ASSESS ANY ADDITIONAL FEES OR CHARGES OR REQUIRE OTHER REMUNERATION  
46 OF ANY KIND FROM THE FRANCHISE HOLDER OTHER THAN AS SET FORTH IN THIS  
47 SECTION, PROVIDED, HOWEVER, THAT THE PROVISION OF IN-KIND SERVICES OR  
48 SUPPORT, PERSONNEL AND FUNDING DEDICATED TO PUBLIC, EDUCATIONAL AND  
49 GOVERNMENT FACILITIES AND SERVICES SHALL NOT BE CONSIDERED ADDITIONAL  
50 FEES, CHARGES OR REMUNERATION.

51 5. FOR PURPOSES OF THIS SECTION, IN THE CASE OF A CABLE SERVICE THAT  
52 MAY BE BUNDLED OR INTEGRATED FUNCTIONALLY WITH OTHER SERVICES, CAPABILI-  
53 TIES OR APPLICATIONS, THE FRANCHISE FEE SHALL BE APPLIED ONLY TO THE  
54 GROSS REVENUES, AS DEFINED IN THIS ARTICLE, ATTRIBUTABLE TO CABLE  
55 SERVICE OR THE USE OF THE CABLE SYSTEM AND FACILITIES, AS REFLECTED ON  
56 THE BOOKS AND RECORDS OF THE HOLDER IN ACCORDANCE WITH GENERALLY

1 ACCEPTED ACCOUNTING PRINCIPLES AND FEDERAL COMMUNICATIONS COMMISSION  
2 RULES, REGULATIONS, STANDARDS OR ORDERS, AS APPLICABLE.

3 6. THE FRANCHISE FEE SHALL BE REMITTED TO THE APPLICABLE MUNICIPALITY  
4 QUARTERLY, WITHIN FORTY-FIVE DAYS AFTER THE END OF THE QUARTER FOR THE  
5 PRECEDING CALENDAR QUARTER. EACH PAYMENT SHALL BE ACCOMPANIED BY A  
6 SUMMARY EXPLAINING THE BASIS FOR THE CALCULATION OF THE FRANCHISE FEE.  
7 NOT MORE THAN ONCE ANNUALLY, A MUNICIPALITY MAY EXAMINE THE FRANCHISE  
8 HOLDER'S BUSINESS RECORDS TO THE EXTENT REASONABLY NECESSARY TO ENSURE  
9 COMPENSATION IN ACCORDANCE WITH THIS SECTION. EACH PARTY SHALL BEAR THE  
10 PARTY'S OWN COSTS OF THE EXAMINATION. ANY CLAIMS BY A MUNICIPALITY THAT  
11 COMPENSATION IS NOT IN ACCORDANCE WITH THIS SECTION, AND ANY CLAIMS FOR  
12 REFUNDS OR OTHER CORRECTIONS TO THE REMITTANCE OF THE FRANCHISE HOLDER,  
13 MUST BE MADE WITHIN THREE YEARS AND FORTY-FIVE DAYS OF THE END OF THE  
14 QUARTER FOR WHICH COMPENSATION IS REMITTED, OR THREE YEARS FROM THE DATE  
15 OF REMITTANCE, WHICHEVER IS LATER. EITHER A MUNICIPALITY OR THE FRAN-  
16 CHISE HOLDER MAY, IN THE EVENT OF A DISPUTE CONCERNING COMPENSATION  
17 UNDER THIS SECTION, BRING AN ACTION IN A COURT OF COMPETENT JURISDIC-  
18 TION.

19 S 240. PUBLIC, EDUCATIONAL AND GOVERNMENT CHANNELS. 1. IN ADDITION TO  
20 THE REQUIREMENTS SET FORTH IN 16 NYCRR SEC. 894.4 (AS MAY BE AMENDED  
21 FROM TIME TO TIME), THE FRANCHISE HOLDER SHALL PROVIDE THE MUNICIPALITY  
22 WITH CAPACITY IN ITS CABLE SYSTEM TO ALLOW PUBLIC, EDUCATIONAL, AND  
23 GOVERNMENTAL (PEG) ACCESS CHANNELS FOR NONCOMMERCIAL PROGRAMMING. FOR  
24 THE PURPOSES OF THIS SECTION, PEG CHANNELS SHALL BE DEFINED AS ANALOG  
25 CHANNELS OF SIX MEGAHERTZ BANDWIDTH OR THE SAME AS ANY OTHER CHANNEL ON  
26 THE BASIC TIER, WHICHEVER IS GREATER. IN ADDITION TO THE REQUIREMENTS  
27 SET FORTH IN THIS SECTION, THE COMMISSION MAY ISSUE ADDITIONAL RULES OR  
28 GUIDELINES REGARDING PEG ACCESS CHANNELS. THE HOLDER SHALL PROVIDE THE  
29 SAME ANCILLARY SERVICES TO THE PEG CHANNELS AND ENTITIES AS THE INCUM-  
30 BENT PROVIDER.

31 2. THE FRANCHISE HOLDER SHALL DESIGNATE A SUFFICIENT AMOUNT OF CAPACI-  
32 TY ON ITS CABLE SYSTEM TO ALLOW THE PROVISION OF A COMPARABLE NUMBER OF  
33 PEG CHANNELS OR HOURS OF PROGRAMMING THAT THE INCUMBENT CABLE OPERATOR  
34 HAS ACTIVATED AND PROVIDED WITHIN THE MUNICIPALITY UNDER THE TERMS OF  
35 ITS FRANCHISE AGREEMENT AS OF THE EFFECTIVE DATE OF THIS ARTICLE. IF A  
36 MUNICIPALITY DID NOT HAVE PEG ACCESS CHANNELS AS OF THAT DATE, THE CABLE  
37 OPERATOR SHALL FURNISH TO THE MUNICIPALITY UPON REQUEST UP TO THREE PEG  
38 CHANNELS FOR A MUNICIPALITY WITH A POPULATION OF AT LEAST FIFTY THOUSAND  
39 AND UP TO TWO PEG CHANNELS FOR A MUNICIPALITY WITH A POPULATION OF LESS  
40 THAN FIFTY THOUSAND. FOR THE PURPOSES OF THIS SECTION, A PEG CHANNEL IS  
41 DEEMED ACTIVATED IF IT IS BEING UTILIZED FOR PEG PROGRAMMING WITHIN THE  
42 MUNICIPALITY FOR AT LEAST EIGHT HOURS PER DAY AND IF SUCH PROGRAMMING IS  
43 NOT BROADCAST MORE THAN ONCE IN EVERY EIGHT HOURS. THE HOLDER SHALL HAVE  
44 TWELVE MONTHS FROM THE DATE THE MUNICIPALITY REQUESTS SUCH PEG CHANNELS  
45 TO DESIGNATE THE CAPACITY; PROVIDED, HOWEVER, THAT THE TWELVE-MONTH  
46 PERIOD SHALL BE TOLLED BY ANY PERIOD DURING WHICH THE DESIGNATION OR  
47 PROVISION OF PEG CHANNEL CAPACITY IS TECHNICALLY INFEASIBLE, INCLUDING  
48 ANY FAILURE OR DELAY OF THE INCUMBENT CABLE OPERATOR TO MAKE ADEQUATE  
49 INTERCONNECTION AVAILABLE, AS REQUIRED BY THIS SECTION. IN CITIES WITH A  
50 POPULATION OF ONE MILLION OR MORE PERSONS, IF A SYSTEM HAS TOTAL ACTI-  
51 VATED BANDWIDTH IN EXCESS OF EIGHT HUNDRED SIXTY-TWO MEGAHERTZ THEN AT  
52 LEAST TWO ADDITIONAL PEG CHANNELS SHALL BE SET ASIDE BY THE HOLDER,  
53 INCLUDING ONE FOR PUBLIC ACCESS.

54 3. THE FRANCHISE HOLDER MAY SUBMIT TO THE COMMISSION AN APPLICATION TO  
55 CEASE PROVIDING ANY PEG CHANNEL PROVIDED PURSUANT TO THIS SECTION THAT  
56 IS NOT UTILIZED BY THE MUNICIPALITY FOR AT LEAST EIGHT HOURS PER DAY,

1 AND EXCEPT AS PROVIDED HEREIN, THE CHANNEL MAY THEREAFTER BE PROGRAMMED  
2 AT THE FRANCHISE HOLDER'S DISCRETION. THE COMMISSION MAY HOLD A HEARING  
3 IN THE MUNICIPALITY TO AID IN MAKING ITS DETERMINATION WHETHER TO  
4 APPROVE THE APPLICATION. THE COMMISSION SHALL ISSUE A DECISION WITHIN  
5 THIRTY BUSINESS DAYS OF THE FRANCHISEE'S APPLICATION. IF THE MUNICI-  
6 PALITY SUBSEQUENTLY CERTIFIES TO THE COMMISSION AND HOLDER A SCHEDULE  
7 FOR AT LEAST EIGHT HOURS OF DAILY NON-REPEAT PEG CHANNEL PROGRAMMING PER  
8 CHANNEL, THE HOLDER SHALL RESTORE THE PEG CHANNEL OR CHANNELS FOR THE  
9 USE OF THE MUNICIPALITY FOR AS LONG AS THE MUNICIPALITY USES THE CHANNEL  
10 OR CHANNELS FOR AT LEAST EIGHT HOURS A DAY.

11 4. THE CONTENT AND OPERATION OF ANY PEG ACCESS CHANNEL PROVIDED PURSU-  
12 ANT TO THIS SECTION SHALL BE THE RESPONSIBILITY OF THE MUNICIPALITY,  
13 RECEIVING THE BENEFIT OF SUCH CHANNEL, AND THE FRANCHISE HOLDER BEARS  
14 ONLY THE RESPONSIBILITY FOR THE TRANSMISSION OF SUCH CHANNEL, SUBJECT TO  
15 REASONABLE TECHNOLOGICAL CONSTRAINTS. THE FRANCHISE HOLDER SHALL BE  
16 RESPONSIBLE FOR PROVIDING THE CONNECTIVITY, AS WELL AS OTHER EQUIPMENT  
17 NECESSARY, TO EACH PEG ACCESS CHANNEL PROGRAMMING DISTRIBUTION LOCATION  
18 AND FOR DOING SO WITHOUT CHARGE FOR UP TO THE FIRST TWO HUNDRED FEET OF  
19 THE HOLDER'S CONNECTING FACILITIES.

20 5. THE MUNICIPALITY, OR ITS DESIGNEES, MUST ENSURE THAT ALL TRANS-  
21 MISSIONS, CONTENT, OR PROGRAMMING TO BE TRANSMITTED OVER A PEG ACCESS  
22 CHANNEL OR FACILITY BY A FRANCHISE HOLDER ARE PROVIDED OR SUBMITTED TO  
23 THE CABLE OPERATOR IN A MANNER OR FORM THAT IS CAPABLE OF BEING ACCEPTED  
24 AND TRANSMITTED BY THE CABLE OPERATOR, WITHOUT REQUIREMENT FOR ADDI-  
25 TIONAL ALTERATION OR CHANGE IN THE CONTENT BY THE CABLE OPERATOR, OVER  
26 THE CABLE SYSTEM OF THE CABLE OPERATOR. THE MUNICIPALITY'S, OR ITS  
27 DESIGNEES' PROVISION OF PEG CONTENT TO THE HOLDER SHALL CONSTITUTE  
28 AUTHORIZATION FOR THE HOLDER TO CARRY SUCH CONTENT INCLUDING, AT THE  
29 HOLDER'S OPTION, BEYOND THE JURISDICTIONAL BOUNDARIES OF THE MUNICI-  
30 PALITY.

31 6. THE FRANCHISE HOLDER AND AN INCUMBENT CABLE OPERATOR SHALL USE  
32 REASONABLE EFFORTS TO INTERCONNECT THEIR CABLE SYSTEMS FOR THE PURPOSE  
33 OF PROVIDING PEG PROGRAMMING. INTERCONNECTION MAY BE ACCOMPLISHED BY  
34 DIRECT CABLE, MICROWAVE LINK, SATELLITE, OR OTHER REASONABLE METHOD OF  
35 CONNECTION. FRANCHISE HOLDERS AND INCUMBENT CABLE OPERATORS SHALL NEGO-  
36 TIATE IN GOOD FAITH AND INCUMBENT CABLE OPERATORS MAY NOT WITHHOLD  
37 INTERCONNECTION OF PEG CHANNELS. IN THE EVENT A FRANCHISE HOLDER AND AN  
38 INCUMBENT CABLE OPERATOR CANNOT REACH A MUTUALLY ACCEPTABLE INTERCON-  
39 NECTION AGREEMENT, THEN THE DUTY OF THE HOLDER SHALL BE DISCHARGED IF  
40 THE HOLDER MAKES INTERCONNECTION AVAILABLE TO THE CHANNEL ORIGINATOR AT  
41 A POINT ON THE HOLDER'S NETWORK DETERMINED BY THE HOLDER.

42 7. THE PEG CHANNELS SHALL BE FOR THE EXCLUSIVE USE OF THE LOCAL ENTITY  
43 OR ITS DESIGNEE TO PROVIDE PUBLIC, EDUCATIONAL, AND GOVERNMENTAL CHAN-  
44 NELS. THE PEG CHANNELS SHALL BE USED ONLY FOR NONCOMMERCIAL PURPOSES.  
45 HOWEVER, ADVERTISING, UNDERWRITING, OR SPONSORSHIP RECOGNITION MAY BE  
46 CARRIED ON THE CHANNELS FOR THE PURPOSE OF FUNDING PEG-RELATED ACTIV-  
47 ITIES. THE PEG CHANNELS SHALL ALL BE CARRIED ON THE BASIC SERVICE TIER.  
48 TO THE EXTENT FEASIBLE, THE PEG CHANNELS SHALL NOT BE SEPARATED NUMER-  
49 ICALLY FROM OTHER CHANNELS CARRIED ON THE BASIC SERVICE TIER AND THE  
50 CHANNEL NUMBERS FOR THE PEG CHANNELS SHALL BE THE SAME CHANNEL NUMBERS  
51 USED BY THE INCUMBENT CABLE OPERATOR UNLESS PROHIBITED BY FEDERAL LAW.  
52 AFTER THE INITIAL DESIGNATION OF PEG CHANNEL NUMBERS, THE CHANNEL  
53 NUMBERS SHALL NOT BE CHANGED WITHOUT THE AGREEMENT OF THE LOCAL ENTITY  
54 UNLESS THE CHANGE IS REQUIRED BY FEDERAL LAW. EACH CHANNEL SHALL BE  
55 CAPABLE OF CARRYING A NATIONAL TELEVISION SYSTEM COMMITTEE (NTSC) TELE-  
56 VISION SIGNAL.

1 8. THE CONTENT TO BE PROVIDED OVER THE PEG CHANNEL CAPACITY PROVIDED  
2 PURSUANT TO THIS SECTION SHALL BE THE RESPONSIBILITY OF THE LOCAL ENTITY  
3 OR ITS DESIGNEE RECEIVING THE BENEFIT OF THAT CAPACITY, AND THE HOLDER  
4 OF A STATE FRANCHISE BEARS ONLY THE RESPONSIBILITY FOR THE TRANSMISSION  
5 OF THAT CONTENT, SUBJECT TO TECHNOLOGICAL RESTRAINTS.

6 9. THE PEG SIGNAL SHALL BE RECEIVABLE BY ALL SUBSCRIBERS, WHETHER THEY  
7 RECEIVE DIGITAL OR ANALOG SERVICE, OR A COMBINATION THEREOF, WITHOUT THE  
8 NEED FOR ANY EQUIPMENT OTHER THAN THE EQUIPMENT NECESSARY TO RECEIVE THE  
9 LOWEST COST TIER OF SERVICE. THE PEG ACCESS CAPACITY PROVIDED SHALL BE  
10 OF SIMILAR QUALITY AND FUNCTIONALITY TO THAT OFFERED BY COMMERCIAL CHAN-  
11 NELS ON THE LOWEST COST TIER OF SERVICE UNLESS THE SIGNAL IS PROVIDED TO  
12 THE HOLDER AT A LOWER QUALITY OR WITH LESS FUNCTIONALITY.

13 10. AFTER JANUARY FIRST, TWO THOUSAND FOURTEEN, AND UNTIL THE EXPIRA-  
14 TION OF THE INCUMBENT CABLE OPERATOR'S FRANCHISE, IF THE INCUMBENT CABLE  
15 OPERATOR HAS EXISTING UNSATISFIED OBLIGATIONS UNDER THE FRANCHISE TO  
16 REMIT TO THE LOCAL ENTITY OR ITS DESIGNEE ANY CASH PAYMENTS FOR THE  
17 ONGOING COSTS OF PUBLIC, EDUCATIONAL, AND GOVERNMENT ACCESS CHANNEL  
18 FACILITIES, THE LOCAL ENTITY, OR ITS DESIGNEE FOR THE PUBLIC ACCESS  
19 CHANNELS, SHALL DIVIDE THOSE CASH PAYMENTS AMONG ALL CABLE OR VIDEO  
20 PROVIDERS AS PROVIDED IN THIS SECTION. THE FEE SHALL BE THE HOLDER'S PRO  
21 RATA PER SUBSCRIBER SHARE OF THE CASH PAYMENT REQUIRED TO BE PAID BY THE  
22 INCUMBENT CABLE OPERATOR TO THE LOCAL ENTITY OR ITS DESIGNEE COMMUNITY  
23 ACCESS ORGANIZATION FOR THE COSTS OF PEG CHANNEL FACILITIES. ALL VIDEO  
24 SERVICE PROVIDERS AND THE INCUMBENT CABLE OPERATOR SHALL BE SUBJECT TO  
25 THE SAME REQUIREMENTS FOR RECURRING PAYMENTS FOR THE SUPPORT OF PEG  
26 CHANNEL FACILITIES, WHETHER EXPRESSED AS A PERCENTAGE OF GROSS REVENUE  
27 OR AS AN AMOUNT PER SUBSCRIBER, PER MONTH, OR OTHERWISE.

28 11. A LOCAL ENTITY SHALL ESTABLISH A PAYMENT FOR THE ONGOING SUPPORT  
29 OF THE COST OF PEG FACILITIES AND SERVICES THAT WOULD BECOME EFFECTIVE  
30 SUBSEQUENT TO THE EXPIRATION OF ANY FEE IMPOSED BY THIS ARTICLE,  
31 PROVIDED, HOWEVER, THAT NO SUCH FEE SHALL BE ALLOCATED SUCH THAT ANY  
32 COMMUNITY ACCESS ORGANIZATION IS RECEIVING ANYTHING LESS THAN WHAT IT IS  
33 RECEIVING FROM THE CABLE OPERATOR ON THE EFFECTIVE DATE OF THIS LEGIS-  
34 LATION, AND PROVIDED, HOWEVER, THAT EVERY LOCAL ENTITY SHALL BE ENTITLED  
35 TO A PAYMENT OF NOT LESS THAN TWO PERCENT FROM THE HOLDER OF A STATE  
36 FRANCHISE FOR THE ONGOING SUPPORT OF THE COST OF PEG FACILITIES AND  
37 SERVICES. IF, ON DECEMBER THIRTY-FIRST, TWO THOUSAND THIRTEEN, A LOCAL  
38 ENTITY OR ITS DESIGNEE WAS IMPOSING A SEPARATE FEE TO SUPPORT PEG CHAN-  
39 NEL FACILITIES THAT IS IN EXCESS OF TWO PERCENT, THAT ENTITY OR ITS  
40 DESIGNEE MAY ESTABLISH A FEE NO GREATER THAN THAT SEPARATE FEE, AND IN  
41 NO EVENT GREATER THAN THREE PERCENT, TO SUPPORT PEG ACTIVITIES. IF THE  
42 PEG SUPPORT FEE IMPOSED BY A LOCAL ENTITY OR ITS DESIGNEE IS EXPRESSED  
43 IN A MANNER OTHER THAN AS A PERCENTAGE OF GROSS REVENUES, THE LOCAL  
44 ENTITY OR ITS DESIGNEE COMMUNITY ACCESS ORGANIZATION MAY CONVERT THAT  
45 FEE TO A CURRENTLY EQUIVALENT PERCENTAGE OF GROSS REVENUES AT ANY TIME.  
46 THE LOCAL ENTITY OR ITS DESIGNEE MAY ADOPT REQUIREMENTS FOR THE  
47 PROVISION OF PEG-RELATED IN-KIND RESOURCES BY ALL CABLE AND VIDEO  
48 SERVICE PROVIDERS.

49 12. RULES AND REGULATIONS ADOPTED BY THE COMMUNITY ACCESS ORGANIZATION  
50 SHALL GOVERN THE USE OF ANY CHANNEL TIME ON THE PUBLIC CHANNELS AS WELL  
51 AS THE EQUIPMENT, FACILITIES AND SERVICES RELATED TO THE PUBLIC CHAN-  
52 NELS.

53 13. THE COMMISSION, THROUGH AN ADMINISTRATIVE PROCEEDING SHALL HAVE  
54 THE ORIGINAL JURISDICTION TO ENFORCE ANY REQUIREMENTS UNDER THIS SECTION  
55 TO RESOLVE ANY DISPUTE REGARDING THE REQUIREMENTS SET FORTH IN THIS  
56 SECTION. AFTER THE ADMINISTRATIVE PROCESS IS EXHAUSTED, A COURT OF

1 COMPETENT JURISDICTION SHALL HAVE JURISDICTION TO ENFORCE ANY REQUIRE-  
2 MENT UNDER THIS SECTION OR RESOLVE ANY DISPUTE REGARDING THE REQUIRE-  
3 MENTS SET FORTH IN THIS SECTION, AND NO CABLE OPERATOR MAY BE BARRED  
4 FROM THE PROVISION OF CABLE SERVICE OR BE REQUIRED TO TERMINATE CABLE  
5 SERVICE AS A RESULT OF SUCH DISPUTE OR ENFORCEMENT ACTION.

6 S 241. CABLE OPERATOR'S COMMUNITY COMMITMENT. 1. CABLE OPERATORS  
7 SHALL INSTALL AND RETAIN OR PROVIDE, WITHOUT CHARGE, ONE SERVICE OUTLET  
8 ACTIVATED FOR BASIC SERVICE TO ANY AND ALL FIRE STATIONS, PUBLIC  
9 SCHOOLS, POLICE STATIONS, PUBLIC LIBRARIES AND OTHER SUCH BUILDINGS USED  
10 FOR MUNICIPAL PURPOSES.

11 2. CABLE OPERATORS SHALL PROVIDE INTERNET SERVICE, WITHOUT CHARGE,  
12 THROUGH ONE SERVICE OUTLET ACTIVATED FOR BASIC SERVICE TO ANY AND ALL  
13 FIRE STATIONS, PUBLIC SCHOOLS, POLICE STATIONS, PUBLIC LIBRARIES, AND  
14 OTHER SUCH BUILDING USED FOR MUNICIPAL PURPOSES.

15 S 242. CONSUMER PROTECTION RULES. 1. EVERY CABLE OPERATOR SHALL  
16 PROVIDE SAFE, ADEQUATE AND RELIABLE SERVICE IN ACCORDANCE WITH APPLICA-  
17 BLE LAWS, REGULATIONS, AND FRANCHISE REQUIREMENTS. CABLE OPERATORS WITH  
18 A STATEWIDE FRANCHISE ARE SUBJECT TO THE REQUIREMENTS UNDER SECTIONS TWO  
19 HUNDRED TWENTY-FOUR AND TWO HUNDRED TWENTY-FOUR-A OF THIS CHAPTER AND  
20 ANY OTHER CUSTOMER SERVICE STANDARDS PERTAINING TO THE PROVISION OF  
21 VIDEO SERVICE ESTABLISHED BY FEDERAL LAW OR REGULATION OR ADOPTED BY  
22 SUBSEQUENT ENACTMENT OF THE LEGISLATURE. ALL CUSTOMER SERVICE AND  
23 CONSUMER PROTECTION STANDARDS UNDER THIS SECTION SHALL BE INTERPRETED  
24 AND APPLIED TO ACCOMMODATE NEWER OR DIFFERENT TECHNOLOGIES WHILE MEETING  
25 OR EXCEEDING THE GOALS OF THESE STANDARDS.

26 2. IN ADDITION, CABLE OPERATORS:

27 (A) SHALL CLEARLY AND CONSPICUOUSLY DISCLOSE TO USERS, IN PLAIN  
28 LANGUAGE, ACCURATE INFORMATION CONCERNING ANY TERMS, CONDITIONS, OR  
29 LIMITATIONS ON THE BROADBAND NETWORK SERVICE THEY OFFER, THE SPEEDS OF  
30 THE DOWNLOAD AND UPLOADING SPEEDS OF THE PROVIDER'S INTERNET SERVICE;

31 (B) PROVIDE THEIR BROADBAND NETWORK SERVICES ON REASONABLE AND NONDIS-  
32 CRIMINATORY TERMS AND CONDITIONS SUCH THAT ANY PERSON CAN OFFER OR  
33 PROVIDE CONTENT, APPLICATIONS, OR SERVICES TO OR OVER THE NETWORK IN A  
34 MANNER THAT IS AT LEAST EQUAL TO THE MANNER IN WHICH THE PROVIDER OR ITS  
35 AFFILIATES OFFER CONTENT, APPLICATIONS, AND SERVICES, FREE OF ANY  
36 SURCHARGE ON THE BASIS OF THE CONTENT, APPLICATION, OR SERVICE;

37 (C) INTERCONNECT THEIR FACILITIES WITH THE FACILITIES OF OTHER PROVID-  
38 ERS OF BROADBAND NETWORK SERVICES ON REASONABLE AND NONDISCRIMINATORY  
39 TERMS OR CONDITIONS.

40 S 243. NEUTRAL INTERNET AND BROADBAND NETWORKS. 1. CABLE OPERATORS  
41 SHALL NOT:

42 (A) BLOCK, IMPAIR, DISCRIMINATE AGAINST, OR INTERFERE WITH THE ABILITY  
43 OF ANY PERSON TO USE INTERNET BASED TRAFFIC BASED ON THE SOURCE, DESTI-  
44 NATION, OR OWNERSHIP OF THE INTERNET TRAFFIC THAT CARRIES VIDEO SERVICE,  
45 IN A MANNER THAT DEGRADES OR OTHERWISE NEGATIVELY IMPACTS THE ACCESS TO,  
46 OR THE QUALITY OF SERVICES RECEIVED BY AN END USER;

47 (B) ENGAGE IN ANY EXCLUSIVE OR PREFERENTIAL DEALINGS REGARDING THE  
48 CARRIAGE AND TREATMENT OF INTERNET TRAFFIC, INCLUDING, BUT NOT LIMITED  
49 TO, TRAFFIC THAT CARRIES VIDEO PROGRAMMING OR VIDEO SERVICE, WITH AN  
50 AFFILIATE OR THIRD PARTY PROVIDER OF INTERNET APPLICATIONS, SERVICES,  
51 CONTENT, OR VIDEO SERVICES;

52 (C) IMPOSE AN ADDITIONAL CHARGE TO AVOID ANY CONDUCT THAT IS PROHIBIT-  
53 ED BY THIS SECTION;

54 (D) PROHIBIT A USER FROM ATTACHING OR USING A DEVICE ON THE PROVIDER'S  
55 INTERNET OR BROADBAND NETWORK THAT DOES NOT PHYSICALLY DAMAGE OR MATE-  
56 Rially DEGRADE OTHER USERS' UTILIZATION OF THE NETWORK.

1 2. NOTHING IN THIS SECTION SHALL BE CONSTRUED TO PREVENT A BROADBAND  
2 OR INTERNET NETWORK PROVIDER FROM TAKING REASONABLE AND NONDISCRIMINATO-  
3 RY MEASURES:

4 (A) TO MANAGE THE FUNCTIONING OF ITS NETWORK TO PROTECT THE SECURITY  
5 AND TO OFFER PARENTAL CONTROLS AND OTHER CONSUMER PROTECTION MEASURES OF  
6 SUCH NETWORK AND BROADBAND OR INTERNET NETWORK SERVICES IF SUCH MANAGE-  
7 MENT DOES NOT RESULT IN DISCRIMINATION AMONG THE CONTENT, APPLICATIONS,  
8 OR SERVICES ON THE NETWORK;

9 (B) TO GIVE PRIORITY TO EMERGENCY COMMUNICATIONS; OR

10 (C) TO PREVENT A VIOLATION OF A FEDERAL OR STATE LAW, OR TO COMPLY  
11 WITH AN ORDER OF A COURT TO ENFORCE SUCH LAW, OR SUCH OTHER ACTION  
12 AGAINST NETWORK THREATS AS MAY BE AUTHORIZED IN SECTION TWO HUNDRED  
13 FIFTEEN OF THIS CHAPTER.

14 S 244. DEPLOYMENT REQUIREMENTS FOR STATEWIDE CABLE FRANCHISE. 1. AS  
15 PART OF ANY FRANCHISE ISSUED BY THE COMMISSION IN THIS ARTICLE, A CABLE  
16 OPERATOR SHALL BE REQUIRED TO:

17 (A) BEGIN PROVIDING CABLE SERVICE ON A COMMERCIAL BASIS, WITHIN THREE  
18 YEARS OF ISSUANCE OF THE SYSTEM-WIDE FRANCHISE, IN:

19 (I) EACH COUNTY SEAT THAT IS WITHIN THE CATV COMPANY'S SERVICE AREA;  
20 AND

21 (II) EACH MUNICIPALITY WITHIN THE CATV COMPANY'S SERVICE AREA THAT HAS  
22 A POPULATION DENSITY GREATER THAN SEVENTY-ONE HUNDRED ELEVEN PERSONS PER  
23 SQUARE MILE OF LAND AREA, AS DETERMINED BY THE MOST RECENT FEDERAL  
24 DECENNIAL CENSUS, PROVIDED, HOWEVER, THAT IF SUCH COUNTY SEATS ARE NOT  
25 LOCATED WITHIN OR CONTIGUOUS TO SUCH MUNICIPALITIES, EACH SUCH COUNTY  
26 SEAT SHALL BE INTERCONNECTED TO THE NEAREST MUNICIPALITY WITH A POPU-  
27 LATION DENSITY GREATER THAN PERSONS PER SQUARE MILE OF LAND AREA BY THE  
28 CABLE OPERATOR; AND

29 (B) MAKE CABLE TELEVISION SERVICE AVAILABLE THROUGHOUT THE RESIDENTIAL  
30 AREAS ON A COMMERCIAL BASIS, BEFORE THE BEGINNING OF THE SIXTH YEAR  
31 AFTER THE ISSUANCE OF THE SYSTEM-WIDE FRANCHISE, IN:

32 (I) EACH MUNICIPALITY WITHIN THE STATE THAT HAS A POPULATION DENSITY  
33 GREATER THAN FIVE HUNDRED ONE PERSONS PER SQUARE MILE OF LAND AREA, AS  
34 DETERMINED BY THE MOST RECENT FEDERAL DECENNIAL CENSUS; AND

35 (II) THROUGHOUT THE RESIDENTIAL AREAS OF ANY MUNICIPALITIES SERVED BY  
36 CENTRAL OFFICES LOCATED WITHIN A COUNTY SEAT WITHIN THE FRANCHISEE'S  
37 SERVICE AREA, SUBJECT TO THE CABLE OPERATOR'S LINE EXTENSION POLICY;  
38 PROVIDED, HOWEVER, A CATV COMPANY MAY APPLY TO THE COMMISSION FOR AN  
39 EXEMPTION FROM THIS REQUIREMENT IF THE BOARD FINDS, AFTER CONDUCTING A  
40 HEARING WITH FULL NOTICE AND OPPORTUNITY TO BE HEARD, THAT THE AREAS IN  
41 QUESTION ARE AREAS IN WHICH THE CATV COMPANY IS UNABLE TO ACCESS THE  
42 PUBLIC RIGHTS-OF-WAY UNDER REASONABLE TERMS AND CONDITIONS.

43 2. THE REQUIREMENTS OF SUBDIVISION ONE OF THIS SECTION SHALL ONLY  
44 APPLY TO CABLE OPERATORS THAT ON THE DATE OF THE ISSUANCE OF THE  
45 SYSTEM-WIDE FRANCHISE PROVIDE MORE THAN FORTY PERCENT OF THE LOCAL  
46 EXCHANGE TELEPHONE SERVICE MARKET IN THIS STATE; AND TO CABLE OPERATORS  
47 THAT ON THE DATE OF THE ISSUANCE OF THE SYSTEM-WIDE FRANCHISE PROVIDE  
48 TWO HUNDRED FIFTY THOUSAND OR MORE LOCAL EXCHANGE TELEPHONE LINES IN  
49 THIS STATE;

50 3. INCUMBENT CABLE COMPANIES THAT BECOME STATEWIDE FRANCHISE HOLDERS  
51 SHALL NOT REDUCE THE NUMBER OR PERCENTAGE OF HOUSEHOLDS SERVED; WILL  
52 BUILD OUT TO ALL RESIDENTIAL HOUSEHOLDS SUBJECT TO THE OPERATOR'S LINE  
53 EXTENSION POLICY WITHIN THREE YEARS; AND WILL UPGRADE THEIR FACILITIES  
54 TO THE ENTIRE SERVICE AREA WITHIN THREE YEARS OF THE DATE THE CABLE  
55 OPERATOR UPGRADES ANY PART OF ITS FACILITIES.

1 4. WITHIN THREE YEARS OF THE ISSUANCE OF THE SYSTEM-WIDE FRANCHISE ALL  
2 OTHER STATEWIDE FRANCHISE HOLDERS SHALL FULLY COMPLETE A SYSTEM CAPABLE  
3 OF PROVIDING CABLE SERVICE TO ALL HOUSEHOLDS WITHIN THE CABLE OPERATOR'S  
4 SERVICE AREA, SUBJECT TO THE CABLE OPERATOR'S LINE EXTENSION POLICY.

5 S 245. DISCRIMINATION IN THE PROVISIONING OF SERVICE PROHIBITED. 1.  
6 THE FRANCHISE HOLDER SHALL BECOME CAPABLE OF PROVIDING CABLE SERVICE TO  
7 ALL HOUSEHOLDS WITHIN THE DESIGNATED SERVICE AREA FOOTPRINT. A CABLE  
8 OPERATOR THAT HAS BEEN GRANTED A STATEWIDE FRANCHISE UNDER THIS ARTICLE  
9 SHALL NOT DENY ACCESS TO CABLE SERVICE TO ANY GROUP OF POTENTIAL RESI-  
10 DENTIAL SUBSCRIBERS BECAUSE OF THE INCOME OR RACE OF THE RESIDENTS IN  
11 THE LOCAL AREA IN WHICH SUCH GROUP RESIDES. A FRANCHISEE MUST SUBMIT TO  
12 THE COMMISSION A DEPLOYMENT SCHEDULE, SETTING FORTH THE MUNICIPALITIES  
13 TO BE SERVED, THE DATE SERVICE SHALL BEGIN IN EACH PROPOSED MUNICI-  
14 PALITY, AND A DATE CERTAIN BY WHICH EACH COMMUNITY WILL BE ABLE TO  
15 RECEIVE CABLE SERVICE. THE COMMISSION WILL ENSURE THAT THE BUILD-OUT  
16 PROCESS IS NOT DISCRIMINATORY BASED ON AN AREA'S CLASS OR RACE. IF  
17 DEPLOYMENT OF CABLE SERVICES UNDER A STATEWIDE FRANCHISE IS SCHEDULED  
18 FOR DEPLOYMENT IN A GIVEN AREA, THE CABLE OPERATOR MUST OFFER SERVICE TO  
19 ALL RESIDENTS WITHIN THE GEOGRAPHIC AREA OR THE COMMISSION MAY TERMINATE  
20 THE FRANCHISE PURSUANT TO SECTION TWO HUNDRED THIRTY-SIX OF THIS ARTI-  
21 CLE.

22 2. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE FRANCHISE HOLDER  
23 SHALL COMPLY WITH CUSTOMER SERVICE REQUIREMENTS SET FORTH IN ARTICLE  
24 ELEVEN OF THIS CHAPTER, AT 47 C.F.R. S 76.309(C) AND ANY OTHER CUSTOMER  
25 SERVICE STANDARDS PERTAINING TO THE PROVISION OF VIDEO SERVICE ESTAB-  
26 LISHED BY FEDERAL LAW OR REGULATION OR BY SUBSEQUENT ENACTMENT OF THE  
27 LEGISLATURE. ALL CUSTOMER SERVICE AND CONSUMER PROTECTION STANDARDS  
28 UNDER THIS SECTION SHALL BE INTERPRETED AND APPLIED TO ACCOMMODATE NEWER  
29 OR DIFFERENT TECHNOLOGIES WHILE MEETING OR EXCEEDING THE GOALS OF THESE  
30 STANDARDS.

31 3. IF THE COMMISSION DETERMINES THAT A CABLE OPERATOR HAS DENIED  
32 ACCESS OF CABLE SERVICE TO A GROUP OF POTENTIAL RESIDENTIAL SUBSCRIBERS  
33 BECAUSE OF THE INCOME LEVELS OF THE RESIDENTS OF THE LOCAL AREA IN WHICH  
34 SUCH GROUP RESIDES OR HAS FAILED TO MEET THE REQUIREMENTS OF THE  
35 SECTION, THE COMMISSION IS AUTHORIZED TO, AFTER CONDUCTING A HEARING  
36 WITH FULL NOTICE AND OPPORTUNITY TO BE HEARD, IMPOSE MONETARY PENALTIES  
37 OF NOT LESS THAN FIFTY THOUSAND DOLLARS, NOR MORE THAN ONE HUNDRED THOU-  
38 SAND DOLLARS PER MUNICIPALITY, NOT TO EXCEED A TOTAL OF THREE MILLION  
39 SIX HUNDRED FIFTY THOUSAND DOLLARS PER YEAR FOR ALL VIOLATIONS. A MUNI-  
40 CIPALITY IN WHICH THE PROVIDER OFFERS CABLE SERVICE SHALL BE AN APPRO-  
41 PRIATE PARTY IN ANY SUCH PROCEEDING.

42 S 246. ENFORCEMENT. THE EXCLUSIVE REMEDY FOR ENFORCING THE PROVISIONS  
43 OF THIS ARTICLE, NOTWITHSTANDING SPECIFIC SECTIONS OF THIS ARTICLE,  
44 SHALL BE AN ACTION IN A COURT OF COMPETENT JURISDICTION BROUGHT BY  
45 EITHER THE MUNICIPALITY, THE ATTORNEY GENERAL ON BEHALF OF THE COMMIS-  
46 SION OR OTHER INJURED PARTY. AT LEAST SIXTY DAYS BEFORE BRINGING SUCH AN  
47 ACTION, THE MUNICIPALITY OR ATTORNEY GENERAL SHALL SERVE THE FRANCHISE  
48 HOLDER WITH A NOTICE SETTING OUT THE ALLEGED VIOLATION AND STATING THAT  
49 AN ACTION MAY BE BROUGHT UNLESS THE HOLDER CORRECTS THE ALLEGED  
50 VIOLATION OR ENTERS INTO A BINDING AGREEMENT TO CORRECT THE VIOLATION  
51 WITHIN THE SIXTY-DAY NOTICE PERIOD. THE NOTICE SHALL CONTAIN A SUFFI-  
52 CIENTLY DETAILED DESCRIPTION OF THE ALLEGED VIOLATION TO ENABLE THE  
53 FRANCHISE HOLDER TO MAKE A SPECIFIC RESPONSE.

54 S 6. Section 215 of the public service law is amended by adding a new  
55 subdivision 14 to read as follows:

1 14. REQUIRE THAT CABLE TELEVISION FRANCHISES CONTAIN, UPON SUBMISSION  
2 FOR CERTIFICATES OF CONFIRMATION, PROVISIONS REQUIRING THAT THE CABLE  
3 TELEVISION SERVICES FRANCHISEE DELIVER TO THE FRANCHISOR AND THE COMMIS-  
4 SION, ON AN ANNUAL BASIS, A WRITTEN REPORT DESCRIBING EVERY INSTANCE IN  
5 WHICH SUCH FRANCHISEE BLOCKS, LIMITS OR OTHERWISE RESTRICTS SUBSCRIBERS  
6 OR OTHER PURCHASERS OF BROADBAND SERVICES FROM THE FRANCHISEE FROM  
7 ACCESSING ANY PARTICULAR INTERNET SITE OR CATEGORY OR TYPE OF INTERNET  
8 SITE OR ANY SPECIFIC ELECTRONIC MAIL MESSAGE OR CATEGORY OR TYPE OF  
9 ELECTRONIC MAIL ("NEUTRALITY REPORT"). SUCH NEUTRALITY REPORT SHALL  
10 CONTAIN DETAIL OF A SPECIFICITY LEVEL TO BE DETERMINED BY THE COMMIS-  
11 SION, AND SHALL CONTAIN SUFFICIENT DETAIL TO ALLOW THE COMMISSION OR THE  
12 FRANCHISOR TO ASCERTAIN THE NATURE OF ANY BLOCKING, LIMITATION OR OTHER  
13 RESTRICTIONS, AND THE REASON FOR THE FRANCHISEE FOR TAKING SUCH ACTION,  
14 BUT SHALL BE PROVIDED IN A MANNER REASONABLY CALCULATED TO PROTECT  
15 SUBSCRIBER PRIVACY OR THE LEGITIMATE NEEDS OF LAW ENFORCEMENT. NOTHING  
16 IN THIS SUBDIVISION SHALL BE INTERPRETED TO RESTRICT THE RIGHTS OF FRAN-  
17 CHISEES, IF THEY SO CHOOSE, TO BLOCK, LIMIT OR OTHERWISE RESTRICT THE  
18 PASSAGE OF ELECTRONIC MAIL MESSAGES OR OTHER CONTENT THAT TRANSMIT,  
19 PORTRAY, DESCRIBE, REPRESENT OR OTHERWISE CONTAIN MATTERS SUCH AS CHILD  
20 PORNOGRAPHY OR SIMILAR OBSCENITY, OTHER UNLAWFUL MATERIAL, THREATS OF  
21 SERIOUS BODILY HARM, THREATS TO THE PUBLIC SAFETY AND HOMELAND SECURITY,  
22 THREATS OF DEATH TO INDIVIDUALS OR GROUPS OF INDIVIDUALS, VIRUSES OR  
23 SIMILAR COMPUTER GENERATED PROGRAMS OR CODE THAT HAVE THE POTENTIAL TO  
24 HARM COMPUTER HARDWARE AND/OR SOFTWARE AND/OR NETWORKS, EXCESSIVE UNSO-  
25 LICITED COMMERCIAL EMAIL THAT DEGRADES OR INTERFERES WITH OR HARMS THE  
26 NORMAL OPERATION OF BROADBAND NETWORKS, AND OTHER SIMILAR TYPES OR FORMS  
27 OF MATERIAL OR SOFTWARE (THE FOREGOING EXAMPLES ARE ILLUSTRATIVE, NOT  
28 EXHAUSTIVE OF SUCH THREATS TO USERS AND/OR THE NETWORK, COLLECTIVELY  
29 HEREFTER "NETWORK THREATS"). BLOCKING OR LIMITATION OF SUBSCRIBER  
30 ACCESS TO THE MAXIMALLY DIVERSE INTERNET, IF NOT PREDICATED UPON THE  
31 FRANCHISEE'S RIGHT TO DEFEND ITS NETWORK AND SUBSCRIBERS AGAINST  
32 "NETWORK THREATS", SHALL PRESUMPTIVELY BE A BREACH OF THE FRANCHISE. NO  
33 FRANCHISEE SHALL BE RESPONSIBLE OR LIABLE FOR ANY EFFORTS BY OR POLI-  
34 CIES, PRACTICES OR PROCEDURES OF AN UNAFFILIATED TELECOMMUNICATIONS  
35 SERVICES PROVIDER OR INTERNET SERVICES PROVIDER OR INTERNET PROTOCOL  
36 TRAFFIC ROUTING ENTITY TO BLOCK SUBSCRIBERS FROM ACCESSING ANY INTERNET  
37 SITE OR ANY CATEGORY OR TYPE OF INTERNET SITE OR ANY SPECIFIC ELECTRONIC  
38 MAIL MESSAGE OR ANY CATEGORY OR TYPE OF ELECTRONIC MAIL.

39 S 7. Section 99 of the public service law is amended by adding a new  
40 subdivision 4 to read as follows:

41 4. NO BUILDING OWNER MAY DISCRIMINATE AGAINST A TELEPHONE COMPANY,  
42 BROADBAND SERVICES OR ADVANCED COMMUNICATIONS COMPANY OR THEIR ABILITY  
43 TO PROVIDE SERVICES TO ONE OR MORE TENANTS OF A MULTI-TENANT PROPERTY  
44 THAT IS OWNED OR CONTROLLED BY THE BUILDING OWNER, INCLUDING DISCRIMINA-  
45 TORY TERMS AND CONDITIONS BY WHICH THE TELEPHONE COMPANY, BROADBAND  
46 SERVICES OR ADVANCED COMMUNICATIONS COMPANY GAIN PHYSICAL ACCESS TO THE  
47 PROPERTY TO PLACE ITS FACILITIES AND PROVIDE TELECOMMUNICATIONS SERVICES  
48 TO THE PROPERTY'S TENANTS. THE COMMISSION SHALL HAVE JURISDICTION TO  
49 IMPLEMENT THE PROVISIONS OF THIS SUBDIVISION BY APPROPRIATE RULES AND  
50 REGULATIONS AND TO ADMINISTRATIVELY ADJUDICATE DISPUTES ARISING UNDER  
51 THIS SUBDIVISION. IN NO EVENT MAY THE LACK OF AGREEMENT OVER TERMS AND  
52 CONDITIONS OF ACCESS DELAY THE ABILITY OF A REQUESTING TELECOMMUNI-  
53 CATIONS COMPANY TO OBTAIN ACCESS FOR MORE THAN THIRTY DAYS FOLLOWING AN  
54 INITIAL REQUEST THEREFOR.

55 S 8. Subdivision 2 of section 99 of the public service law, as amended  
56 by chapter 383 of the laws of 1996, is amended to read as follows:

1 2. (A) No franchise nor any right to or under any franchise to own or  
2 operate a telegraph line or telephone line shall be assigned, trans-  
3 ferred, or leased, nor shall any contract or agreement hereafter made  
4 with reference to or affecting any such franchise or right be valid or  
5 of any force or effect whatsoever[,] unless the assignment, transfer,  
6 lease, contract, or agreement shall have been approved by the commis-  
7 sion.

8 (B) No telephone corporation shall transfer or lease its works or  
9 system or any part of such works or system to any other person or corpo-  
10 ration or contract for the operation of its works or system[,] without  
11 the written consent of the commission. [Notwithstanding the foregoing,  
12 any such transfer or lease between affiliated corporations with an  
13 original cost of (a) less than one hundred thousand dollars proposed by  
14 a telephone corporation having annual gross revenues in excess of two  
15 hundred million dollars, (b) less than twenty-five thousand dollars  
16 proposed by a telephone corporation having annual gross revenues of less  
17 than two hundred million but more than ten million dollars or (c) less  
18 than ten thousand dollars proposed by a telephone corporation having  
19 annual gross revenues of less than ten million dollars and any other  
20 transfer or lease between non-affiliates regardless of cost shall be  
21 effective without the commission's written consent within ninety days  
22 after such corporation notifies the commission that it plans to complete  
23 such transfer or lease and submits a description of the transfer or  
24 lease, unless the commission, or its designee, determines within such  
25 ninety days that the public interest requires the commission's review  
26 and written consent.]

27 (C) (1) NO CONSENT SHALL BE GIVEN BY THE COMMISSION TO THE ASSIGNMENT,  
28 TRANSFER, OR LEASE OF ANY RIGHT OR FRANCHISE TO OPERATE A TELEGRAPH LINE  
29 OR TELEPHONE LINE UNLESS IT SHALL HAVE BEEN SHOWN THAT SUCH ASSIGNMENT,  
30 TRANSFER, OR LEASE IS IN THE PUBLIC INTEREST.

31 (2) NO CONSENT SHALL BE GIVEN BY THE COMMISSION TO THE ASSIGNMENT,  
32 TRANSFER, OR LEASE OF ANY RIGHT OR FRANCHISE TO OPERATE ANY PART OF A  
33 TELEPHONE CORPORATION'S WORKS OR SYSTEM, OR TO A CONTRACT FOR THE OPERA-  
34 TION OF SUCH ENTITY'S WORKS OR SYSTEM, UNLESS IT SHALL HAVE BEEN SHOWN  
35 THAT SUCH ASSIGNMENT, TRANSFER, OR LEASE OR CONTRACT IS IN THE PUBLIC  
36 INTEREST.

37 (D) BEFORE AUTHORIZING THE MERGER, ACQUISITION, ASSIGNMENT, LEASE, OR  
38 TRANSFER OF CONTROL OF ANY TELEPHONE CORPORATION ORGANIZED AND DOING  
39 BUSINESS IN THIS STATE, WHERE ANY OF THE ENTITIES THAT ARE PARTIES TO  
40 THE PROPOSED TRANSACTION HAS GROSS ANNUAL NEW YORK REVENUES EXCEEDING  
41 TWO HUNDRED MILLION DOLLARS, THE COMMISSION SHALL FIND THAT THE PROPOSAL  
42 DOES ALL OF THE FOLLOWING:

44 (2) EQUITABLY ALLOCATES, WHERE THE COMMISSION HAS RATEMAKING AUTHORI-  
45 TY, THE TOTAL SHORT-TERM AND LONG-TERM FORECASTED ECONOMIC BENEFITS, AS  
46 DETERMINED BY THE COMMISSION, OF THE PROPOSED MERGER, ACQUISITION, OR  
47 CONTROL BETWEEN SHAREHOLDERS AND RATEPAYERS. RATEPAYERS SHALL RECEIVE  
48 NOT LESS THAN FORTY PERCENT OF SUCH BENEFITS.

49 (3) MAINTAINS OR IMPROVES THE FINANCIAL CONDITION OF THE RESULTING  
50 TELEPHONE CORPORATIONS DOING BUSINESS IN THE STATE AND DOES NOT UNREA-  
51 SONABLY ALLOCATE A TELEPHONE CORPORATION'S DEBT TO A DIVESTITURE ENTITY  
52 CREATED FROM AN EXISTING TELEPHONE CORPORATION. FOR THE PURPOSE OF THIS  
53 SECTION, A DIVESTITURE ENTITY IS A BUSINESS ENTITY CREATED BY THE  
54 ASSIGNMENT, EXCHANGE, SALE, OR OTHER TRANSFER OF SOME OR ALL OF AN  
55 EXISTING TELEPHONE CORPORATION'S LINES, SYSTEM, OR WORKS TO A NEW TELE-  
56 PHONE CORPORATION.

1 (4) MAINTAINS OR IMPROVES THE QUALITY OF SERVICE TO TELEPHONE CORPO-  
2 RATION RATEPAYERS IN THE STATE.

3 (5) MAINTAINS OR IMPROVES THE QUALITY OF MANAGEMENT OF THE RESULTING  
4 TELEPHONE CORPORATION DOING BUSINESS IN THE STATE.

5 (6) IS FAIR AND REASONABLE TO AFFECTED TELEPHONE CORPORATION EMPLOY-  
6 EES, INCLUDING BOTH UNION AND NONUNION EMPLOYEES.

7 (7) IS FAIR AND REASONABLE TO THE MAJORITY OF ALL AFFECTED TELEPHONE  
8 CORPORATIONS.

9 (8) IS BENEFICIAL ON AN OVERALL BASIS TO STATE AND LOCAL ECONOMIES AND  
10 TO THE COMMUNITIES IN THE AREA SERVED BY THE RESULTING ENTITY AND DOES  
11 NOT ALLOCATE SUBSTANTIALLY UNFUNDED PENSION OR HEALTH CARE OBLIGATIONS  
12 OR OTHER EMPLOYEE BENEFITS TO A RESULTING TELEPHONE CORPORATION.

13 (9) PRESERVES THE JURISDICTION OF THE COMMISSION AND THE CAPACITY OF  
14 THE COMMISSION TO EFFECTIVELY REGULATE AND AUDIT TELEPHONE CORPORATION  
15 OPERATIONS IN THE STATE.

16 (10) PROVIDES MITIGATION MEASURES TO PREVENT SIGNIFICANT ADVERSE  
17 CONSEQUENCES WHICH MAY RESULT.

18 (11) DOES NOT ADVERSELY AFFECT COMPETITION. IN MAKING THIS FINDING,  
19 THE COMMISSION SHALL REQUEST AN ADVISORY OPINION FROM THE ATTORNEY  
20 GENERAL REGARDING WHETHER OR NOT COMPETITION WILL BE ADVERSELY AFFECTED  
21 AND WHAT MITIGATORY MEASURES COULD BE ADOPTED TO AVOID ANY SUCH ADVERSE  
22 EFFECT.

23 (E) WHEN REVIEWING A MERGER, ACQUISITION, OR TRANSFER OF CONTROL  
24 PROPOSAL, THE COMMISSION SHALL CONSIDER REASONABLE ALTERNATIVES OR  
25 MODIFICATIONS TO THE PROPOSAL RECOMMENDED BY OTHER PARTIES, INCLUDING NO  
26 MERGER, ACQUISITION, OR CONTROL, TO DETERMINE WHETHER OR NOT COMPARABLE  
27 SHORT-TERM AND LONG-TERM ECONOMIC SAVINGS CAN BE ACHIEVED THROUGH OTHER  
28 MEANS WHILE AVOIDING THE POSSIBLE ADVERSE CONSEQUENCES OF THE PROPOSAL.

29 (F) THE PERSON OR CORPORATION SEEKING ACQUISITION OR CONTROL OF A  
30 TELEPHONE CORPORATION ORGANIZED AND DOING BUSINESS IN THIS STATE SHALL  
31 HAVE BEFORE THE COMMISSION THE BURDEN OF PROVING BY A PREPONDERANCE OF  
32 THE EVIDENCE THAT THE REQUIREMENTS OF PARAGRAPH (D) OF THIS SUBDIVISION  
33 ARE MET.

34 (G) IN DETERMINING WHETHER OR NOT AN ACQUIRING TELEPHONE CORPORATION  
35 HAS GROSS ANNUAL REVENUES EXCEEDING THE AMOUNT SPECIFIED IN PARAGRAPH  
36 (D) OF THIS SUBDIVISION, THE REVENUES OF THAT TELEPHONE CORPORATION'S  
37 AFFILIATES SHALL NOT BE CONSIDERED, UNLESS THE AFFILIATE IS TO BE  
38 UTILIZED FOR THE PURPOSE OF EFFECTING SUCH MERGER, ACQUISITION, OR  
39 CONTROL.

40 (H) SUBPARAGRAPHS ONE AND TWO OF PARAGRAPH (D) OF THIS SUBDIVISION  
41 SHALL NOT APPLY TO THE FORMATION OF A HOLDING COMPANY.

42 (I) SUBPARAGRAPHS ONE AND TWO OF PARAGRAPH (D) OF THIS SUBDIVISION  
43 SHALL NOT APPLY TO ACQUISITIONS OR CHANGES IN CONTROL THAT ARE MANDATED  
44 BY EITHER THE COMMISSION OR THE LEGISLATURE.

45 S 9. Section 100 of the public service law, as amended by chapter 226  
46 of the laws of 2009, is amended to read as follows:

47 S 100. Transfer and ownership of stock. 1. No telegraph corporation or

9 telephone corporation[, ] or any portion thereof.

10 3. (A) No consent shall be given by the commission to the acquisition  
11 of any stock in accordance with this section unless it shall have been  
12 shown that such acquisition is in the public interest[; provided, howev-  
13 er, that any], WHICH THE COMMISSION SHALL DETERMINE BY FINDING THAT THE  
14 PROPOSAL DOES ALL OF THE FOLLOWING, TO THE EXTENT DETERMINED TO BE  
15 APPLICABLE:

17 (II) EQUITABLY ALLOCATES, WHERE APPLICABLE AND WHERE THE COMMISSION  
18 HAS RATEMAKING AUTHORITY, THE TOTAL SHORT-TERM AND LONG-TERM FORECASTED  
19 ECONOMIC BENEFITS, AS DETERMINED BY THE COMMISSION, OF THE PROPOSED  
20 ACQUISITION, PURCHASE, SALE, TRANSFER, OR RETENTION BETWEEN SHAREHOLDERS  
21 AND RATEPAYERS. RATEPAYERS SHALL RECEIVE NOT LESS THAN FORTY PERCENT OF  
22 THOSE BENEFITS.

23 (III) MAINTAINS OR IMPROVES THE FINANCIAL CONDITION OF THE RESULTING  
24 TELEPHONE CORPORATIONS DOING BUSINESS IN THE STATE AND DOES NOT UNREA-  
25 SONABLY ALLOCATE A TELEPHONE CORPORATION'S DEBT TO A DIVESTITURE ENTITY  
26 CREATED FROM AN EXISTING TELEPHONE CORPORATION. FOR THE PURPOSE OF THIS  
27 SECTION, A DIVESTITURE ENTITY IS A BUSINESS ENTITY CREATED BY THE  
28 ASSIGNMENT, EXCHANGE, SALE, OR OTHER TRANSFER OF SOME OR ALL OF AN  
29 EXISTING TELEPHONE CORPORATION'S LINES, SYSTEM, OR WORKS TO A NEW TELE-  
30 PHONE CORPORATION.

31 (IV) MAINTAINS OR IMPROVES THE QUALITY OF SERVICE TO TELEPHONE CORPO-  
32 RATION RATEPAYERS IN THE STATE.

33 (V) MAINTAINS OR IMPROVES THE QUALITY OF MANAGEMENT OF THE RESULTING  
34 TELEPHONE CORPORATION DOING BUSINESS IN THE STATE.

35 (VI) IS FAIR AND REASONABLE TO AFFECTED TELEPHONE CORPORATION EMPLOY-  
36 EES, INCLUDING BOTH UNION AND NON-UNION EMPLOYEES.

37 (VII) IS FAIR AND REASONABLE TO THE MAJORITY OF ALL AFFECTED TELEPHONE  
38 CORPORATIONS.

39 (VIII) IS BENEFICIAL, ON AN OVERALL BASIS, TO STATE AND LOCAL ECONO-  
40 MIES, AND TO THE COMMUNITIES IN THE AREA SERVED BY THE RESULTING ENTITY  
41 AND DOES NOT ALLOCATE SUBSTANTIALLY UNFUNDED PENSION OR HEALTH CARE  
42 OBLIGATIONS OR OTHER EMPLOYEE BENEFITS TO A RESULTING TELEPHONE CORPO-  
43 RATION.

44 (IX) PRESERVES THE JURISDICTION OF THE COMMISSION AND THE CAPACITY OF  
45 THE COMMISSION TO EFFECTIVELY REGULATE AND AUDIT TELEPHONE CORPORATION  
46 OPERATIONS IN THE STATE.

47 (X) PROVIDES MITIGATION MEASURES TO PREVENT SIGNIFICANTLY ADVERSE  
48 CONSEQUENCES WHICH MAY RESULT FROM SUCH ACQUISITION.

49 (XI) DOES NOT ADVERSELY AFFECT COMPETITION. IN MAKING THIS FINDING,  
50 THE COMMISSION SHALL REQUEST AN ADVISORY OPINION FROM THE ATTORNEY  
51 GENERAL REGARDING WHETHER OR NOT COMPETITION WILL BE ADVERSELY AFFECTED  
52 AND WHAT MITIGATORY MEASURES COULD BE ADOPTED TO AVOID ANY SUCH ADVERSE

54 (B) ANY such consent, HOWEVER, shall be deemed to be granted by the  
55 commission ninety days after such corporation applies to the commission

31 IS HEREIN DEFINED FOR THE PURPOSES OF THIS ARTICLE TO INCLUDE CONDUITS,  
32 DUCTS, POLES, WIRES, FIBEROPTIC CABLE AND/OR LINES, COAXIAL CABLE,  
33 COPPER TWISTED PAIR TELEPHONE LINES, RECEIVERS, TRANSMITTERS, BROADCAST  
34 RADIO FREQUENCY BANDWIDTH, LASERS AND MULTIPLEXERS, TRANSMITTERS,  
35 INSTRUMENTS, MACHINES, APPLIANCES AND ALL DEVICES, REAL ESTATE, EASE-  
36 MENTS, APPARATUS, PROPERTY AND ROUTES USED AND/OR OPERATED BY STATE  
37 AGENCIES.

38 2. ALL STATE AGENCIES SHALL, WITHIN ONE HUNDRED FIFTY DAYS OF THE  
39 EFFECTIVE DATE OF THIS SECTION, IDENTIFY THE EXCESS CAPACITY AND BAND-  
40 WIDTH REPORTED UPON WHICH MAY BE LEASED ON A NON-DISCRIMINATORY AND

42 NICATIONS CARRIERS THAT NEED SUCH CAPACITY TO PROVIDE BROADBAND SERVICES

44 BANDWIDTH SO IDENTIFIED SHALL BE REPORTED UPON.

46 EFFECTIVE DATE OF THIS SECTION, IDENTIFY AND REPORT UPON ALL TELECOMMU-  
47 NICATIONS SERVICES PURCHASED, LEASED OR OTHERWISE USED BY THE AGENCIES  
48 THAT MAY BE USED IN A TELECOMMUNICATIONS DEMAND AGGREGATION PROGRAM  
49 ADMINISTERED BY THE STATE BROADBAND DEVELOPMENT AND DEPLOYMENT COUNCIL  
50 PURSUANT TO SECTION FOUR THOUSAND ONE HUNDRED FIVE OF THE PUBLIC AUTHOR-  
51 ITIES LAW.

52 4. (A) ALL STATE AGENCIES SHALL, WITHIN NINETY DAYS OF THE EFFECTIVE  
53 DATE OF THIS SECTION, INSTALL TELECOMMUNICATIONS-GRADE CONDUIT AND  
54 ANTENNA ATTACHMENT POINTS IN AND/OR ON ALL INFRASTRUCTURE PROJECTS NEWLY  
55 CONSTRUCTED OR UPGRADED BY SUCH AGENCIES, FOR LEASE ON A NON-DISCRIMINA-  
56 TORY AND COMMERCIALY REASONABLE BASIS TO PUBLIC ENTITIES OR CERTIFIED

1 TELECOMMUNICATIONS CARRIERS THAT NEED SUCH CAPACITY TO PROVIDE BROADBAND

7 (B) THE STATE OFFICE OF GENERAL SERVICES SHALL, WITHIN NINETY DAYS OF  
8 THE EFFECTIVE DATE OF THIS SECTION, MAKE WIRELESS INTERNET ACCESS AVAIL-  
9 ABLE TO THE PUBLIC IN PUBLICLY ACCESSIBLE AND HIGHLY-TRAFFICKED AREAS OF  
10 THE STATE CAPITOL AND THE LEGISLATIVE OFFICE BUILDING, AND SUCH OTHER  
11 PUBLICLY ACCESSIBLE AND HIGHLY-TRAFFICKED OFFICE OF GENERAL SERVICES  
12 MANAGED STATE BUILDINGS AS IS REASONABLE AND PRUDENT.

13 5. ALL REPORTS PROVIDED FOR IN THIS SECTION SHALL BE DELIVERED

35 AND THE CHAIR AND RANKING MINORITY MEMBER OF THE ASSEMBLY CORPORATIONS,

37 COMMISSION, COMMISSIONER OF THE DEPARTMENT OF ECONOMIC DEVELOPMENT,  
38 COMMISSIONER OF THE EMPIRE STATE DEVELOPMENT CORPORATION AND THE CHAIRS

46 SPEAKER OF THE ASSEMBLY, MINORITY LEADERS OF THE SENATE AND ASSEMBLY,  
47 CHAIR AND RANKING MINORITY MEMBER OF THE SENATE ENERGY AND TELECOMMUNI-  
48 CATIONS COMMITTEE, AND THE CHAIR AND RANKING MINORITY MEMBER OF THE  
49 ASSEMBLY CORPORATIONS, AUTHORITIES AND COMMISSIONS COMMITTEE, CHAIR-  
50 PERSON OF THE PUBLIC SERVICE COMMISSION, COMMISSIONER OF THE DEPARTMENT  
51 OF ECONOMIC DEVELOPMENT, COMMISSIONER OF THE EMPIRE STATE DEVELOPMENT

6 PURCHASED, LEASED OR OTHERWISE USED BY THE AUTHORITIES THAT MAY BE USED  
7 IN A TELECOMMUNICATIONS DEMAND AGGREGATION PROGRAM ADMINISTERED BY THE  
8 STATE BROADBAND DEVELOPMENT AND DEPLOYMENT COUNCIL.

9 (B) ALL STATE AUTHORITIES SHALL, FROM THE EFFECTIVE DATE OF THIS  
10 SECTION, INSTALL TELECOMMUNICATIONS-GRADE CONDUIT AND ANTENNA ATTACHMENT  
11 POINTS IN AND/OR ON ALL INFRASTRUCTURE PROJECTS NEWLY CONSTRUCTED OR  
12 UPGRADED BY SUCH AGENCIES, FOR LEASE ON A NON-DISCRIMINATORY AND COMMER-  
13 CIALY REASONABLE BASIS TO PUBLIC ENTITIES OR CERTIFIED TELECOMMUNI-  
14 CATIONS CARRIERS THAT NEED SUCH CAPACITY TO PROVIDE BROADBAND SERVICES  
15 TO UNSERVED, UNDERSERVED AND DISTRESSED AREAS. STATE AUTHORITIES MAY,  
16 HOWEVER, EXEMPT FROM THIS REQUIREMENT INFRASTRUCTURE WHERE SUCH INSTAL-  
17 LATIONS COULD POSE A THREAT TO PUBLIC SAFETY OR OTHERWISE BE UNREASON-  
18 ABLE. SUCH CONDUIT AND ANTENNA ATTACHMENT POINT INSTALLATIONS SHALL BE  
19 REPORTED ON A SEMI-ANNUAL BASIS.

20 (C) ALL STATE AUTHORITY REPORTS PROVIDED FOR IN THIS SECTION SHALL BE  
21 DELIVERED INITIALLY, AND THEREAFTER ON AN ANNUAL BASIS UNLESS OTHERWISE  
22 SPECIFIED, TO THE GOVERNOR, TEMPORARY PRESIDENT OF THE SENATE, SPEAKER  
23 OF THE ASSEMBLY, MINORITY LEADERS OF THE SENATE AND ASSEMBLY, CHAIR AND  
24 RANKING MINORITY MEMBER OF THE SENATE ENERGY AND TELECOMMUNICATIONS  
25 COMMITTEE, AND THE CHAIR AND RANKING MINORITY MEMBER OF THE ASSEMBLY  
26 CORPORATIONS, AUTHORITIES AND COMMISSIONS COMMITTEE, CHAIR OF THE PUBLIC  
27 SERVICE COMMISSION, COMMISSIONER OF THE EMPIRE STATE DEVELOPMENT CORPO-  
28 RATION AND THE CHAIRPERSONS OF THE BROADBAND DEVELOPMENT AND DEPLOYMENT  
29 COUNCIL AND BROADBAND DEVELOPMENT AUTHORITY.

30 (D) TELECOMMUNICATIONS INFRASTRUCTURE IS DEFINED FOR THE PURPOSES OF  
31 THIS ARTICLE TO INCLUDE CONDUITS, DUCTS, POLES, WIRES, FIBEROPTIC CABLE  
32 AND/OR LINES, COAXIAL CABLE, COPPER TWISTED PAIR TELEPHONE LINES,  
33 RECEIVERS, TRANSMITTERS, BROADCAST RADIO FREQUENCY BANDWIDTH, LASERS AND  
34 MULTIPLEXERS, TRANSMITTERS, INSTRUMENTS, MACHINES, APPLIANCES AND ALL  
35 DEVICES, REAL ESTATE, EASEMENTS, APPARATUS, PROPERTY AND ROUTES USED  
36 AND/OR OPERATED BY STATE AUTHORITIES AND LOCAL AUTHORITIES.

37 2. LOCAL AUTHORITIES. (A) FOR THE PURPOSE OF FURNISHING THE STATE WITH  
38 SYSTEMATIC INFORMATION REGARDING THE EXISTING, NEWLY CONSTRUCTED AND  
39 PLANNED TELECOMMUNICATIONS INFRASTRUCTURE RESOURCES OF PUBLIC AUTHORI-

42 (I) WITHIN NINETY DAYS OF THE EFFECTIVE DATE OF THIS SECTION, SUBMIT  
43 TO THE GOVERNOR, TEMPORARY PRESIDENT OF THE SENATE, SPEAKER OF THE  
44 ASSEMBLY, MINORITY LEADERS OF THE SENATE AND ASSEMBLY, CHAIR AND RANKING  
45 MINORITY MEMBER OF THE SENATE ENERGY AND TELECOMMUNICATIONS COMMITTEE,  
46 AND THE CHAIR AND RANKING MINORITY MEMBER OF THE ASSEMBLY CORPORATIONS,  
47 AUTHORITIES AND COMMISSIONS COMMITTEE, CHAIR OF THE PUBLIC SERVICE  
48 COMMISSION, COMMISSIONER OF THE EMPIRE STATE DEVELOPMENT CORPORATION AND  
49 THE CHAIRS OF THE BROADBAND DEVELOPMENT AND DEPLOYMENT COUNCIL AND  
50 BROADBAND DEVELOPMENT AUTHORITY, A COMPLETE AND DETAILED REPORT OR  
51 REPORTS UPON THE PHYSICAL LOCATION AND/OR FREQUENCY, AND AMOUNT OF ALL  
52 EXCESS CAPACITY, WITHIN THE TELECOMMUNICATIONS INFRASTRUCTURE AND RADIO  
53 FREQUENCY BANDWIDTH OWNED, LICENSED OR OTHERWISE CONTROLLED BY STATE  
54 AUTHORITIES;

55 (II) WITHIN ONE HUNDRED FIFTY DAYS OF THE EFFECTIVE DATE OF THIS  
56 SECTION, SUBMIT TO THE GOVERNOR, TEMPORARY PRESIDENT OF THE SENATE,

1 SPEAKER OF THE ASSEMBLY, MINORITY LEADERS OF THE SENATE AND ASSEMBLY,  
2 CHAIR AND RANKING MINORITY MEMBER OF THE SENATE ENERGY AND TELECOMMUNI-  
3 CATIONS COMMITTEE, AND THE CHAIR AND RANKING MINORITY MEMBER OF THE  
4 ASSEMBLY CORPORATIONS, AUTHORITIES AND COMMISSIONS COMMITTEE, CHAIR OF  
5 THE PUBLIC SERVICE COMMISSION, COMMISSIONER OF THE EMPIRE STATE DEVELOP-  
6 MENT CORPORATION AND THE CHAIRS OF THE BROADBAND DEVELOPMENT AND DEPLOY-  
7 MENT COUNCIL AND BROADBAND DEVELOPMENT AUTHORITY, A COMPLETE AND  
8 DETAILED REPORT OR REPORTS IDENTIFYING THE EXCESS CAPACITY AND BANDWIDTH  
9 POSSESSED OR CONTROLLED BY LOCAL AUTHORITIES WHICH MAY BE LEASED ON A  
10 NON-DISCRIMINATORY AND COMMERCIALY REASONABLE BASIS TO PUBLIC ENTITIES  
11 OR CERTIFIED TELECOMMUNICATIONS CARRIERS THAT NEED SUCH CAPACITY TO  
12 PROVIDE BROADBAND SERVICES TO UNSERVED, UNDERSERVED AND DISTRESSED  
13 AREAS;

14 (III) WITHIN ONE HUNDRED EIGHTY DAYS OF THE EFFECTIVE DATE OF THIS  
15 SECTION, IDENTIFY AND REPORT UPON ALL TELECOMMUNICATIONS SERVICES  
16 PURCHASED, LEASED OR OTHERWISE USED BY THE AUTHORITIES THAT MAY BE USED  
17 IN A TELECOMMUNICATIONS DEMAND AGGREGATION PROGRAM ADMINISTERED BY THE  
18 STATE BROADBAND DEVELOPMENT AND DEPLOYMENT COUNCIL.

19 (B) ALL LOCAL AUTHORITIES SHALL, FROM THE EFFECTIVE DATE OF THIS  
20 SECTION, INSTALL TELECOMMUNICATIONS-GRADE CONDUIT AND ANTENNA ATTACHMENT  
21 POINTS IN AND/OR ON ALL INFRASTRUCTURE PROJECTS NEWLY CONSTRUCTED OR  
22 UPGRADED BY SUCH AGENCIES, FOR LEASE ON A NON-DISCRIMINATORY AND COMMER-  
23 CIALY REASONABLE BASIS TO PUBLIC ENTITIES OR CERTIFIED TELECOMMUNI-  
24 CATIONS CARRIERS THAT NEED SUCH CAPACITY TO PROVIDE BROADBAND SERVICES  
25 TO UNSERVED, UNDERSERVED AND DISTRESSED AREAS. LOCAL AUTHORITIES MAY,  
26 HOWEVER, EXEMPT FROM THIS REQUIREMENT INFRASTRUCTURE WHERE SUCH INSTAL-

30 (C) ALL LOCAL AUTHORITY REPORTS PROVIDED FOR IN THIS SECTION SHALL BE  
31 DELIVERED INITIALLY, AND THEREAFTER ON AN ANNUAL BASIS UNLESS OTHERWISE  
32 SPECIFIED, TO THE GOVERNOR, TEMPORARY PRESIDENT OF THE SENATE, SPEAKER  
33 OF THE ASSEMBLY, MINORITY LEADERS OF THE SENATE AND ASSEMBLY, CHAIR AND  
34 RANKING MINORITY MEMBER OF THE SENATE ENERGY AND TELECOMMUNICATIONS  
35 COMMITTEE, AND THE CHAIR AND RANKING MINORITY MEMBER OF THE ASSEMBLY  
36 CORPORATIONS, AUTHORITIES AND COMMISSIONS COMMITTEE, CHAIRPERSON OF THE  
37 PUBLIC SERVICE COMMISSION, COMMISSIONER OF THE EMPIRE STATE DEVELOPMENT

40 3. STATE AND LOCAL AUTHORITIES. TO THE EXTENT PRACTICABLE, AND  
41 CONSISTENT WITH APPLICABLE DIRECTIVES OR GUIDELINES BY THE EMERGENCY  
42 PREPAREDNESS COMMISSION, STATE EMERGENCY MANAGEMENT OFFICE AND STATE  
43 OFFICE OF HOMELAND SECURITY, EACH STATE AND LOCAL AUTHORITY SHALL MAKE  
44 ACCESSIBLE TO THE PUBLIC VIA ITS OFFICIAL INTERNET WEB SITE DOCUMENTA-  
45 TION PERTAINING TO THE TELECOMMUNICATIONS INFRASTRUCTURE RESOURCES OWNED  
46 BY, LEASED BY, USED BY OR OTHERWISE CONTROLLED BY SUCH STATE AND LOCAL  
47 AUTHORITIES.

48 S 12. The public service law is amended by adding a new section 90-a

50 S 90-A. STATEMENT OF POLICY. 1. THE STATE OF NEW YORK'S LONG-STANDING

1 TOOLS AND SERVICES HAVE, OVER TIME, AND INCREASINGLY NOW, SHAPED CITI-  
2 ZENS' ABILITY TO PARTICIPATE IN CIVIC AFFAIRS, TO ACQUIRE LEARNING  
3 SKILLS NEEDED FOR THEIR ECONOMIC SUCCESS AND THAT OF THE STATE, AND TO  
4 ENJOY THE RICH AND UNPARALLELED SOCIAL AND CULTURAL LIFE THAT IS A VITAL  
5 PART OF NEW YORK STATE'S ECONOMY. THE STATE'S GOALS FOR UNIVERSAL  
6 SERVICE ARE TO FURTHER AND PROTECT THE PUBLIC INTEREST BY PROMOTING THE  
7 AVAILABILITY OF QUALITY SERVICES AT JUST, REASONABLE, AND AFFORDABLE  
8 RATES; TO ADVANCE THE AVAILABILITY OF SUCH SERVICES TO ALL CONSUMERS,  
9 INCLUDING THOSE IN LOW INCOME, RURAL, INSULAR, AND HIGH COST AREAS AT  
10 RATES THAT ARE REASONABLY COMPARABLE TO THOSE CHARGED IN HIGH-DENSITY  
11 URBAN AREAS; AND TO INCREASE ACCESS TO, AND THE UBIQUITY OF, ADVANCED  
12 TELECOMMUNICATIONS SERVICES AVAILABLE TO THE PUBLIC IN AN EQUITABLE AND  
13 NONDISCRIMINATORY MANNER. ALL TELEPHONE CORPORATIONS AND PROVIDERS AND  
14 RESELLERS OF TELECOMMUNICATIONS SERVICES SHOULD CONTRIBUTE TO CORE  
15 PUBLIC SAFETY AND PUBLIC INTEREST GOALS TO THE EXTENT ALLOWABLE BY LAW.  
16 AT A MINIMUM, THESE INCLUDE EQUIVALENT UNIVERSAL SERVICE SUPPORT,  
17 PROVISION AND SUPPORT FOR E911, DISABILITY ACCESS, CONSUMER PROTECTIONS,  
18 AND EQUITABLE TAXATION. EFFECTIVE PUBLIC PROGRAMS MUST BE MADE AVAILABLE  
19 WHERE COMPETITIVE FORCES DO NOT RESULT IN THE DEPLOYMENT, MAINTENANCE,  
20 OR RECONSTRUCTION OF AFFORDABLE, HIGH-QUALITY, AND RELIABLE ADVANCE  
21 TELECOMMUNICATIONS CAPABILITY ACROSS ALL GEOGRAPHIC REGIONS AND DEMO-  
22 GRAPHIC SEGMENTS OF THE STATE. TELECOMMUNICATIONS NETWORKS MUST BE  
23 INTER-OPERABLE, BASED ON OPEN STANDARDS, RELIABLE, SURVIVABLE, DIVERSELY  
24 PATHED, AS WIDELY INTERCONNECTED AS IS REASONABLE, ACCESSIBLE FOR ALL  
25 USERS AS PROVIDED FOR BY LAW, INCLUDING BUT NOT LIMITED TO THE AMERICANS  
26 WITH DISABILITIES ACT, AND ALL APPLICABLE FEDERAL, STATE, AND LOCAL  
27 REGULATIONS, AND MUST MEET BASIC REQUIREMENTS CONCERNING PUBLIC SAFETY,  
28 CONSUMER PROTECTION, AND RELEVANT SOCIAL AND MORAL OBLIGATIONS.

29 2. FOR THE PURPOSES OF THIS SECTION:

30 (A) THE TERM "UNIVERSAL SERVICE" MEANS THAT CERTAIN BASIC TELEPHONE  
31 FACILITIES, SERVICES, AND INSTRUMENTALITIES, KNOWN AS "ESSENTIAL  
32 SERVICES", SHALL BE ACCESSIBLE TO ANY PERSON, CORPORATION, OR LOCALITY  
33 IN NEW YORK STATE AT COSTS REASONABLY COMPARABLE TO RATES CHARGED IN  
34 URBAN AREAS AND LOW-COST AREAS, SO THAT THERE SHALL NOT BE ANY UNDUE OR  
35 UNREASONABLE PREFERENCE OR ADVANTAGE TO ANY PERSON, CORPORATION, OR  
36 LOCALITY.

37 (B) THE TERM "ESSENTIAL SERVICES" MEANS THE PROVISION BY TELEPHONE  
38 CORPORATIONS OF VOICE GRADE ACCESS TO AND ACROSS THE PUBLIC SWITCHED  
39 TELEPHONE NETWORK, WITH THE ABILITY TO PLACE AND RECEIVE CALLS;  
40 TOUCH-TONE SERVICE; SINGLE-PARTY SERVICE; ACCESS TO EMERGENCY SERVICES,  
41 INCLUDING 911 AND E911 (WHICH IDENTIFIES A CALLER'S LOCATION); ACCESS TO  
42 OPERATOR SERVICES; ACCESS TO INTER-EXCHANGE SERVICES; ACCESS TO DIRECTO-  
43 RY ASSISTANCE; ACCESS TO "LIFELINE" SERVICES, OR OTHER SERVICES EQUIV-  
44 ALENT IN PRICE AND QUALITY FOR QUALIFYING LOW-INCOME CONSUMERS; AND  
45 ACCESS TO ALL OF SUCH OTHER SERVICES AS MAY BE MANDATED BY FEDERAL,  
46 STATE, AND LOCAL LAW.

47 3. WITHIN THIRTY DAYS OF THE DATE ON WHICH THE COMMISSION HAD ACTUAL  
48 KNOWLEDGE, OR SHOULD REASONABLY HAVE KNOWN OR BEEN INFORMED, OF THE  
49 OCCURRENCE, OR APPEARANCE OF THE PROXIMATE OCCURRENCE, OF A PURCHASE,  
50 ACQUISITION, TAKING, OR OTHER TRANSFER OF CONTROL OR OWNERSHIP OF THE  
51 CAPITAL STOCK OF A TELEGRAPH OR TELEPHONE CORPORATION ORGANIZED OR  
52 EXISTING UNDER THE LAWS OF THIS STATE WITHIN THE CONTEMPLATION OF  
53 SECTION ONE HUNDRED OF THIS ARTICLE OR PARAGRAPH (B) OF THIS SUBDIVI-  
54 SION, THE COMMISSION SHALL COMPILE AND PUBLISH A REPORT ON THE EFFECT,  
55 IF ANY, OF SUCH TRANSFER OF CONTROL UPON UNIVERSAL SERVICE IN THE STATE.  
56 SUCH REPORT SHALL BE KNOWN AS THE "UNIVERSAL SERVICE IMPACT ANALYSIS",

1 AND SHALL BE ISSUED BEFORE THE COMMISSION MAY VOTE UPON THE APPROVAL OF  
2 SUCH OCCURRENCE. IF, ON THE EFFECTIVE DATE OF THIS SUBDIVISION, THERE IS  
3 A PROCEEDING BEFORE THE COMMISSION WITHIN THE CONTEMPLATION OF SUBDIVI-  
4 SION ONE OF THIS SECTION, THEN THE COMMISSION SHALL HAVE THIRTY DAYS  
5 FROM SUCH EFFECTIVE DATE TO ISSUE ITS UNIVERSAL SERVICE IMPACT ANALYSIS  
6 REPORT. SUCH UNIVERSAL SERVICE IMPACT ANALYSIS REPORT SHALL INCLUDE, BUT  
7 NOT BE LIMITED TO:

8 (A) AN ANALYSIS OF THE EFFECTS UPON PRICING OF TELEPHONE SERVICES IN  
9 HIGH-COST AND RURAL AND LOW-INCOME AREAS AFFECTED BY SUCH TRANSFER OF  
10 CONTROL;

11 (B) AN ANALYSIS OF THE ACTUAL OR POTENTIAL EFFECTS OF SUCH TRANSFER OF  
12 CONTROL UPON NETWORK RELIABILITY AND SERVICE QUALITY IN THE AREA  
13 AFFECTED BY SUCH TRANSFER OF CONTROL;

14 (C) AN ANALYSIS OF THE ACTUAL OR POTENTIAL EFFECTS UPON NEW SERVICE  
15 PROVISION IN RURAL AND HIGH-COST AND LOW-INCOME AREAS WITHIN THE AREA  
16 AFFECTED BY SUCH TRANSFER OF CONTROL.

17 FOR THE PURPOSES OF TRIGGERING SUCH REPORTING REQUIREMENT BY THE  
18 COMMISSION, THERE SHALL BE A REBUTTABLE PRESUMPTION OF A TRANSFER OF  
19 CONTROL OR OWNERSHIP UPON THE ACQUISITION OR ACCUMULATION BY ANY PERSON  
20 OR GROUP OF PERSONS OF TEN PERCENT OR MORE OF THE SHARES OF, OR OF  
21 COMPARABLE OWNERSHIP INTEREST IN, A TELEGRAPH OR TELEPHONE CORPORATION.  
22 SUCH TRANSFER OF CONTROL OR ACQUISITION OR ACCUMULATION OF OWNERSHIP  
23 INTERESTS SHALL ALSO BE DEEMED TO OCCUR UPON THE SALE, ASSIGNMENT,  
24 TRANSFER, DIVESTITURE OF A PORTION OF A BUSINESS ENTITY, LEASE OR OTHER  
25 DISPOSAL, EITHER IN WHOLE OR PART, EITHER BY INVOLUNTARY SALE OR BY  
26 VOLUNTARY SALE, MERGER, OR CONSOLIDATION, OR BANKRUPTCY, OF ANY TITLE TO  
27 SUCH TELEGRAPH OR TELEPHONE CORPORATION, EITHER LEGAL OR EQUITABLE, OR  
28 OF THE LINES OR OTHER NETWORK ELEMENTS OF SUCH TELEGRAPH OR TELEPHONE  
29 CORPORATION WITHIN THREE OR MORE LOCAL ACCESS AND TRANSPORT AREAS  
30 (LATAS) OR COUNTIES.

31 4. UPON THE COMPLETION OF THE REPORT UNDER SUBDIVISION THREE OF THIS  
32 SECTION THE COMMISSION SHALL HAVE POWER AND THE DUTY TO ESTABLISH BY  
33 RULE OR REGULATION, WITHIN NINETY DAYS OF THE EFFECTIVE DATE OF THIS  
34 SECTION, SUCH CHARGES, EXCHANGES OF FUNDS, FEES, METHODOLOGIES, AND  
35 MODALITIES AS ARE NECESSARY AND CONVENIENT TO PROMOTE AND ENSURE THE  
36 STATEWIDE UNIVERSAL AVAILABILITY OF HIGH-QUALITY ESSENTIAL SERVICES AT  
37 JUST, REASONABLE, AND AFFORDABLE RATES; TO ADVANCE THE AVAILABILITY OF  
38 SUCH SERVICES TO ALL CONSUMERS, INCLUDING THOSE IN LOW INCOME, RURAL,  
39 INSULAR, AND HIGH COST AREAS AT RATES THAT ARE REASONABLY COMPARABLE TO  
40 THOSE CHARGED IN LOW COST AND URBAN AREAS; AND TO INCREASE ACCESS TO,  
41 AND THE UBIQUITY OF, ADVANCED TELECOMMUNICATIONS SERVICES AVAILABLE TO  
42 THE PUBLIC IN AN EQUITABLE AND NONDISCRIMINATORY MANNER. THE COMMISSION  
43 SHALL HAVE POWER AND THE DUTY TO PROMULGATE SUCH RULES OR REGULATIONS AS  
44 ARE NECESSARY AND CONVENIENT TO EFFECTUATE THE STATE POLICIES SET FORTH  
45 IN THIS SECTION.

46 S 13. The public service law is amended by adding a new section 90-b

48 S 90-B. REPORTS, HEARINGS AND INVESTIGATIONS STUDYING MATTERS IN THE  
49 PUBLIC INTEREST. THE LEGISLATURE FINDS THAT UNIVERSAL ACCESS TO AFFORDA-

5 CHAIR AND RANKING MINORITY MEMBER OF THE ASSEMBLY CORPORATIONS, AUTHORI-  
6 TIES AND COMMISSIONS COMMITTEE. THE REPORT SHALL EVALUATE THE IMPLI-  
7 CATIONS OF A SALE OF A PORTION OF THE UPSTATE TELEPHONE NETWORK FOR THE  
8 POLICY OF UNIVERSAL ACCESS TO AFFORDABLE SERVICE. THE REPORT SHALL  
9 FURTHER EVALUATE THE STANDARDS BY WHICH THE DEPARTMENT WILL ANALYZE A  
10 PROPOSED SALE.

21 THE FOREFRONT OF NUMEROUS VITAL INDUSTRIES, BUT THAT TO CONTINUE TO BE A  
22 WORLD-CLASS LEADER, NEW YORK MUST ADOPT POLICIES AND PRACTICES THAT  
23 PROMOTE THE ROLL-OUT AND FURTHER DEVELOPMENT OF BROADBAND. FINALLY, THE  
24 LEGISLATURE FINDS THAT RURAL AREAS OF NEW YORK LACK THE MULTIPLE TELE-  
25 COMMUNICATIONS CONNECTIONS NECESSARY TO LINK TO OUTSIDE RESOURCES DURING  
26 TIMES OF EMERGENCY, THAT BROADBAND NETWORKS ARE NECESSARY TO CREATE OR  
27 FACILITATE SUSTAINABLE TELEMEDICINE NETWORKS THAT CONNECT RURAL HEALTH  
28 CLINICS TO URBAN MEDICAL CENTERS, AND THAT INCREASED GOVERNMENT USE OF  
29 BROADBAND NETWORKS AND ADVANCED COMMUNICATIONS SERVICES WILL ENHANCE  
30 GOVERNMENT OPERATIONS THROUGH TELEMEDICINE FOR HEALTHCARE, DISTANCE  
31 LEARNING FOR EDUCATION, REDUNDANT AND DIVERSELY-PATHED COMMUNICATIONS  
32 NETWORKS FOR PUBLIC SAFETY COMMUNICATIONS AND TO GENERALLY PROTECT THE

39 MINORITY MEMBER OF THE ASSEMBLY CORPORATIONS, AUTHORITIES AND COMMIS-  
40 SIONS COMMITTEE. THE REPORT SHALL STUDY IN DETAIL THE ACTUAL RETAIL  
41 AVAILABILITY OF WIRELINE, WIRELESS CELLULAR AND FIXED-WIRELESS BROADBAND  
42 COMMUNICATIONS MODALITIES ACROSS THE STATE OF NEW YORK, AND SHALL ORGAN-  
43 IZE THE DATA OF SUCH AVAILABILITY BY CENSUS TRACT.

44 3. THE DEPARTMENT, ACTING TOGETHER WITH THE EMPIRE STATE DEVELOPMENT  
45 CORPORATION, SHALL PREPARE AND SUBMIT, WITHIN NINETY DAYS OF THE EFFEC-  
46 TIVE DATE OF THIS SECTION, A REPORT TO THE GOVERNOR, TEMPORARY PRESIDENT  
47 OF THE SENATE, SPEAKER OF THE ASSEMBLY, MINORITY LEADERS OF THE SENATE  
48 AND ASSEMBLY, CHAIR AND RANKING MINORITY MEMBER OF THE SENATE ENERGY AND  
49 TELECOMMUNICATIONS COMMITTEE, AND THE CHAIR AND RANKING MINORITY MEMBER  
50 OF THE ASSEMBLY CORPORATIONS, AUTHORITIES AND COMMISSIONS COMMITTEE. THE  
51 REPORT SHALL LIST ALL FEDERAL, STATE, LOCAL, FOUNDATION, PRIVATE SECTOR  
52 AND OTHER FUNDS, GRANTS, LOANS AND OTHER FUNDING MECHANISMS THAT CAN BE  
53 APPLIED FOR AND USED BY THE BROADBAND DEVELOPMENT AUTHORITY, BY THE  
54 STATE, BY MUNICIPAL CORPORATIONS, BY NONPROFIT CORPORATIONS AND BY  
55 PRIVATE SECTOR BUSINESSES TO FUND BROADBAND DEPLOYMENT IN NEW YORK.

1 4. THE DEPARTMENT, ACTING TOGETHER WITH THE OFFICE FOR TECHNOLOGY AND  
2 THE OFFICE OF CYBER SECURITY AND CRITICAL INFRASTRUCTURE COORDINATION  
3 ("CSCIC") SHALL PREPARE AND SUBMIT, WITHIN NINETY DAYS OF THE EFFECTIVE  
4 DATE OF THIS SECTION, A REPORT TO THE GOVERNOR, TEMPORARY PRESIDENT OF  
5 THE SENATE, SPEAKER OF THE ASSEMBLY, MINORITY LEADERS OF THE SENATE AND  
6 ASSEMBLY, CHAIR AND RANKING MINORITY MEMBER OF THE SENATE ENERGY AND  
7 TELECOMMUNICATIONS COMMITTEE, AND THE CHAIR AND RANKING MINORITY MEMBER  
8 OF THE ASSEMBLY CORPORATIONS, AUTHORITIES AND COMMISSIONS COMMITTEE. THE  
9 REPORT SHALL DETERMINE THE LOCATION OF ALL AREAS OF THE STATE, BY CENSUS  
10 TRACT, THAT DO NOT HAVE GENERALLY AND READILY COMMERCIALY AVAILABLE  
11 RETAIL ACCESS TO BROADBAND WIRELINE FACILITIES AND/OR FIXED-WIRELESS  
12 BROADBAND FACILITIES ("UNSERVED AREAS"); THE REPORT SHALL ALSO DETERMINE  
13 ALL AREAS OF THE STATE, BY CENSUS TRACT, THAT DO NOT HAVE GENERALLY AND  
14 READILY COMMERCIALY AVAILABLE RETAIL ACCESS TO BROADBAND WIRELINE  
15 FACILITIES AND/OR FIXED-WIRELESS BROADBAND FACILITIES FROM TWO OR MORE  
16 TELECOMMUNICATIONS OR ADVANCED COMMUNICATIONS SERVICES PROVIDERS  
17 ("UNDERSERVED AREAS"); THE REPORT SHALL ALSO DETERMINE THE LOCATION OF  
18 ALL AREAS OF THE STATE, BY CENSUS TRACT, THAT QUALIFY AS "DISTRESSED  
19 AREAS" UNDER THIS CHAPTER, AND EITHER DO OR DO NOT HAVE GENERALLY AND  
20 READILY COMMERCIALY AVAILABLE RETAIL ACCESS TO BROADBAND WIRELINE  
21 FACILITIES AND/OR FIXED-WIRELESS BROADBAND FACILITIES; THE REPORT SHALL,  
22 FURTHERMORE, ASSESS AND SET FORTH WITH SPECIFICITY THE AGGREGATE UNMET  
23 DEMAND FOR BROADBAND SERVICES IN UNSERVED, UNDERSERVED AND DISTRESSED  
24 AREAS BY CENSUS TRACT AND BY BLOCK, LOT OR OTHER UNIQUELY IDENTIFIABLE  
25 ADMINISTRATIVE CHARACTERISTIC, AND SHALL ESTIMATE THE AMOUNT OF BROAD-  
26 BAND CONNECTIVITY THAT WOULD NEED TO BE BUILT OR OFFERED IN SUCH AREAS  
27 TO MEET THE UNMET DEMAND. SUCH REPORT SHALL, IN ADDITION TO BEING  
28 SUBMITTED TO THE GOVERNMENT OFFICES AND OFFICIALS SET FORTH ABOVE, BE  
29 USED TO CREATE A MAP IN STANDARD FORMAT TO BE DETERMINED BY THE NEW YORK

42 LAND SECURITY CONCERNS, AND PARTICULARLY SO IN RURAL AREAS AND ON OR  
43 NEAR NEW YORK'S COASTLINES;

44 (B) EXISTING EMERGENCY SERVICES SYSTEMS CAN ISOLATE EMERGENCY RESPONSE  
45 AGENCIES THAT NEED INTER-CONNECTIVITY IN MEETING HOMELAND SECURITY AND  
46 PUBLIC SAFETY CRISES;

47 (C) ALL 9-1-1 CALLERS IN NEW YORK, AND THE FIRST RESPONDERS WHO  
48 RECEIVE AND ACT UPON SUCH CALLS, WOULD BE BETTER ABLE TO ENHANCE THE  
49 PUBLIC SAFETY WITH FLEXIBLE E911 NETWORKS THAT COULD BE INTERCONNECTED  
50 WITH LOCAL, REGIONAL AND NATIONAL INTERNET PROTOCOL BASED NETWORKS, AND  
51 THAT COULD BE FLEXIBLY ADAPTED AND SCALED TO MEET THE CHALLENGES NEW  
52 COMMUNICATIONS TECHNOLOGY PLACE UPON E911 NETWORKS; AND

53 (D) CLEAR LINES OF AUTHORITY AND ORGANIZATION IN THE DEPLOYMENT AND

10 NEXT-GENERATION TECHNOLOGICAL SOLUTIONS, AND NATIONAL STANDARDS, AND  
11 POTENTIALLY AMELIORATIVE SYSTEMS AND PROCEDURES PROPOSED BY NATIONAL  
12 PUBLIC SAFETY EXPERT ASSOCIATIONS SUCH AS, BUT NOT LIMITED TO, THE  
13 NATIONAL EMERGENCY NUMBERING ASSOCIATION ("NENA"), THE ASSOCIATION OF  
14 PUBLIC-SAFETY COMMUNICATIONS OFFICIALS ("APCO"), AND THE NATIONAL PUBLIC  
15 SAFETY TELECOMMUNICATIONS COUNCIL.

16 3. THE DEPARTMENT, ACTING TOGETHER WITH THE STATE EMERGENCY MANAGEMENT  
17 OFFICE, THE STATE OFFICE OF FIRE PREVENTION AND CONTROL, AND THE STATE  
18 POLICE, SHALL PREPARE AND SUBMIT, WITHIN NINETY DAYS OF THE EFFECTIVE  
19 DATE OF THIS SECTION, A REPORT TO THE GOVERNOR, TEMPORARY PRESIDENT OF  
20 THE SENATE, SPEAKER OF THE ASSEMBLY, MINORITY LEADERS OF THE SENATE AND  
21 ASSEMBLY, CHAIR AND RANKING MINORITY MEMBER OF THE SENATE ENERGY AND

2 OR OTHER DIFFERING CHARGES FOR DIFFERING TIME PERIODS AND THE TIME PERI-  
3 ODS WHEN NIGHT AND WEEKEND MINUTES OR OTHER CHARGES APPLY; THE CHARGES  
4 FOR EXCESS OR ADDITIONAL MINUTES; WHETHER OR NOT, AND THE EXTENT TO  
5 WHICH, PER-MINUTE DOMESTIC OR INTERNATIONAL LONG DISTANCE CHARGES ARE  
6 INCLUDED IN OTHER RATES, AND, TO THE EXTENT NOT INCLUDED, THE APPLICABLE

16 TIME DURING WHICH SUCH SERVICE MAY BE TERMINATED WITHOUT PENALTY; A  
17 STATEMENT NOTIFYING THE CUSTOMER THAT THE SERVICE INCLUDES BASIC WIRE-  
18 LESS 911 SERVICE; THE INFORMATION WHICH IS INCLUDED IN THE EDUCATIONAL  
19 PLAN FOR INFORMING THE PUBLIC ABOUT THE ENHANCED WIRELESS 911 SERVICE IN  
20 NEW YORK STATE REQUIRED BY SUBDIVISION EIGHT OF SECTION THREE HUNDRED  
21 TWENTY-EIGHT OF THE COUNTY LAW AND WHICH IS AN EXPLANATION OF THE

23 COUNTY-BY-COUNTY IMPLEMENTATION OF THE STATEWIDE SYSTEM; WEBSITE INFOR-

35 PROCEDURES FOR DISCLOSURE AT ANY POINT OF SALE OR OF CONTACT WITH POTEN-  
36 TIAL OR EXISTING RESIDENTIAL CUSTOMERS OF MAPS DISPLAYING THE WIRELESS  
37 TELEPHONE SERVICE PROVIDER'S OUTSIDE COVERAGE WITHIN THE STATE AND WITH-

45 SERVICE FOLLOWING SERVICE ACTIVATION AND DURING WHICH PERIOD SUCH  
46 CUSTOMER MAY, AFTER PAYMENT FOR SERVICES USED, TERMINATE SUCH SERVICE  
47 WITHOUT INCURRING ANY TERMINATION FEES OR CHARGES OR ANY OTHER PENALTY  
48 OF ANY KIND AND MAY, UPON THE RETURN OF ANY HANDSET BOUGHT OR LEASED IN  
49 CONNECTION WITH SUCH SERVICE, RECEIVE A PRO RATA REFUND OF ANY AMOUNTS  
50 PAID FOR SUCH HANDSET;

51 (F) WIRELESS TELEPHONE SERVICE PROVIDERS HAVE ESTABLISHED PROCEDURES  
52 FOR THE NOTIFICATION OF RESIDENTIAL CUSTOMERS AT LEAST THIRTY DAYS IN  
53 ADVANCE OF ANY CHANGE IN RATES, CHARGES, TERMS, OR CONDITIONS OF SERVICE  
54 FOR SUCH CUSTOMERS; AND

55 (G) WIRELESS TELEPHONE SERVICE PROVIDERS HAVE ESTABLISHED PROCEDURES  
56 FOR THE TIMELY PRIOR NOTICE TO RESIDENTIAL CUSTOMERS OF THE WIRELESS

1 TELEPHONE SERVICE PROVIDER'S INTENT TO TERMINATE SUCH CUSTOMER'S SERVICE  
2 SUCH THAT, AT A MINIMUM, SUCH CUSTOMER IS FULLY ADVISED OF THE AMOUNT  
3 WHICH MUST BE PAID TO MAINTAIN SERVICE, THE PROCEDURES AVAILABLE TO MAKE  
4 SUCH PAYMENTS SO THAT THE TERMINATION MAY BE AVOIDED AND THE BOARD'S  
5 COMPLAINT HANDLING PROCEDURES.

6 3. THE COMMISSION SHALL DELIVER THE REPORT TO THE GOVERNOR, TEMPORARY  
7 PRESIDENT OF THE SENATE, SPEAKER OF THE ASSEMBLY, MINORITY LEADERS OF  
8 THE SENATE AND ASSEMBLY, CHAIR AND RANKING MINORITY MEMBER OF THE SENATE  
9 ENERGY AND TELECOMMUNICATIONS COMMITTEE, AND THE CHAIR AND RANKING  
10 MINORITY MEMBER OF THE ASSEMBLY CORPORATIONS, AUTHORITIES AND COMMIS-  
11 SIONS COMMITTEE.

12 4. THE COMMISSION SHALL, AT THE COMPLETION OF THE STUDY AND SIMULTANE-  
13 OUSLY WITH THE DELIVERY OF THE REPORT, BEGIN A RULEMAKING PROCEEDING TO  
14 IMPLEMENT SUCH RULES AS MAY BE DETERMINED DURING THE STUDY TO BE NECES-  
15 SARY AND CONVENIENT TO EFFECTUATE THE REQUIREMENTS OF SUBDIVISION ONE OF  
16 THIS SECTION.

17 S 17. The public service law is amended by adding a new section 90-f  
18 to read as follows:

19 S 90-F. LEGISLATIVE FINDINGS AND DECLARATION. 1. IT IS HEREBY FOUND  
20 AND DECLARED THAT UNIVERSAL, AFFORDABLE AND HIGH QUALITY TELECOMMUNI-  
21 CATIONS SERVICES THAT MEET THE NEEDS OF INDIVIDUALS AND BUSINESSES IN  
22 THE STATE ARE NECESSARY AND VITAL TO THE WELFARE AND DEVELOPMENT OF OUR  
23 SOCIETY. IT IS, AND HAS BEEN THE GOAL OF THE STATE TO ENSURE THE  
24 UNIVERSAL AVAILABILITY AND ACCESSIBILITY OF HIGH QUALITY, AFFORDABLE  
25 TELECOMMUNICATIONS SERVICES TO ALL RESIDENTS AND BUSINESSES IN THE STATE  
26 AND TO ENSURE THAT PROVIDERS OF TELECOMMUNICATIONS SERVICES IN THE STATE  
27 PROVIDE HIGH QUALITY CUSTOMER SERVICE AND HIGH QUALITY TECHNICAL  
28 SERVICE. ALL NEW YORK RESIDENTS SHOULD BE ABLE TO EXPECT TO RECEIVE A  
29 SIMILAR LEVEL OF HIGH QUALITY SERVICE REGARDLESS OF WHERE THEY LIVE OR  
30 WHO PROVIDES THEIR SERVICE. THE COMMISSION MUST MAKE USE OF ITS MAXIMUM  
31 AUTHORITY TO PROTECT THE PUBLIC HEALTH, SAFETY AND WELFARE BY ENSURING  
32 THAT TELEPHONE SERVICE QUALITY DOES NOT ERODE TO THE POINT THAT E-911  
33 SERVICE IS ENDANGERED BY PERSISTENT, EXTENDED, OR CHRONIC LOSS OF DIAL-  
34 TONE, OR BY THE FAILURE OF INTERMODAL CARRIERS TO PROVIDE E-911  
35 SERVICES, OR BY SUCH OTHER EROSION OF SERVICE QUALITY THAT WOULD TEND TO  
36 UNDERMINE THE ABILITY OF THE VARIOUS CITIZENS OF NEW YORK TO ENGAGE IN  
37 PROTECTED SPEECH OVER THE TELEPHONE NETWORKS AND LINES AND FACILITIES  
38 AND EQUIPMENT UNDER THE JURISDICTION OF THE COMMISSION.

39 2. THE COMMISSION SHALL COMMENCE A STUDY TO SURVEY SERVICE QUALITY  
40 PRACTICES AND STANDARDS OF PROVIDERS OF TELECOMMUNICATIONS SERVICES THAT  
41 WILL LEAD TO LEGISLATIVE AND REGULATORY RECOMMENDATIONS. FOR THE  
42 PURPOSES OF THIS SECTION, "TELECOMMUNICATIONS SERVICE PROVIDER" OR  
43 "PROVIDER OF TELECOMMUNICATIONS SERVICES" SHALL MEAN A TELEPHONE CORPO-  
44 RATION, OR OTHER PROVIDER OF TELEPHONE SERVICES, CERTIFIED IN THE STATE  
45 WITH THE AUTHORITY TO PROVIDE INTRASTATE TOLL AND LOCAL EXCHANGE SERVICE  
46 USING EITHER ITS OWN OR LEASED FACILITIES. THE COMMISSION SHALL ALSO, AS  
47 PART OF SUCH STUDY, DETERMINE WHAT RULES AND REGULATIONS SHALL BE NECES-  
48 SARY:

49 (A) TO ENHANCE CONSUMER PROTECTIONS CURRENTLY OFFERED TO WIRELINE  
50 TELEPHONE SERVICES CONSUMERS;

51 (B) TO ESTABLISH AND SAFEGUARD WIRELINE TELEPHONE SERVICE QUALITY SO  
52 THAT IT IS REASONABLY COMPARABLE TO THE WIRELINE SERVICE QUALITY NECES-  
53 SARY TO SAFEGUARD CITIZEN ACCESS TO E911; AND

54 (C) TO PROTECT THE PUBLIC INTEREST, PUBLIC SAFETY AND HEALTH AND  
55 WELFARE.

1 3. THE COMMISSION SHALL SPECIFICALLY STUDY SERVICE AND RELIABILITY  
2 ISSUES INCLUDING, BUT NOT LIMITED TO, AREAS OF THE STATE THAT EXPERIENCE  
3 CHRONIC TELECOMMUNICATIONS OUTAGES, CUSTOMER SERVICE PROVIDERS OF TELE-  
4 COMMUNICATION SERVICES, INSTALLATION OF TELECOMMUNICATION SERVICES  
5 ISSUES, NETWORK PERFORMANCE, DATA COLLECTION BY PROVIDERS OF TELECOMMU-  
6 NICATIONS SERVICES, THE PREVIOUS EFFECT OF PERFORMANCE-BASED INCENTIVE  
7 PLANS UPON SERVICE QUALITY PROVIDED BY WIRELINE PROVIDERS, WHETHER AND  
8 HOW THE COMMISSION'S PRE-TWO THOUSAND ONE SERVICE QUALITY AND CONSUMER  
9 PROTECTION RULES AND REGULATIONS CAN BE EXPANDED TO BE EQUALLY APPLICA-  
10 BLE TO ALL TELECOMMUNICATIONS PROVIDERS THAT PROVIDE E911 AND IN ANY  
11 MARKETING MATERIALS PRESENT THEIR COMPANY OR PRODUCT AS A REPLACEMENT  
12 FOR PRIMARY LINE TELEPHONE SERVICE USED BY CONSUMERS IN NEW YORK, AND  
13 ISSUES CONCERNING REPORTING UPON SERVICE QUALITY AND OTHER CONSUMER  
14 PROTECTION RELATED ISSUES, PROVIDED HOWEVER THAT SUCH REPORTING REQUIRE-  
15 MENTS SHALL BE EXAMINED BY THE COMMISSION FOR METHODS THAT MIGHT  
16 DECREASE THE COST OF COMPLIANCE BY SUCH TELECOMMUNICATIONS PROVIDERS.

17 4. THE COMMISSION SHALL ISSUE A REPORT OF ITS FINDINGS INCLUDING  
18 LEGISLATIVE AND REGULATORY RECOMMENDATIONS TO ENHANCE RELIABILITY OF  
19 PROVIDERS OF TELEPHONE SERVICE TO THE GOVERNOR, TEMPORARY PRESIDENT OF  
20 THE SENATE, SPEAKER OF THE ASSEMBLY, CHAIR OF THE SENATE COMMITTEE ON  
21 ENERGY AND TELECOMMUNICATIONS AND CHAIR OF THE ASSEMBLY COMMITTEE ON  
22 CORPORATIONS, AUTHORITIES AND COMMISSIONS WITHIN ONE HUNDRED EIGHTY  
23 DAYS.

24 5. THE COMMISSION SHALL, AT THE COMPLETION OF THE STUDY AND SIMULTANE-  
25 OUSLY WITH THE DELIVERY OF THE REPORT, BEGIN A RULEMAKING PROCEEDING TO  
26 IMPLEMENT SUCH RULES AS MAY BE DETERMINED DURING THE STUDY TO BE NECES-  
27 SARY AND CONVENIENT TO EFFECTUATE THE REQUIREMENTS OF SUBDIVISION TWO OF  
28 THIS SECTION.

29 S 18. Applicability of other laws. The provisions of section seven of  
30 this act are intended to be consistent with the Federal Cable Act, 47  
31 U.S.C. S521, et. seq., and nothing in this act shall be interpreted to  
32 prevent a voice provider, cable operator or municipality from seeking  
33 clarification of its rights and obligations under federal law. In the  
34 event that any cable operator obtains relief through judicial, adminis-  
35 trative, or executive action from any obligation imposed under this act,  
36 or from any obligation in a franchise agreement that gives rise to an  
37 obligation of another cable operator under this act, all other cable  
38 operators shall be deemed to be relieved of their obligations under this  
39 act within the same geographic area and to the same extent.

40 S 19. Severability. If any provision of this act or its application to  
41 any person or circumstance is held invalid, this invalidity does not  
42 affect other provisions or applications of this act that can be given  
43 effect without the invalid provision or application, and to this end the  
44 provisions of this act are declared to be severable.

45 S 20. This act shall take effect immediately.
