AN ACT to amend chapter 326 of the laws of 2011, amending the environmental conservation law, relating to allowing the use of rifles for hunting in Wyoming county, in relation to making such provisions permanent; and to amend the environmental conservation law, in relation to making the use of rifles for hunting in Wyoming county permanent

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 3 of chapter 326 of the laws of 2011, amending the
2 environmental conservation law, relating to allowing the use of rifles
3 for hunting in Wyoming county, is amended to read as follows:
4 S 3. This act shall take effect immediately, provided that:
5 a. the amendments to item (i) of paragraph a of subdivision 2 of
6 section 11-0907 of the environmental conservation law made by section
7 one of this act shall be subject to the expiration and reversion of such
8 paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as
9 amended[, when upon such date the provisions of section two of this act
10 shall take effect;
11 b. the amendments to item (i) of paragraph a of subdivision 2 of
12 section 11-0907 of the environmental conservation law made by section
13 two of this act shall be subject to the expiration and reversion of such
14 paragraph pursuant to section 17 of chapter 483 of the laws of 2010, as
15 amended; and
