AN ACT to amend chapter 751 of the laws of 2005, amending the insurance law and the vehicle and traffic law relating to establishing the accident prevention course internet technology pilot program, in relation to repealing such program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The commissioner of motor vehicles shall not approve any defensive driving program or defensive driving course instructed only over the internet or other such technological means, and shall require that a certified instructor be physically present for the instruction of such programs. All fees received, but not yet expended, by the department of motor vehicles pursuant to the provisions of article 12-C of the vehicle and traffic law and all other moneys appropriated, credited or transferred thereto from any other fund or source pursuant to law for purposes of administering or implementing the provisions of such article 12-C shall be returned to the possession of the state comptroller and the commissioner of taxation and finance within sixty days from the date on which this act shall take effect.
