AN ACT to amend the education law, in relation to requiring the state to pay down the gap elimination adjustment

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1.     Subdivision 17 of section 3602 of the education law is  
2     amended by adding three new paragraphs (g), (h) and (i) to read as  
3     follows:  
4     (G)   NOTWITHSTANDING ANY OTHER LAW TO THE CONTRARY THE GAP ELIMINATION  
5     ADJUSTMENT FOR THE TWO THOUSAND FOURTEEN--TWO THOUSAND FIFTEEN SCHOOL  
6     YEAR SHALL EQUAL SIXTY-SIX PERCENT (0.66) OF THE GAP ELIMINATION ADJUST-  
7     MENT FOR SUCH DISTRICT FOR THE TWO THOUSAND THIRTEEN--TWO THOUSAND FOUR-  
8     TEEN SCHOOL YEAR.  
9     (H)   NOTWITHSTANDING ANY OTHER LAW TO THE CONTRARY THE GAP ELIMINATION  
10    ADJUSTMENT FOR THE TWO THOUSAND FIFTEEN--TWO THOUSAND SIXTEEN SCHOOL  
11    YEAR SHALL EQUAL FIFTY PERCENT (0.50) OF THE GAP ELIMINATION ADJUSTMENT  
12    FOR SUCH DISTRICT FOR THE TWO THOUSAND FOURTEEN--TWO THOUSAND FIFTEEN  
13    SCHOOL YEAR.  
14    (I)   NOTWITHSTANDING ANY OTHER LAW TO THE CONTRARY THE GAP ELIMINATION  
15    ADJUSTMENT FOR THE TWO THOUSAND SIXTEEN--TWO THOUSAND SEVENTEEN SCHOOL  
16    YEAR SHALL EQUAL ZERO.  
17    S 2. This act shall take effect July 1, 2014.
