AN ACT to amend the education law, in relation to establishing the school district financial accountability act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new article 78 to 2 read as follows:

ARTICLE 78

SCHOOL DISTRICT FISCAL ACCOUNTABILITY ACT

- 10 S 3817. SHORT TITLE. THIS ACT SHALL BE KNOWN AND MAY BE CITED AS THE 11 "SCHOOL DISTRICT FISCAL ACCOUNTABILITY ACT."
- 12 S 3818. LEGISLATIVE FINDINGS AND INTENT. THE LEGISLATURE HEREBY FINDS, 13 DETERMINES AND DECLARES THAT:
- 14 1. SCHOOL DISTRICT FINANCES ARE COMPLEX AND MULTI-FACETED AND REQUIRE 15 A HIGH LEVEL OF EXPERTISE IN FISCAL MANAGEMENT TO ENSURE THAT TAXPAYER 16 FUNDS ARE PROPERLY MANAGED AND ALLOCATED.
- 2. APPROPRIATELY MANAGED SCHOOL FINANCES ARE CRITICAL TO ENSURING THAT SCHOOL DISTRICTS HAVE THE RESOURCES NECESSARY TO PROVIDE A SOUND BASIC EDUCATION THAT PREPARES STUDENTS TO BE CAREER AND COLLEGE READY.

1 3. SCHOOL DISTRICT FINANCES SHOULD BE TRANSPARENT AND ACCESSIBLE TO 2 THE PUBLIC SO THEY MAY HAVE A CLEAR PICTURE OF THE FISCAL CONDITION OF 3 THE SCHOOL DISTRICT.

- S 3819. DEFINITIONS. FOR THE PURPOSE OF THIS ARTICLE:
- 5 1. "SCHOOL DISTRICT" SHALL MEAN ANY SCHOOL DISTRICT ORGANIZATION 6 DEFINED IN TITLE TWO OF THIS CHAPTER.
- 7 2. "SCHOOL BUSINESS OFFICIAL" SHALL MEAN ANY SCHOOL DISTRICT EMPLOYEE 8 WITH THE TITLE OF ASSISTANT SUPERINTENDENT FOR BUSINESS, SCHOOL BUSINESS 9 ADMINISTRATOR, SCHOOL BUSINESS OFFICIAL, OR SIMILAR TITLE THAT REPORTS 10 DIRECTLY TO THE SUPERINTENDENT, AND HOLDS THE APPROPRIATE CERTIFICATION 11 AS REQUIRED BY THE DEPARTMENT OR THE OPERATIVE CIVIL SERVICE AGENCY, AS 12 APPROPRIATE.
- 3. "LONG RANGE FINANCIAL PLAN" SHALL MEAN A PLAN THAT INCLUDES PROJEC14 TIONS FOR THE SUBSEQUENT FIVE YEARS OF THE SCHOOL DISTRICT THAT COVERS:
  15 (A) REVENUES, (B) EXPENDITURES, (C) UNASSIGNED FUND BALANCE, (D)
  16 RESTRICTED FUND BALANCE, (E) CAPITAL PROJECT PLANNING OR IMPLEMENTING
  17 AND FINANCING THE DISTRICT'S FIVE-YEAR FACILITY PLAN, AND (F) RESOURCES
  18 REQUIRED TO IMPLEMENT AN INSTRUCTIONAL PROGRAM NECESSARY TO ENSURE THAT
  19 ALL STUDENTS GRADUATE COLLEGE AND CAREER READY.
  - S 3820. LONG RANGE FINANCIAL PLAN. EVERY YEAR, COMMENCING WITH THE PROPOSED BUDGET FOR THE TWO THOUSAND FIFTEEN--TWO THOUSAND SIXTEEN SCHOOL YEAR, THE SCHOOL BUSINESS OFFICIAL OF EACH SCHOOL DISTRICT SHALL PREPARE FOR APPROVAL BY THE TRUSTEES OR BOARD OF TRUSTEES A FIVE-YEAR LONG-RANGE FINANCIAL PLAN.
- 25 S 3821. PUBLIC ACCESS TO FINANCIAL INFORMATION. NOTWITHSTANDING ANY 26 OTHER LAW TO THE CONTRARY, A SCHOOL DISTRICT MUST POST ON ITS WEBSITE, 27 THE DISTRICT'S LONG RANGE FINANCIAL PLAN, ANNUAL AUDITED FINANCIAL 28 STATEMENT, INCLUDING ANY CORRECTIVE ACTION PLAN, AND ADOPTED ANNUAL 29 BUDGET.
