AN ACT to amend the environmental conservation law, in relation to authorizing the hunting of big game in the county of Albany with rifles; and providing for the repeal of such provisions upon the expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Item (d) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as amended by section 14 of part 3 EE of chapter 55 of the laws of 2014, is amended to read as follows:

4 (d) Eastern region, Deer, first Monday Pistol, shotgun, cross-5 except ALBANY, after November 15 bow, muzzle loading 6 Columbia, Fulton, through first Tuesday firearm or

7 Orange, Rensselaer, after December 7 long bow only

8 Saratoga, Washington

S 3. This act shall take effect immediately, provided that:

- (a) the amendments to item (d) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section one of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended;
- (b) the amendments to paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section two of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended; and
- (c) nothing contained in this act shall be construed so as to extend the provisions of this act beyond October 1, 2016, when upon such date this act shall expire and the provisions contained herein shall be deemed repealed.
