AN ACT to amend the state finance law, in relation to providing additional funding to counties to cover the costs of unfunded state mandates; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. This act shall be known and may be cited as the "county
2 payment relief act".
- 3 S 2. The state finance law is amended by adding a new section 54-m to
4 read as follows:
- 5 S 54-M. COUNTY PAYMENT RELIEF. 1. THERE SHALL BE APPORTIONED AND PAID
6 TO THE SEVERAL COUNTIES OUTSIDE THE CITY OF NEW YORK, FROM MONEYS APPRO-
7 PRIATED, AN AMOUNT EQUAL TO TWENTY DOLLARS PER RESIDENT OF THE COUNTY AS
8 DETERMINED BY THE MOST RECENT UNITED STATES CENSUS FOR THE STATE FISCAL
9 YEAR TWO THOUSAND FOURTEEN. SUCH AMOUNT SHALL BE INCREASED BY TEN
10 PERCENT IN EACH SUCCEEDING FISCAL YEAR OVER THE PRIOR YEAR UNTIL TWO
11 THOUSAND TWENTY-FOUR.
- 12 2. THE COUNTY PAYMENT RELIEF SHALL BE PROVIDED IN ADDITION TO THE
13 OTHER STATE AID ALREADY PROVIDED BY THIS CHAPTER AND OTHER ALREADY
14 EXISTING AID TO COUNTIES. PAYMENTS MADE UNDER THIS SECTION SHALL NOT
15 DECREASE THE AMOUNT OF AID PROVIDED UNDER OTHER PROVISIONS OF LAW.
- 16 3. COUNTIES SHALL UTILIZE FUNDS PROVIDED UNDER THIS SECTION TO PAY FOR
17 COSTS ASSOCIATED WITH CURRENTLY UNFUNDED MANDATES IMPOSED BY THE STATE.
- 18 4. FOR PURPOSES OF THIS SECTION, AN UNFUNDED MANDATE MEANS ANY PROGRAM
19 OR SERVICE REQUIREMENT IMPOSED ON A COUNTY BY THE STATE THROUGH STATUTE,
20 REGULATION OR OTHER DIRECTIVE THAT HAS A DIRECT FINANCIAL IMPACT ON ANY
21 COUNTY IN EXCESS OF TEN THOUSAND DOLLARS PER YEAR, OR ON TWO OR MORE
22 COUNTIES IN EXCESS OF ONE HUNDRED THOUSAND DOLLARS.
- 23 S 3. This act shall take effect April 1, 2014 and shall expire and be
24 deemed repealed on and after December 31, 2024.
