- AN ACT to amend the vehicle and traffic law and the administrative code of the city of New York, in relation to speed limits

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1643 of the vehicle and traffic law, as amended by 2 chapter 412 of the laws of 2012, is amended to read as follows:

3 S 1643. Speed limits on highways in cities and villages. The legislative body of any city or village with respect to highways (which term 4 for the purposes of this section shall include private roads 5 open to 6 public motor vehicle traffic) in such city or village, other than state 7 highways maintained by the state on which the department of transporta-8 tion shall have established higher or lower speed limits than the statu-9 fifty-five miles per hour speed limit as provided in section tory 10 sixteen hundred twenty of this title, or on which the department of transportation shall have designated that such city or village shall not 11 establish any maximum speed limit as provided in section sixteen hundred 12 twenty-four of this title, subject to the limitations imposed by section 13 14 sixteen hundred eighty-four of this title may by local law, ordinance, 15 order, rule or regulation establish maximum speed limits at which vehi-16 cles may proceed within such city or village, within designated areas of 17 such city or village or on or along designated highways within such city village higher or lower than the fifty-five miles per hour maximum 18 or statutory limit. No such speed limit applicable throughout such city or 19 20 village or within designated areas of such city or village shall be 21 established at less than thirty miles per hour; except that in the city 22 Long Beach, in the county of Nassau, speed limits may be established of at not less than fifteen miles per hour on any portion of the following 23

highways in such city: Cleveland avenue, Harding avenue, Mitchell 1 avenue, Belmont avenue, Atlantic avenue, Coolidge avenue, Wilson avenue 2 3 and Taft avenue; AND EXCEPT THAT IN THE CITY OF NEW YORK THE SPEED LIMIT 4 APPLICABLE THROUGHOUT SUCH CITY MAY BE ESTABLISHED AT NOT LESS THAN TWENTY-FIVE MILES PER HOUR. No such speed limit applicable on or along designated highways within such city or village shall be established at 5 6 7 less than twenty-five miles per hour, except that school speed limits 8 be established at not less than fifteen miles per hour, for a may distance not to exceed one thousand three hundred twenty feet, on a 9 10 highway passing a school building, entrance or exit of a school abutting 11 the highway and except that within the cities of Buffalo and Rocheson ter speed limits may be established at not less than fifteen miles 12 per 13 hour for any portion of a highway within a city park, AND EXCEPT THAT 14 WITHIN THE CITY OF NEW YORK SPEED LIMITS MAY BE ESTABLISHED AT NOT LESS 15 THAN TWENTY MILES PER HOUR ON OR ALONG DESIGNATED HIGHWAYS WITHIN SUCH 16 CITY IF SUCH CITY HAS DETERMINED THAT THE IMPLEMENTATION OF TRAFFIC 17 CALMING MEASURES AS SUCH IS DEFINED IN SECTION SIXTEEN HUNDRED TERM 18 FORTY-TWO OF THIS TITLE IS NOT FEASIBLE ON SUCH HIGHWAYS.

19 S 2. Paragraph 26 of subdivision (a) of section 1642 of the vehicle 20 and traffic law, as added by chapter 499 of the laws of 1999, is amended 21 to read as follows:

22 [(a)] Establishment of maximum speed limits below twenty-five 26. 23 miles per hour at which motor vehicles may proceed on or along desig-24 nated highways within such city for the explicit purpose of implementing 25 traffic calming measures as such term is defined herein; provided, 26 however, that no SUCH speed limit shall be set below fifteen miles per hour nor shall such speed limit be established where the traffic calming 27 28 measure to be implemented consists solely of a traffic control sign. 29 Establishment of such a speed limit shall, where applicable, be in 30 compliance with the provisions of sections sixteen hundred twenty-four and sixteen hundred eighty-four of this chapter. Nothing contained here-31 32 in shall be deemed to alter or affect the establishment of school speed limits pursuant to the provisions of section sixteen hundred forty-three 33 34 of this article. For the purposes of this paragraph, "traffic calming measures "shall mean any physical engineering measure or measures 35 that reduce the negative effects of motor vehicle use, alter driver behavior 36 37 and improve conditions for non-motorized street users such as pedestri-38 ans and bicyclists.

39 [(b) Any city establishing maximum speed limits below twenty-five 40 miles per hour pursuant to clause (i) of this subparagraph shall submit a report to the governor, the temporary president of the senate and the 41 speaker of the assembly on or before March first, two thousand two on 42 43 results of using traffic calming measures and speed limits lower the 44 than twenty-five miles per hour as authorized by this paragraph. Such 45 report shall include, but not be limited to the following:

46 (i) a description of the designated highways where traffic calming 47 measures and a lower speed limit were established and

48 (ii) a description of the specific traffic calming measures used and 49 the maximum speed limit established.]

50 S 3. Subdivision a of section 19-177 of the administrative code of the 51 city of New York, as added by Local law number 6 of the city of New York 52 for the year 1996, is amended to read as follows:

53 a. The official speed limit for a vehicle in the city of New York 54 shall be [thirty] TWENTY-FIVE miles per hour except where an official 55 sign indicates that a different speed limit is in effect.

56 S 4. This act shall take effect immediately.
