AN ACT granting tier I status in the New York state teachers' retirement system to Joanne Ohnmeiss

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Notwithstanding any other provision of law, Ohnmeiss, a member of the New York state teachers' retirement system, 3 was employed on July 5, 1971 by the Lake Shore Central School District, who, for reasons not ascribable to her own negligence, did not file a membership application in such system until September 1, 1984, which gave her Tier IV status instead of Tier I status, where she would 7 have been had she been able to file a membership application when first employed by the Lake Shore Central School District, may be 9 deemed to have become a member of the New York state teachers' retiresystem on July 5, 1971 if on or before December 31, 2014 she shall 10 11 file with the head of the New York state teachers' retirement system a 12 written request to that effect. Upon granting of such retroactive membership, Joanne Ohnmeiss shall not be granted a refund of any employ-13 14 ee contribution made by her to the New York state teachers' retirement 15 system.

S Any costs incurred in implementing the provisions of this act shall be borne by the employers of members of the New York state teachers' retirement system.

S 3. This act shall take effect immediately.

FISCAL NOTE. -- Pursuant to Legislative Law, Section 50:

This bill would allow Joanne Ohnmeiss, a member of the New York State Teachers' Retirement System with Tier 4 status, to be reclassified as a Tier 1 member with all rights, benefits, and privileges which would be available to her as a Tier 1 member. Her date of membership changed based upon her employment with the Lake Shore Central School District during the 1971-72 school year. Employee contributions made pursuant to Article 15 of the Retirement and Social Security Law would not be refunded to Ms. Ohnmeiss. Ms. Ohnmeiss must file a written

request with the head of the New York State Teachers' Retirement System on or before December 31, 2014.

The cost of this benefit is equal to the increase in the present value of benefits, which is estimated to be \$136,000.
