AN ACT to amend the public authorities law and the general business law, in relation to establishing a home heating fuel oil consumer assistance program and in relation to home heating fuel oil pricing disclosure

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Section 1854 of the public authorities law is amended by adding a new subdivision 22 to read as follows:
- TO CREATE A HOME HEATING FUEL OIL CONSUMER ASSISTANCE PROGRAM TO INITIATE AND ENCOURAGE CONSUMER EDUCATION PROGRAMS FOR THE PURPOSES PROVIDING OUTREACH AND EDUCATION MATERIALS TO CONSUMERS AND PROVIDERS OF HEATING FUEL OIL, AND TO RECEIVE COMPLAINTS OF CONSUMERS, ATTEMPT HOME TO MEDIATE SUCH COMPLAINTS WHERE APPROPRIATE, AND REFER COMPLAINTS APPROPRIATE FEDERAL, STATE OR LOCAL AGENCY AUTHORIZED BY LAW OR THE OF THE ATTORNEY GENERAL FOR APPROPRIATE ACTION SUCH COMPLAINTS. THERE SHALL BE A SINGLE STATEWIDE TELEPHONE NUMBER AND DEDI-CATED WEBSITE FOR USE BY ALL PERSONS SEEKING GENERAL INFORMATION ABOUT HOME HEATING FUEL OIL.
- 13 S 2. The general business law is amended by adding a new article 36-E 14 to read as follows:

S 778-BB. HOME HEATING FUEL OIL PRICING DISCLOSURE. IT SHALL BE UNLAW-FUL FOR ANY PERSON, FIRM OR CORPORATION TO SELL OR OFFER FOR SALE ANY HOME HEATING FUEL OIL OR ENTER INTO A CONTRACT FOR HOME HEATING FUEL OIL SERVICES UNLESS SUCH SELLER PRIOR TO THE FIRST ANNUAL DELIVERY OF HOME HEATING FUEL OIL OR UPON EXECUTION OF ANY CONTRACT WHICH INCLUDES DELIVERY OF HOME HEATING FUEL OIL, PROVIDES THE CONSUMER WITH WRITTEN INFORMATION, AVAILABLE FROM THE NEW YORK STATE ENERGY AND RESEARCH DEVELOPMENT AUTHORITY, RELATING TO THE USE OF HOME HEATING FUEL OIL; THE MAIN
