CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

proposing an amendment to section 2 of article 3 of the constitution, in relation to increasing the terms of office of members of the legislature to four years

1 Section 1. Resolved (if the Assembly concur), That section 2 of arti-  
2 cle 3 of the constitution be amended to read as follows:  
3 S 2. The senate shall consist of fifty members, except as hereinafter  
4 provided. The senators [elected in the year one thousand eight hundred  
5 and ninety-five shall hold their offices for three years, and their  
6 successors] shall be [chosen] ELECTED for TERMS OF two years; PROVIDED,  
7 THAT SENATORS ELECTED IN THE YEAR TWO THOUSAND SIXTEEN AND IN SUBSEQUENT  
8 YEARS THEREAFTER SHALL HOLD THEIR OFFICES FOR FOUR YEARS; PROVIDED,  
9 FURTHER, THAT IN ALL LEGISLATIVE TERMS THAT COMMENCE IMMEDIATELY FOLLOW-  
10 ING A DECENNIAL CENSUS YEAR, THE TERM SHALL BE TWO YEARS. The assembly  
11 shall consist of one hundred and fifty members. The assembly members  
12 [elected in the year one thousand nine hundred and thirty-eight, and  
13 their successors,] shall be [chosen] ELECTED for TERMS OF two years;  
14 PROVIDED, THAT ASSEMBLY MEMBERS ELECTED IN THE YEAR TWO THOUSAND SIXTEEN  
15 AND IN SUBSEQUENT YEARS THEREAFTER SHALL HOLD THEIR OFFICES FOR FOUR  
16 YEARS; PROVIDED, FURTHER, THAT IN ALL LEGISLATIVE TERMS THAT COMMENCE  
17 IMMEDIATELY FOLLOWING A DECENNIAL CENSUS YEAR, THE TERM SHALL BE TWO  
18 YEARS.  
19 S 2. Resolved (if the Assembly concur), That the provisions of the  
20 foregoing amendments shall apply only to terms of office commencing

1 after such amendments shall have been adopted pursuant to section 1 of  
2 article 19 of the constitution.

3 S 3. Resolved (if the Assembly concur), That the foregoing amendments  
4 be referred to the first regular legislative session convening after the  
5 next succeeding general election of the members of the assembly, and, in  
6 conformity with section 1 of article 19 of the constitution, be  
7 published for three months previous to the time of such election.
