AN ACT to amend the education law, in relation to allowing for prorated refunds of the licensure and registration fee to the spouse of a deceased professional

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:
