AN ACT to amend the vehicle and traffic law, in relation to the regis-  
tration of snowmobiles used solely for the purpose of hunting, fishing  
or trapping

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. Section 2222 of the vehicle and traffic law is amended by  
2     adding a new subdivision 2-a to read as follows:  
3     2-A. THE COMMISSIONER IS AUTHORIZED TO REGISTER A SNOWMOBILE AS A  
4     NON-TRAIL SNOWMOBILE WHICH SHALL BE USED SOLELY FOR THE PURPOSE OF GAIN-  
5     ING ACCESS TO HUNTING, FISHING AND TRAPPING AREAS. SUCH REGISTRATION  
6     SHALL BE COMPRISED OF A BLAZE ORANGE BACKGROUND WITH BLACK LETTERING.  
7     THE FEE FOR THE REGISTRATION OF A SNOWMOBILE AS A NON-TRAIL SNOWMOBILE  
8     AND EACH RENEWAL THEREOF SHALL BE TWENTY-FIVE DOLLARS, FIFTEEN DOLLARS  
9     OF WHICH SHALL BE DEPOSITED INTO THE SNOWMOBILE TRAIL DEVELOPMENT AND  
10    MAINTENANCE FUND SET FORTH IN SECTION 21.07 OF THE PARKS, RECREATION AND  
11    HISTORIC PRESERVATION LAW.  
12    S 2. Section 2230 of the vehicle and traffic law is amended by adding  
13    a new subdivision 3 to read as follows:  
14    3. ANY PERSON WHO VIOLATES THE PROVISIONS OF SUBDIVISION TWO-A OF  
15    SECTION TWENTY-TWO HUNDRED TWENTY-TWO OF THIS ARTICLE SHALL BE GUILTY OF  
16    A VIOLATION PUNISHABLE BY A FINE OF FIVE HUNDRED DOLLARS FOR EACH  
17    OFFENSE, OF WHICH FOUR HUNDRED DOLLARS OF SUCH FINE SHALL BE DEPOSITED  
18    IN THE SNOWMOBILE TRAIL DEVELOPMENT AND MAINTENANCE FUND SET FORTH IN  
19    SECTION 21.07 OF THE PARKS, RECREATION AND HISTORIC PRESERVATION LAW. IN  
20    ADDITION TO SUCH FINE, ANY SECOND OR SUBSEQUENT OFFENSE WITHIN A FIVE
