AN ACT to amend the vehicle and traffic law, in relation to authorizing distinctive license plates for recipients of the Bronze or Silver star

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The vehicle and traffic law is amended by adding a new section 404-bb to read as follows:

- S 404-BB. DISTINCTIVE PLATES FOR BRONZE OR SILVER STAR RECIPIENTS. 1. ANY RECIPIENT OF A BRONZE STAR OR A SILVER STAR RESIDING IN THIS STATE OR THE SPOUSE OF ANY SUCH RECIPIENT SHALL, UPON REQUEST, BE ISSUED A LICENSE PLATE BEARING THE WORDS "BRONZE STAR RECIPIENT" OR "SILVER STAR RECIPIENT". IF A DISTINCTIVE PLATE IS ISSUED TO A BRONZE OR SILVER STAR RECIPIENT PURSUANT TO THIS SECTION, SUCH A DISTINCTIVE PLATE SHALL NOT BE ISSUED TO THE SPOUSE OF SUCH RECIPIENT. APPLICATION FOR SAID LICENSE PLATE SHALL BE FILED WITH THE COMMISSIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.
- 2. THE DISTINCTIVE PLATE AUTHORIZED IN THIS SECTION SHALL BE ISSUED UPON PROOF, SATISFACTORY TO THE COMMISSIONER, THAT THE APPLICANT OR THE SPOUSE OF THE APPLICANT IS A BRONZE OR SILVER STAR RECIPIENT.

A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED IN THE SAME MANNER AS OTHER NUMBER PLATES UPON PAYMENT OF 16 THEREGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE, 17 HOWEVER, THAT AN ADDITIONAL ONE-TIME SERVICE CHARGE OF TEN 18 19 DOLLARS SHALL BE CHARGED FOR SUCH PLATE. PROVIDED, HOWEVER, THAT ONE 20 THE EFFECTIVE DATE OF THIS SECTION, FUNDS IN THE AMOUNT OF FIVE THOUSAND DOLLARS, OR SO MUCH THEREOF AS MAY BE AVAILABLE, SHALL 21
