AN ACT to amend the penal law, in relation to creating the offense of reckless infection of a patient with a communicable disease by a health care provider

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The penal law is amended by adding a new section 240.67 to 2 read as follows:

3 S 240.67 RECKLESS INFECTION OF A PATIENT WITH A COMMUNICABLE DISEASE BY 4 A HEALTH CARE PROVIDER.

5 A PERSON IS GUILTY OF RECKLESS INFECTION OF A PATIENT WITH A COMMUNI-6 CABLE DISEASE BY A HEALTH CARE PROVIDER WHEN A HEALTH CARE PROVIDER 7 THROUGH RECKLESS CONDUCT, INCLUDING, BUT NOT LIMITED TO, THE REUSE OF A SYRINGE, NEEDLE OR OTHER SHARP, INFECTS A PATIENT WITH A COMMUNICABLE 8 9 DISEASE. FOR THE PURPOSES OF THIS SECTION, "HEALTH CARE PROVIDER" MEANS ANY PERSON WHO IS, OR IS REQUIRED TO BE, LICENSED OR REGISTERED OR HOLDS 10 11 HIMSELF OR HERSELF OUT TO BE LICENSED OR REGISTERED, OR PROVIDES SERVICES AS IF HE OR SHE WERE LICENSED OR REGISTERED IN 12 THEPROFESSION CHIROPRACTIC, DENTISTRY OR PODIATRY UNDER 13 OF MEDICINE, ANY OF THE FOLLOWING: ARTICLE ONE HUNDRED THIRTY-ONE, ONE HUNDRED THIRTY-TWO, 14 ONE 15 HUNDRED THIRTY-THREE, OR ONE HUNDRED FORTY-ONE OF THE EDUCATION LAW.

16 RECKLESS INFECTION OF A PATIENT WITH A COMMUNICABLE DISEASE BY A 17 HEALTH CARE PROVIDER IS A CLASS E FELONY.

18 S 2. This act shall take effect immediately.
