AN ACT to amend the state finance law, in relation to prohibiting the use of lottery funds for any purpose other than education

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 92-c of the state finance law, as 2 amended by chapter 913 of the laws of 1977, is amended to read as 3 follows:
