- AN ACT to amend the education law, in relation to requiring public and private colleges and universities to provide all incoming and current students with information about depression and suicide prevention and resources available to them on campus

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Legislative intent. The legislature hereby finds and 2 declares that there is a need to address the growing number of students 3 the collegiate level who are suffering from psychiatric stressors at 4 that may lead to suicide. The legislature further recognizes that such 5 psychiatric stressors also contribute to difficulties in learning and success on the collegiate level. Early detection and identification of 6 7 individuals may not only prevent suicide, but may also allow at-risk 8 such other students suffering from psychiatric stressors to get the support needed to be successful in their academic endeavors. The support 9 10 necessary to achieve these goals may often require collaboration between college officials and parents and/or guardians in such a manner as to be 11 12 consistent with the needs of each student.

13 Therefore, to achieve the above-stated goals, the legislature hereby 14 finds and declares that every college within the state shall establish a 15 suicide prevention program.

16 S 2. The education law is amended by adding a new section 6439 to read 17 as follows:

18 S 6439. THE COLLEGIATE SUICIDE PREVENTION PROGRAM. 1. THE TRUSTEES OR 19 GOVERNING BOARD OF EACH COLLEGE SHALL INFORM INCOMING STUDENTS ABOUT 20 SUICIDE PREVENTION MEASURES THROUGH PROGRAMS WHICH MAY INCLUDE WORK-

SHOPS, SEMINARS, DISCUSSION GROUPS, AND FILM PRESENTATIONS, IN ORDER 1 ΤO DISSEMINATE INFORMATION ABOUT PRESSURES AND MATTERS THAT MAY PLACE A 2 3 PERSON AT RISK OF SUICIDE, PROMOTE DISCUSSION, ENCOURAGE REPORTING OF 4 PERSONS AT RISK OF SUICIDE, AND FACILITATE PREVENTION OF SUCH INCIDENTS. SUCH INFORMATION SHALL INCLUDE, BUT NOT BE LIMITED TO: 5

A. THE MENTAL HEALTH SERVICES AVAILABLE TO STUDENTS, 6 7

B. HOW TO IDENTIFY AN AT RISK PERSON,

8 C. THE PROCEDURES IN EFFECT AT THE COLLEGE FOR DEALING WITH ATTEMPTED 9 SUICIDE,

10 D. THE AVAILABILITY OF COUNSELING AND OTHER SUPPORT SERVICES FOR 11 PERSONS AT RISK AND THOSE AFFECTED BY SUICIDE,

12 THE NATURE OF AND COMMON CIRCUMSTANCES RELATING TO SUICIDE ON Ε. 13 COLLEGE CAMPUSES, AND

F. THE METHODS THE COLLEGE EMPLOYS TO SUPPORT AT RISK STUDENTS.

15 2. PURSUANT TO THE REQUIREMENTS SET FORTH IN SUBDIVISION ONE OF THIS 16 SECTION, EACH COLLEGE SHALL FILE A REPORT ANNUALLY ON ITS COMPLIANCE OF 17 SUCH PROGRAM WITH THE COMMISSIONER.

18 3. IF THE TRUSTEES OR OTHER GOVERNING BOARD OF A COLLEGE FAILS TO FILE 19 THE RULES AND REGULATIONS WITHIN THE TIME REQUIRED BY THIS SECTION SUCH 20 COLLEGE SHALL NOT BE ELIGIBLE TO RECEIVE ANY STATE AID OR ASSISTANCE 21 UNTIL SUCH RULES AND REGULATIONS ARE DULY FILED.

4. A. THE PRESIDENT OR CHIEF ADMINISTRATIVE OFFICER OF EACH COLLEGE, 22 EXCEPT THOSE INDEPENDENT COLLEGES INELIGIBLE TO RECEIVE STATE AID UNDER 23 SECTION SIXTY-FOUR HUNDRED ONE OF THIS TITLE, WHICH MAINTAINS A CAMPUS 24 25 IS CHARTERED BY THE REGENTS OR INCORPORATED BY SPECIAL ACT OF THE AND 26 LEGISLATURE SHALL APPOINT AN ADVISORY COMMITTEE ON MENTAL HEALTH.

B. SUCH COMMITTEE SHALL CONSIST OF A MINIMUM OF SIX MEMBERS, ONE INDI-27 VIDUAL SHALL BE A PROFESSIONAL IN THE AREA OF MENTAL HEALTH, AT LEAST 28 ONE MEMBER SHALL BE AN EMPLOYEE OF THE CAMPUS BASED MEDICAL FACILITY, 29 TWO MEMBERS OF THE COMMITTEE SHALL BE APPOINTED FROM A LIST OF STUDENTS 30 THAT ARE PARTICIPANTS IN THE STUDENT GOVERNANCE ORGANIZATION ON SUCH 31 32 CAMPUS, AND AT LEAST TWO MEMBERS SHALL BE APPOINTED FROM A LIST OF 33 FACULTY MEMBERS. ALL APPOINTMENTS SHALL BE MADE BY THE PRESIDENT OR 34 CHIEF ADMINISTRATIVE OFFICER OF THE COLLEGE.

35 C. THE COMMITTEE SHALL REVIEW CURRENT CAMPUS MENTAL HEALTH POLICIES AND PROCEDURES AND MAKE RECOMMENDATIONS FOR THEIR IMPROVEMENT. IT SHALL 36 37 SPECIFICALLY REVIEW CURRENT POLICIES AND PROCEDURES (1) FOR EDUCATING 38 THE CAMPUS COMMUNITY, INCLUDING MENTAL HEALTH AND MEDICAL PERSONNEL AND 39 THOSE PERSONS WHO ADVISE OR SUPERVISE STUDENTS, ABOUT MENTAL HEALTH 40 ISSUES PURSUANT TO SUBDIVISION ONE OF THIS SECTION, (2) FOR EDUCATING THE CAMPUS COMMUNITY ABOUT MENTAL HEALTH ISSUES AND SUICIDE PREVENTION, 41 FOR REPORTING PERSONS IN CRISIS AND DEALING WITH PERSONS IN NEED, 42 (3) 43 (4) FOR REFERRING INDIVIDUALS IN CRISIS TO APPROPRIATE PROFESSIONALS, 44 (5) FOR COUNSELING INDIVIDUALS, AND (6) FOR RESPONDING TO INQUIRIES FROM 45 CONCERNED PERSONS.

D. THE COMMITTEE SHALL REPORT, IN WRITING, TO THE COLLEGE PRESIDENT OR 46 47 CHIEF ADMINISTRATIVE OFFICER ON ITS FINDINGS AND RECOMMENDATIONS AT LEAST ONCE EACH ACADEMIC YEAR, AND SUCH REPORT SHALL BE AVAILABLE UPON 48 49 REOUEST.

50 5. ANY HEALTH CARE PROFESSIONAL WHO IS EMPLOYED BY, OR AFFILIATED WITH THE COLLEGE, AND WHO THROUGH THEIR EMPLOYMENT IS IN A POSITION TO IDEN-51 TIFY A STUDENT WHO IS POTENTIALLY AT RISK FOR SUICIDE, IS HEREBY 52 REQUIRED TO REPORT SUCH BELIEF TO THE COLLEGE PRESIDENT OR CHIEF ADMIN-53 ISTRATIVE OFFICER. THE COLLEGE PRESIDENT OR CHIEF ADMINISTRATIVE OFFICER 54 55 OF THE COLLEGE MAY, AFTER CONSULTATION WITH MENTAL HEALTH PROFESSIONALS,

1 NOTIFY THE PARENTS OR GUARDIANS OF SUCH STUDENT AS TO THE CONCERN OF 2 SUCH STUDENT'S MENTAL WELL BEING.

3 S 3. This act shall take effect on the first of July next succeeding 4 the date on which it shall have become a law; provided that the commis-5 sioner of education is authorized to promulgate any and all rules and 6 regulations necessary for the timely implementation of this act on its 7 effective date on or before such date.
