AN ACT to amend the tax law, in relation to qualified transportation fringe benefits

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subsection (c) of section 612 of the tax law is amended by adding a new paragraph 39 to read as follows:

(39) FOR TAXABLE YEARS BEGINNING AFTER DECEMBER THIRTY-FIRST, TWO THOUSAND TWELVE THE AMOUNT OF QUALIFIED TRANSPORTATION FRINGE BENEFITS INCLUDED IN FEDERAL ADJUSTED GROSS INCOME, TO THE EXTENT THAT SUCH QUAL-6 IFIED TRANSPORTATION FRINGE BENEFITS WOULD HAVE BEEN EXCLUDED FROM GROSS 7 TO PARAGRAPH FIVE OF SUBSECTION (A) OF SECTION ONE PURSUANT 8 HUNDRED THIRTY-TWO OF THE INTERNAL REVENUE CODE HAD THE FLUSH PARAGRAPH TWO OF SUBSECTION (F) OF SECTION ONE HUNDRED THIRTY-TWO OF 9 THE INTERNAL REVENUE CODE THAT WAS IN EFFECT ON DECEMBER 10 THIRTY-FIRST, TWO THOUSAND ELEVEN CONTINUED IN EFFECT AFTER DECEMBER THIRTY-FIRST, TWO 11 PROVIDED, HOWEVER, THAT IF SUBPARAGRAPH (A) OF PARA-12 THOUSAND ELEVEN; GRAPH TWO OF SUBSECTION (F) OF SECTION ONE HUNDRED THIRTY-TWO OF 13 INTERNAL REVENUE CODE IS AMENDED SO THAT FOR ANY MONTH THE DOLLAR AMOUNT 14 EFFECT UNDER SUCH SUBPARAGRAPH (A) IS GREATER THAN THE DOLLAR AMOUNT 15 16 IN EFFECT UNDER SUBPARAGRAPH (B) OF PARAGRAPH TWO OF SUBSECTION 17 SECTION ONE HUNDRED THIRTY-TWO OF THE INTERNAL REVENUE CODE FOR THE SAME 18 MONTH, THE FLUSH SENTENCE OF PARAGRAPH TWO THAT WAS IN EFFECT ON DECEM-BER THIRTY-FIRST, TWO THOUSAND ELEVEN SHALL BE DEEMED TO 19 PROVIDE DOLLAR AMOUNT IN EFFECT FOR SUBPARAGRAPH (B) SHALL BE APPLIED AS IF 20 THE DOLLAR AMOUNT THEREIN WERE THE SAME AS THE DOLLAR AMOUNT 21 INEFFECT 22 SUCH MONTH UNDER SUBPARAGRAPH (A).
