AN ACT to amend the tax law, in relation to exempting veterans eighty-five years of age and older from the obligation to pay New York state income tax

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subsection (i) of section 601 of the tax law is relettered subsection (j) and a new subsection (i) is added to read as follows:

- VETERANS OVER EIGHTY-FIVE YEARS OF AGE. NOTWITHSTANDING THE PROVISIONS OF SUBSECTIONS (A), (B), (C) AND (D) OF THIS SECTION AND ANY THIS ARTICLE, FOR TAXABLE YEARS BEGINNING AFTER OTHER PROVISION OF DECEMBER THIRTY-FIRST, TWO THOUSAND FOURTEEN, THE GROSS INCOME OF A INDIVIDUAL WHO IS AT LEAST EIGHTY-FIVE YEARS OF AGE AS OF RESIDENT DECEMBER THIRTY-FIRST OF THE TAXABLE YEAR FOR WHICH THE EXEMPTION CLAIMED AND WHO QUALIFIES AS A VETERAN UNDER THE PROVISIONS OF SUBDIVI-SION THREE OF SECTION THREE HUNDRED FIFTY OF THE EXECUTIVE LAW SHALL BE EXEMPT FROM TAX UNDER THIS ARTICLE REGARDLESS OF WHETHER SUCH INCOME IS
