AN ACT to amend the economic development law and the New York state urban development corporation act, in relation to limiting the use of economic development funds to certain corporations

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The economic development law is amended by adding a new 2 section 107 to read as follows:

- 107. RESTRICTIONS ON ECONOMIC DEVELOPMENT FUNDING TO CERTAIN CORPO-RATIONS. NO ECONOMIC DEVELOPMENT LOANS, GRANTS OR OTHER FUNDS PROVIDED UNDER THE PROVISIONS OF THIS CHAPTER TO ANY PERSON, FIRM, PART-NERSHIP OR CORPORATION WHERE THE CHIEF EXECUTIVE OFFICER OF SUCH BUSI-NESS ENTITY RECEIVES A SALARY, INCLUDING ALL REMUNERATION, BENEFITS, WHICH IS MORE THAN TWENTY-FIVE TIMES THE AMOUNT OF STOCK AND THE SALARY OF THE LOWEST PAID EMPLOYEE OF SUCH BUSINESS ENTITY. SALARY OF ANY PART TIME EMPLOYEE SHALL BE DETERMINED ON A PRORATED BASIS, AND CALCULATED AS IF SUCH EMPLOYEE WAS EMPLOYED FULLCOMMISSIONER SHALL REQUEST AND EXAMINE THE PAYROLL RECORDS AND ANY OTHER ANY BUSINESS ENTITY WHICH RECEIVES OR APPLIES FOR ANY LOAN, GRANT OR ECONOMIC DEVELOPMENT FUNDING UNDER THIS CHAPTER WHICH NECESSARY TO DETERMINE THE SALARY AMOUNTS PURSUANT TO THIS SECTION.
- S 2. Section 1 of chapter 174 of the laws of 1968, constituting the New York state urban development corporation act, is amended by adding a new section 5-a to read as follows:
- S 5-A. RESTRICTIONS ON ECONOMIC DEVELOPMENT FUNDING TO CERTAIN CORPO-20 RATIONS. NO ECONOMIC DEVELOPMENT LOANS, GRANTS OR OTHER FUNDS MAY BE 21 PROVIDED UNDER THE PROVISIONS OF THIS ACT TO ANY PERSON, FIRM, PARTNER-22 SHIP OR CORPORATION WHERE THE CHIEF EXECUTIVE OFFICER OF SUCH BUSINESS 23 ENTITY RECEIVES A SALARY, INCLUDING ALL REMUNERATION, BONUSES, STOCK AND

BENEFITS, WHICH IS MORE THAN TWENTY-FIVE TIMES THE AMOUNT OF THE SALARY OF THE LOWEST PAID EMPLOYEE OF SUCH BUSINESS ENTITY. THE SALARY OF ANY PART TIME EMPLOYEE SHALL BE DETERMINED ON A PRORATED BASIS, AND CALCULATED AS IF SUCH EMPLOYEE WAS EMPLOYED FULL TIME. THE BOARD OF DIRECTORS OF THE CORPORATION SHALL REQUEST AND EXAMINE THE PAYROLL RECORDS AND ANY OTHER RECORDS OF ANY BUSINESS ENTITY WHICH RECEIVES OR APPLIES FOR ANY LOAN, GRANT OR ECONOMIC DEVELOPMENT FUNDING UNDER THIS ACT WHICH ARE NECESSARY TO DETERMINE THE SALARY AMOUNTS PURSUANT TO THIS SECTION.

9 S 3. This act shall take effect on the first of January next succeed-10 ing the date on which it shall have become a law.
