AN ACT to amend the vehicle and traffic law, in relation to increasing the minimum insurance coverage requirements for motor vehicles rented or leased in the state of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (a) of subdivision 4 of section 311 of the vehicle and traffic law, as amended by chapter 305 of the laws of 1995, is amended to read as follows: (a) Affording coverage as defined in the minimum provisions prescribed

5 in a regulation which shall be promulgated by the superintendent at least ninety days prior to effective date of this act. The superintenб 7 dent before promulgating such regulations or any amendment thereof, 8 shall consult with all insurers licensed to write automobile liability insurance in this state and shall not prescribe minimum provisions which 9 fail to reflect the provisions of automobile liability insurance poli-10 cies, other than motor vehicle liability policies as defined in section 11 12 three hundred forty-five of this chapter, issued within this state at 13 the date of such regulation or amendment thereof. Nothing contained in such regulation or in this article shall prohibit any insurer from 14 affording coverage under an owner's policy of liability insurance more 15 16 liberal than that required by said minimum provisions. Every such 17 owner's policy of liability insurance shall provide insurance subject to 18 said regulation against loss from the liability imposed by law for 19 including damages for care and loss of services, because of damages, bodily injury to or death of any person and injury to or destruction of 20 property arising out of the ownership, maintenance, use, or operation of 21 a specific motor vehicle or motor vehicles within the state of New York, 22 23 elsewhere in the United States in North America or the Dominion of or 24 Canada, subject to a limit, exclusive of interest and costs, with

respect to each such motor vehicle except a tow truck OR A MOTOR VEHICLE 1 2 WHICH IS RENTED OR LEASED FROM A PERSON, ORGANIZATION OR BUSINESS REGU-3 LARLY ENGAGED IN THE BUSINESS OF RENTING OR LEASING MOTOR VEHICLES TO 4 THE GENERAL PUBLIC, of twenty-five thousand dollars because of bodily 5 injuries to and fifty thousand dollars because of death of one person in 6 any one accident and, subject to said limit for one person, to a limit 7 fifty thousand dollars because of bodily injury to and one hundred of 8 thousand dollars because of death of two or more persons in any one accident, and to a limit of ten thousand dollars because of injury to or 9 10 destruction of property of others in any one accident provided, however, 11 that such policy need not be for a period coterminous with the registra-12 tion period of the vehicle insured. The limit, exclusive of interest and 13 with respect to a tow truck shall be a combined single limit of costs. 14 at least three hundred thousand dollars because of bodily injury or 15 death to one or more persons or because of injury or destruction of property of others in any one accident, and to a limit of twenty-five 16 17 thousand dollars because of damage to a vehicle in the care, custody and 18 control of the insured. THE LIMIT, EXCLUSIVE OF INTEREST AND COSTS, 19 WITH RESPECT TO A MOTOR VEHICLE WHICH IS RENTED OR LEASED FROM A PERSON, ORGANIZATION OR BUSINESS REGULARLY ENGAGED IN THE BUSINESS OF RENTING OR 20 LEASING MOTOR VEHICLES TO THE GENERAL PUBLIC, SHALL BE A COMBINED SINGLE 21 22 LIMIT OF AT LEAST ONE MILLION DOLLARS BECAUSE OF BODILY INJURY OR DEATH 23 ONE OR MORE PERSONS OR BECAUSE OF INJURY OR DESTRUCTION OF PROPERTY ТΟ 24 OF OTHERS IN ANY ONE ACCIDENT, AND TO A LIMIT OF TWENTY-FIVE THOUSAND 25 DOLLARS BECAUSE OF DAMAGE TO A VEHICLE IN THE CARE, CUSTODY AND CONTROL 26 OF THE INSURED. Any insurer authorized to issue an owner's policy of liability insurance as provided for in this article may, pending the 27 28 issue of such a policy, make an agreement, to be known as a binder, or 29 in lieu of such a policy, issue a renewal endorsement or evidence may, of renewal of an existing policy; each of which shall be construed to 30 provide indemnity or protection in like manner and to the same extent as 31 32 such a policy. The provisions of this article shall apply to such bind-33 ers, renewal endorsements or evidences of renewal. Every such policy 34 issued insuring private passenger vehicles and every renewal policy, 35 renewal endorsement, or other evidence of renewal issued shall have 36 attached thereto a rating information form which clearly specifies and 37 defines the rating classification assigned thereto, including any appli-38 cable merit rating plan; and

39 S 2. Section 312 of the vehicle and traffic law is amended by adding a 40 new subdivision 6 to read as follows:

6. (A) NO MOTOR VEHICLE SHALL BE LEASED OR RENTED IN THIS STATE UNLESS 41 UPON THE REGISTRATION OF THE LEASED OR RENTED MOTOR VEHICLE, THE 42 APPLI-43 CATION FOR SUCH REGISTRATION IS ACCOMPANIED BY PROOF OF FINANCIAL SECU-44 RITY REQUIRED BY SECTION THREE HUNDRED ELEVEN OF THIS ARTICLE WHICH 45 EVIDENCED BY PROOF OF INSURANCE OR EVIDENCE OF A FINANCIAL SHALL BE SECURITY BOND, A FINANCIAL SECURITY DEPOSIT OR QUALIFICATION AS A SELF-46 47 INSURER UNDER SECTION THREE HUNDRED SIXTEEN OF THIS ARTICLE; PROVIDED, 48 THAT IF DIRECTED BY REGULATION OF THECOMMISSIONER, UPON RENEWAL OF 49 REGISTRATION AN APPLICATION ACCOMPANIED BY A CERTIFICATE OF REGISTRATION 50 RENEWAL STUB IN FORCE IMMEDIATELY PRECEDING THE DATE OF APPLICATION OR 51 FOR RENEWAL, TOGETHER WITH A STATEMENT IN A FORM PRESCRIBED ΒY THE COMMISSIONER CERTIFYING THAT THERE IS IN EFFECT PROOF OF FINANCIAL SECU-52 RITY, SHALL MEET THE REQUIREMENTS OF THIS SECTION. UPON THE ISSUANCE OR 53 54 RENEWAL OF A PRIVATE PASSENGER AUTOMOBILE INSURANCE POLICY SUBJECT ΤO 55 THE PROVISIONS OF SECTION THREE THOUSAND FOUR HUNDRED TWENTY-FIVE OF THE 56 THE INSURANCE COMPANY SHALL PROVIDE THE INSURED WITH AN INSURANCE LAW,

INFORMATIONAL STATEMENT OUTLINING THE LEGAL AND FINANCIAL CONSEQUENCES 1 2 CONVICTIONS UNDER SECTION ELEVEN HUNDRED NINETY-TWO OF THIS CHAPTER, OF 3 PERTAINING TO OPERATING A MOTOR VEHICLE WHILE UNDER THE INFLUENCE OF 4 ALCOHOL OR DRUGS. 7 OWNER AND REGISTRANT IF THE REGISTRANT IS DIFFERENT FROM THE (B) THE OWNER OF SUCH LEASED OR RENTED MOTOR VEHICLE SHALL MAINTAIN 8 PROOF OF 9 FINANCIAL SECURITY CONTINUOUSLY THROUGHOUT THE REGISTRATION PERIOD AND 10 HIS FAILURE TO PRODUCE PROOF OF FINANCIAL SECURITY WHEN REQUESTED TO DO UPON DEMAND OF A MAGISTRATE, MOTOR VEHICLE INSPECTOR, PEACE OFFICER, 11 SO 12 ACTING PURSUANT TO HIS SPECIAL DUTIES, OR POLICE OFFICER, WHILE SUCH VEHICLE IS BEING OPERATED UPON THE PUBLIC HIGHWAY, SHALL BE PRESUMPTIVE 13 14 EVIDENCE OF OPERATING A MOTOR VEHICLE WITHOUT PROOF OF FINANCIAL SECURI-15 TY. UPON THE PRODUCTION OF PROOF OF FINANCIAL SECURITY SUCH PRESUMPTION 16 REMOVED. PRODUCTION OF PROOF OF FINANCIAL SECURITY MAY BE MADE BY IS 17 MAILING SUCH PROOF TO THE COURT HAVING JURISDICTION IN THE MATTER, AND 18 RESPONSE BY SUCH COURT OR ACKNOWLEDGEMENT ANY NECESSARY OF THE 19 PRODUCTION OF SUCH PROOF MAY ALSO BE MADE BY MAIL. WHEN INSURANCE WITH 20 RESPECT TO ANY MOTOR VEHICLE, OTHER THAN A MOTORCYCLE, IS TERMINATED THE 21 OWNER SHALL SURRENDER FORTHWITH THEIR REGISTRATION CERTIFICATE AND 22 NUMBER PLATES OF THE VEHICLE TO THE COMMISSIONER UNLESS PROOF OF FINAN-23 CIAL SECURITY OTHERWISE IS MAINTAINED IN COMPLIANCE WITH THIS ARTICLE.

24 (C) THE OWNER OF ANY LEASED OR RENTED VEHICLE THAT FAILS TO MAINTAIN 25 THE PROOF OF FINANCIAL SECURITY REQUIRED ABOVE MAY BE HELD PERSONALLY 26 LIABLE FOR ANY JUDGMENT ENTERED AGAINST ANY DRIVER AND/OR REGISTRANT OF 27 THE LEASED OR RENTED VEHICLE FOR DAMAGES SUSTAINED AS A RESULT OF 28 WRONGFUL DEATH AND/OR PROPERTY DAMAGE SUFFERED AS A PERSONAL INJURY, 29 RESULT OF THE USE AND OPERATION OF THE LEASED OR RENTED VEHICLE.

30 S 3. Paragraph 3 of subdivision (b) of section 345 of the vehicle and 31 traffic law, as amended by chapter 305 of the laws of 1995, is amended 32 to read as follows:

33 (3) Shall insure the insured, THE VEHICLE OPERATOR, or such other person against loss from the liability imposed by law for damages, 34 including damages for care and loss of services because of bodily injury 35 to or death of any person and injury to or destruction of property aris-36 37 ing out of the ownership, maintenance, use, or operation of such motor vehicle or motor vehicles within the state of New York, or elsewhere in 38 39 the United States in North America or the Dominion of Canada, subject to 40 a limit, exclusive of interest and cost, with respect to each such motor vehicle, except a tow truck OR A MOTOR VEHICLE WHICH IS RENTED OR LEASED 41 42 FROM A PERSON, ORGANIZATION OR BUSINESS REGULARLY ENGAGED IN THE BUSI-43 NESS OF RENTING OR LEASING MOTOR VEHICLES TO THE GENERAL PUBLIC, of 44 twenty-five thousand dollars because of bodily injury to or fifty thou-45 sand dollars because of death of one person in any one accident and, 46 subject to said limit for one person, to a limit of fifty thousand 47 dollars because of bodily injury to or one hundred thousand dollars 48 because of death of two or more persons in any one accident, and to a limit of ten thousand dollars because of injury to or destruction of 49 50 property of others in any one accident. The limit, exclusive of interest 51 and costs, with respect to a tow truck shall be a combined single limit of three hundred thousand dollars because of bodily injury [of] OR death 52 53 to one or more persons or because of injury or destruction of property of others in any one accident, and to a limit of twenty-five thousand 54 55 dollars because of damage to a vehicle in the care, custody and control 56 of the insured. THE LIMIT, EXCLUSIVE OF INTEREST AND COSTS, WITH

RESPECT TO A MOTOR VEHICLE WHICH IS RENTED OR LEASED FROM A PERSON, 1 ORGANIZATION OR BUSINESS REGULARLY ENGAGED IN THE BUSINESS OF RENTING OR 2 LEASING MOTOR VEHICLES TO THE GENERAL PUBLIC, SHALL BE A COMBINED SINGLE 3 4 LIMIT OF AT LEAST ONE MILLION DOLLARS BECAUSE OF BODILY INJURY OR DEATH 5 TO ONE OR MORE PERSONS OR BECAUSE OF INJURY OR DESTRUCTION OF PROPERTY OTHERS IN ANY ONE ACCIDENT, AND TO A LIMIT OF TWENTY-FIVE THOUSAND 6 OF DOLLARS BECAUSE OF DAMAGE TO A VEHICLE IN THE CARE, CUSTODY AND CONTROL 7 8 OF THE INSURED.
