AN ACT to amend the penal law, in relation to the payment of reparation or restitution in certain instances

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 10 of section 60.27 of the penal law, as added  
2     by chapter 310 of the laws of 1996, is amended to read as follows:  
3     10. If the offense of which a person is convicted is defined in  
4     section 150.10, 150.15 or 150.20 of this chapter, and no other victim  
5     who is a person is seeking restitution in the case, the term "victim" as  
6     used in this section, in addition to its ordinary meaning, shall mean  
7     any municipality OR VOLUNTEER FIRE COMPANY which has expended funds or  
8     will expend funds for the purpose of restoration, rehabilitation or  
9     clean-up of the site of the arson. Any restitution which may be required  
10    to be made to a municipality OR VOLUNTEER FIRE COMPANY pursuant to this  
11    section shall be limited to the amount of funds reasonably expended or  
12    to be expended for the purpose of restoration, rehabilitation or clean-  
13    up of the site of the arson, less the amount of any funds which have  
14    been or will be recovered from any other source, and shall not include a  
15    designated surcharge pursuant to subdivision eight of this section. Any  
16    municipality OR VOLUNTEER FIRE COMPANY seeking restitution pursuant to  
17    this section shall file with the court, district attorney and defense  
18    counsel an affidavit stating that the funds reasonably expended or to be  
19    expended for which restitution is being sought have not been and will

2 proceeding. FOR THE PURPOSES OF THIS SUBDIVISION, "VOLUNTEER FIRE  
3 COMPANY" MEANS A FIRE COMPANY AS DEFINED IN PARAGRAPH A OF SUBDIVISION  
4 TWO OF SECTION ONE HUNDRED OF THE GENERAL MUNICIPAL LAW.  
5 S 2. This act shall take effect immediately.
