AN ACT to amend the tax law, in relation to establishing an income tax credit for a teacher's unreimbursed expenditures for qualified classroom or teaching supplies

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 606 of the tax law is amended by adding a new 2 subsection (vv) to read as follows:

3 CREDIT FOR A TEACHER'S UNREIMBURSED EXPENDITURES FOR QUALIFIED (VV)4 CLASSROOM OR TEACHING SUPPLIES. (1) FOR PURPOSES OF THIS SUBSECTION "QUALIFIED EXPENDITURES FOR CLASSROOM OR TEACHING SUPPLIES" SHALL MEAN 5 6 EXPENDITURES FOR CLASSROOM BOOKS AND OTHER INSTRUCTIONAL MATERIALS AND 7 EQUIPMENT USED IN ELEMENTARY AND SECONDARY SCHOOLS, NOTEBOOKS, WRITING UTENSILS INCLUDING BUT NOT LIMITED TO PENCILS, PENS, CRAYONS AND MARK-8 PAPER, TEACHING MATERIALS SUCH AS POSTERS AND SUPPLIES FOR SPECIAL 9 ERS, 10 PROJECTS, AND FIELD TRIP COSTS. CLASSROOM BOOKS AND OTHER INSTRUCTIONAL MATERIALS SHALL NOT INCLUDE BOOKS AND MATERIALS USED IN THE TEACHING OF 11 12 RELIGIOUS TENETS, DOCTRINES, OR WORSHIP, THE PURPOSE OF WHICH IS ТΟ INSTILL SUCH TENETS, DOCTRINES, OR WORSHIP, NOR DOES IT INCLUDE BOOKS OR 13 MATERIALS FOR EXTRACURRICULAR ACTIVITIES INCLUDING SPORTING EVENTS, 14 15 SPEECH ACTIVITIES, DRIVER'S EDUCATION, OR SIMILAR PROGRAMS, WITH THE 16 EXCEPTION OF MUSICAL OR DRAMATIC EVENTS OR PROGRAMS.

17 (2) FOR TAXABLE YEARS BEGINNING ON OR AFTER JANUARY FIRST, TWO THOU-SAND FIFTEEN, A OUALIFIED TAXPAYER SHALL BE ALLOWED A MAXIMUM CREDIT OF 18 FIVE HUNDRED DOLLARS ANNUALLY AGAINST THE TAX IMPOSED BY THIS ARTICLE 19 FOR OUALIFIED EXPENDITURES FOR CLASSROOM OR TEACHING SUPPLIES IN 20 OUALI-21 FIED ELEMENTARY AND SECONDARY EDUCATIONAL INSTITUTIONS, PROVIDED, HOWEV-22 ER, THAT THE AMOUNT OF SUCH CREDIT SHALL NOT EXCEED THE TAX IMPOSED BY SECTION SIX HUNDRED ONE OF THIS PART, FOR THE TAXABLE YEAR.
