AN ACT to amend the village law and the public officers law, in relation to authorizing the village of Macedon to hire a clerk/treasurer outside of such village

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Section 3-300 of the village law is amended by adding two new subdivisions 22 and 23 to read as follows:
  - 22. NOTWITHSTANDING ANY PROVISIONS OF THIS CHAPTER OR ANY OTHER GENERAL LAW, LOCAL LAW, ORDINANCE OR SPECIAL ACT, THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF MACEDON, WAYNE COUNTY, MAY, BY RESOLUTION, PROVIDE THAT THE CLERK/TREASURER OF THE VILLAGE OF MACEDON, WAYNE COUNTY, NEED NOT BE A RESIDENT OF SUCH VILLAGE, BUT MUST BE A RESIDENT OF NEW YORK STATE.

1 CLERK/TREASURER OF THE VILLAGE OF MACEDON, PROVIDED THAT SUCH PERSON 2 RESIDES IN THE COUNTY OF WAYNE OR AN ADJOINING COUNTY WITHIN THE STATE 3 OF NEW YORK.
