AN ACT to amend the public health law, in relation to requiring health  
care providers to report cases of methicillin resistant staphylococcus  
aureus infections

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. Article 21 of the public health law is amended by adding a  
2     new title VIII to read as follows:

6     SECTION 2180. METHICILLIN RESISTANT STAPHYLOCOCCUS AUREUS; DUTY TO  
7     REPORT.

8     S 2180. METHICILLIN RESISTANT STAPHYLOCOCCUS AUREUS; DUTY TO REPORT.

9     1. (A) UPON CONSIDERING THAT THE INFECTION OF A PATIENT IN A HOSPITAL,  
10    NURSING HOME OR OTHER HEALTH CARE FACILITY IS RESISTING ANTIBIOTIC  
11    TREATMENT, AND IS OR MAY BE METHICILLIN RESISTANT STAPHYLOCOCCUS AUREUS,  
12    THE PRESCRIBING PHYSICIAN OR OTHER PRESCRIBING PERSON AUTHORIZED BY LAW  
13    TO MAKE A MEDICAL DIAGNOSIS, SHALL IMMEDIATELY ARRANGE FOR CULTURING AND  
14    LABORATORY TESTING OF SUCH INFECTION, AND FOR APPRISING THE FACILITY'S  
15    ADMINISTRATOR AND ITS DIRECTOR OF NURSING OF THE CASE.

16    (B) UPON ISSUING ITS FINDINGS, THE LABORATORY SHALL SEND A COPY THERE-  
17    OF TO THE COMMISSIONER.

18    (C) UPON THE PATIENT'S DISCHARGE OR DEATH, THE FACILITY SHALL PROMPTLY  
19    REPORT THE CASE TO THE COMMISSIONER.

20    2. THE COMMISSIONER SHALL PROMPTLY FORWARD SUCH REPORT TO THE HEALTH  
21    COMMISSIONER OF THE MUNICIPALITY WHERE SUCH INFECTION OCCURRED. WHEN  
22    CASES OF SUCH INFECTION OCCUR IN A MUNICIPALITY NOT HAVING A HEALTH

1 COMMISSIONER, SUCH REPORTS SHALL BE FORWARDED DIRECTLY TO THE DISTRICT  
2 HEALTH OFFICER.

3 3. SUCH REPORT SHALL CONTAIN SUCH INFORMATION CONCERNING THE CASE AS  
4 SHALL BE REQUIRED BY THE COMMISSIONER.

5 4. THE REQUIREMENTS OF THIS TITLE SHALL BE IN ADDITION TO THE REQUIRE-  
6 MENTS OF SECTION TWENTY-EIGHT HUNDRED NINETEEN OF THIS CHAPTER.

7 S 2. This act shall take effect on the thirtieth day after it shall  
8 have become a law.
