AN ACT to amend the vehicle and traffic law, in relation to the disqual-  
ification of school bus drivers for certain offenses involving chil-  
dren

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 4 of section 509-cc of the vehicle and traffic  
2     law, as amended by chapter 400 of the laws of 2011, is amended to read  
3     as follows:  
4     (4) (a) The offenses referred to in subparagraph (ii) of paragraph (a)  
5     of subdivision one and paragraph (a) of subdivision two of this section  
6     that result in permanent disqualification shall include a conviction  
7     under [sections] SECTION 120.02, 120.12, 125.12, 125.13, 125.14, 125.15,  
8     125.20, 125.21, 125.22, 125.25, 125.26, 125.27, 130.20, 130.25, 130.30,  
9     130.35, 130.45, 130.50, 130.52, 130.53, 130.55, 130.60, 130.65, 130.66,  
10    130.67, 130.70, 130.75, 130.80, 130.85, 130.90, 130.95, 130.96, 135.25,

14    any offenses committed under a former section of the penal law which  
15    would constitute violations of the aforesaid sections of the penal law,  
16    or any offenses committed outside this state which would constitute  
17    violations of the aforesaid sections of the penal law.  
18    (b) The offenses referred to in subparagraph (ii) of paragraph (a) of  
19    subdivision one and paragraph (b) of subdivision two of this section  
20    that result in permanent disqualification shall include a conviction  
21    under sections 100.13, 105.15, 105.17, 115.08, 120.12, 120.70, 125.10,  
22    125.11, 130.40, 130.53, [130.60,] 130.65-a, 135.20, 160.15, 220.18,

6 (c) The offenses referred to in subparagraph (i) of paragraph (b) of  
7 subdivision one and subparagraph (i) of paragraph (c) of subdivision two  
8 of this section that result in disqualification for a period of five
