AN ACT to amend the vehicle and traffic law, in relation to the disqualification of school bus drivers for certain offenses involving children

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 4 of section 509-cc of the vehicle and traffic 2 law, as amended by chapter 400 of the laws of 2011, is amended to read 3 as follows:
