AN ACT to amend the environmental conservation law, in relation to prohibiting the manufacture, distribution and sale of children's foam mats containing formamide

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Article 37 of the environmental conservation law is amended by adding a new title 4 to read as follows:

- 1 (B) "FORMAMIDE" MEANS THE CHEMICAL IDENTIFIED BY CAS NUMBER 75-12-7, 2 INCLUDING METHANAMIDE AND CARBAMALDEHYDE.

- 4 1. BEGINNING DECEMBER FIRST, TWO THOUSAND SIXTEEN, NO PERSON, FIRM, 5 PARTNERSHIP, ASSOCIATION, LIMITED LIABILITY COMPANY OR CORPORATION SHALL 6 SELL OR OFFER FOR SALE IN THIS STATE ANY FOAM MAT PRODUCT CONTAINING 7 FORMAMIDE.
