AN ACT to amend chapter 326 of the laws of 2011, amending the environmental conservation law, relating to allowing the use of rifles for hunting in Wyoming county, in relation to making such provisions permanent; and to amend the environmental conservation law, in relation to making the use of rifles for hunting in Wyoming county permanent

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Section 3 of chapter 326 of the laws of 2011, amending the  
2 environmental conservation law, relating to allowing the use of rifles  
3 for hunting in Wyoming county, is amended to read as follows:  
4     S 3. This act shall take effect immediately, provided that:  
5     a. the amendments to item (i) of paragraph a of subdivision 2 of  
6 section 11-0907 of the environmental conservation law made by section  
7 one of this act shall be subject to the expiration and reversion of such  
8 paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as  
9 amended[, when upon such date the provisions of section two of this act  
10 shall take effect;  
11     b. the amendments to item (i) of paragraph a of subdivision 2 of  
12 section 11-0907 of the environmental conservation law made by section  
13 two of this act shall be subject to the expiration and reversion of such  
14 paragraph pursuant to section 17 of chapter 483 of the laws of 2010, as  
15 amended; and  
16     c. nothing contained in this act shall be construed so as to extend  
17 the provisions of this act beyond January 1, 2014, when upon such date  
18 this act shall expire and the provisions contained in this act shall be  
19 deemed repealed].

1 S 2. Item (i) of paragraph a of subdivision 2 of section 11-0907 of  
2 the environmental conservation law, as amended by section 2 of chapter  
3 600 of the laws of 2005, is amended to read as follows:  
4 (i) The counties of Deer and bear, the Pistol, shotgun,  
5 Allegany, Cattaraugus, first Monday after muzzle loading  
6 Chenango, Herkimer, November 15 through firearm, rifle or  
7 Montgomery, Oneida, first Tuesday after long bow only  
8 Oswego, Otsego, December 7  
9 Schoharie  
10 [and], Tioga AND WYOMING  
11 and that portion  
12 of the county  
13 of Broome east of the  
14 Susquehanna river  
15 S 3. This act shall take effect immediately; provided that section two  
16 of this act shall take effect on the same date as the reversion of para-  
17 graph a of subdivision 2 of section 11-0907 of the environmental conser-  
18 vation law as provided in section 13 of chapter 600 of the laws of 1993,  
19 as amended takes effect.
