AN ACT to amend the vehicle and traffic law, in relation to requiring the use of rear wheel guards on certain vehicles

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. This act shall be known and may be cited as the "Amara Diarrassouba life saving truck guard law".

3 S 2. Section 375 of the vehicle and traffic law is amended by adding a 4 new subdivision 10-f to read as follows:

5 10-F. EVERY TRUCK, TRACTOR, AND TRACTOR-TRAILER OR SEMITRAILER COMBI-6 NATION REGISTERED IN THIS STATE HAVING A GROSS VEHICLE WEIGHT RATING OF 7 TWENTY-SIX THOUSAND POUNDS OR MORE, AND A CONVENTIONAL CAB CONFIGURATION 8 IN WHICH MORE THAN HALF OF THE ENGINE LENGTH IS FORWARD OF THE FOREMOST 9 POINT OF THE WINDSHIELD BASE AND THESTEERING WHEEL HUB IS IN THE FORWARD QUARTER OF THE VEHICLE LENGTH, WHENEVER OPERATED WITHIN A 10 CITY HAVING A POPULATION OF ONE MILLION OR MORE ON HIGHWAYS OTHER THAN CONT-11 12 ROLLED-ACCESS HIGHWAYS, SHALL BE EQUIPPED WITH REAR WHEEL GUARDS ON THE 13 REAR WHEELS OF SUCH VEHICLE OR COMBINATION OF VEHICLES.

14 S 3. This act shall be deemed repealed if any federal agency or any 15 court of competent jurisdiction finally determines that this act would 16 render New York state ineligible for the receipt of federal funds.

17 S 4. Severability. If any clause, sentence, subdivision, paragraph, section or part of this act be adjudged by any court of competent juris-18 19 diction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to 20 21 the clause, sentence, subdivision, paragraph, section or part thereof directly involved in the controversy in which such judgment 22 shall have 23 been rendered.

24 S 5. This act shall take effect on the one hundred eightieth day after 25 it shall have become a law; provided, however, that effective immediate-

ly, the addition, amendment and/or repeal of any rule or regulation 1 necessary for the implementation of this act on its effective date is 2 authorized to be made and completed on or before such effective date; 3 4 and provided that the commissioner of the department of transportation shall notify the legislative bill drafting commission upon the occur-rence of the provisions of section three of this act in order that the 5 б 7 commission may maintain an accurate data base of the official text of 8 the laws of the state of New York in furtherance of effecting the provisions of section 44 of the legislative law and section 70-b of the 9 10 public officers law.
