- AN ACT to amend the real property law, the public housing law and the cooperative corporations law, in relation to discrimination against owners of specific breeds of dog

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The real property law is amended by adding a new section 2 339-11 to read as follows:

3 S 339-LL. LIMITATIONS ON BY-LAWS, RULES AND REGULATIONS. NO BY-LAW, 4 RULE, REGULATION, RESOLUTION OR DECISION MAY BE ADOPTED THAT RESTRICTS A 5 UNIT OWNER'S ABILITY TO OWN A SPECIFIC BREED OF DOG. NOTHING IN THIS SECTION SHALL BE CONSTRUED TO PROHIBIT A BOARD OF MANAGERS б FROM 7 RESTRICTING OWNERSHIP OF DOGS, REGARDLESS OF THEIR BREED, OR OWNERSHIP 8 OF DANGEROUS DOGS AS DEFINED IN SECTION ONE HUNDRED TWENTY-THREE OF THE 9 AGRICULTURE AND MARKETS LAW.

10 S 2. The public housing law is amended by adding a new section 223-c 11 to read as follows:

12 S 223-C. DISCRIMINATION AGAINST PERSONS WHO OWN CERTAIN BREEDS OF DOGS. NO PERSON SHALL BE DENIED OCCUPANCY IN A DWELLING IN ANY PROJECT 13 14 OR BE SUBJECTED TO EVICTION FROM ANY SUCH DWELLING ON THE SOLE GROUND THAT SUCH PERSON OWNS A SPECIFIC BREED OF DOG AND RESIDES WITH SUCH 15 PERSON. NOTHING IN THIS SECTION SHALL BE CONSTRUED 16 TO PROHIBIT THE RESTRICTION OF OWNERSHIP OF DOGS, REGARDLESS OF THEIR BREED, OR OWNER-17 18 SHIP OF DANGEROUS DOGS AS DEFINED IN SECTION ONE HUNDRED TWENTY-THREE OF 19 THE AGRICULTURE AND MARKETS LAW.

1 S 3. The real property law is amended by adding a new section 238-a to 2 read as follows:

3 238-A. S DISCRIMINATION IN LEASES WITH RESPECT TO SPECIFIC BREED OF 4 DOGS. NO PERSON, FIRM OR CORPORATION OWNING OR HAVING IN CHARGE ANY 5 APARTMENT HOUSE, TENEMENT HOUSE OR OTHER BUILDING OR MOBILE HOME PARK 6 USED FOR DWELLING PURPOSES SHALL RESTRICT A TENANT'S ABILITY ΤO OWN A 7 SPECIFIC BREED OF DOG. NOTHING IN THIS SECTION SHALL BE CONSTRUED TO PROHIBIT THE RESTRICTION OF OWNERSHIP OF DOGS, REGARDLESS OF 8 THEIR 9 BREED, OR OWNERSHIP OF DANGEROUS DOGS AS DEFINED IN SECTION ONE HUNDRED 10 TWENTY-THREE OF THE AGRICULTURE AND MARKETS LAW.

11 S 4. The cooperative corporations law is amended by adding a new 12 section 19 to read as follows:

19. LIMITATIONS OF BY-LAWS BY CERTAIN COOPERATIVE CORPORATIONS. 13 S NO 14 BY-LAW OR RULE MAY BE ADOPTED BY A COOPERATIVE CORPORATION THAT WAS 15 FORMED FOR THE PURPOSE OF HOUSING THAT WOULD RESTRICT A MEMBER'S ABILITY TO OWN A SPECIFIC BREED OF DOG. NOTHING IN THIS SECTION SHALL BE 16 CONSTRUED TO PROHIBIT A COOPERATIVE CORPORATION FROM RESTRICTING 17 OWNER-SHIP OF DOGS, REGARDLESS OF THEIR BREED, OR OWNERSHIP OF DANGEROUS DOGS 18 19 AS DEFINED IN SECTION ONE HUNDRED TWENTY-THREE OF THE AGRICULTURE AND 20 MARKETS LAW.

21 S 5. This act shall take effect immediately.
