AN ACT to amend the executive law, in relation to the performance of a study regarding homeless women who are veterans in the state of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 353 of the executive law is amended by adding a new
2 subdivision 6-a to read as follows:
3 6-A. TO CONDUCT A STUDY, IN CONSULTATION WITH THE OFFICE OF TEMPORARY
4 AND DISABILITY SERVICE, DEPARTMENT OF LABOR, AND OFFICE OF CHILDREN AND
5 FAMILY SERVICES TO DETERMINE THE NUMBER OF HOMELESS WOMEN IN NEW YORK
6 STATE THAT ARE VETERANS. SUCH STUDY SHALL INCLUDE, BUT NOT BE LIMITED
7 TO: (A) AN ANALYSIS OF FEMALE VETERANS IN NEW YORK STATE WHO ARE
8 CURRENTLY HOMELESS, OR HAVE BEEN HOMELESS WITHIN FIVE YEARS OF BEING
9 RELEASED FROM ACTIVE DUTY; (B) DATA ON THE NUMBER OF CHILDREN OF HOME-
10 LESS WOMEN VETERANS, INCLUDING THE CURRENT PLACEMENT OF SUCH CHILDREN;
11 (C) CASES OF MILITARY SEXUAL TRAUMA EXPERIENCED BY HOMELESS WOMEN VETER-
12 ANS WHILE ON ACTIVE DUTY OR DURING MILITARY TRAINING; AND (D) THE UNEM-
13 PLOYMENT RATE FOR NEW YORK STATE FEMALE VETERANS. THE TERM "CHILDREN OF
14 HOMELESS VETERANS" SHALL MEAN A PERSON WHO IS UNMARRIED AND WHO IS UNDER
15 THE AGE OF EIGHTEEN YEARS, AND IS THE BIOLOGICAL OR LEGALLY ADOPTED
16 CHILD OF A FEMALE VETERAN. A WRITTEN REPORT OF SUCH STUDY SHALL BE
