THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 353 of the executive law is amended by adding a new 2 subdivision 6-a to read as follows:

TO CONDUCT A STUDY, IN CONSULTATION WITH THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE, DEPARTMENT OF LABOR, AND OFFICE OF FAMILY SERVICES TO DETERMINE THE NUMBER OF HOMELESS PERSONS IN NEW YORK STATE THAT ARE VETERANS. SUCH STUDY SHALL INCLUDE, BUT NOT LIMITED TO: (A) AN ANALYSIS OF VETERANS IN NEW YORK STATE WHO ARE CURRENTLY HOMELESS, OR HAVE BEEN HOMELESS WITHIN FIVE YEARS OF RELEASED FROM ACTIVE DUTY INCLUDING AN ANALYSIS OF GENDER AS IT RELATES TO HOMELESSNESS OF VETERANS; (B) DATA ON THE NUMBER OF CHILDREN OF HOME-LESS VETERANS, INCLUDING THE CURRENT PLACEMENT OF SUCH CHILDREN; MILITARY SEXUAL TRAUMA EXPERIENCED BY HOMELESS VETERANS WHILE
