AN ACT to amend the mental hygiene law, in relation to establishing the direct support professional credential pilot program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The mental hygiene law is amended by adding a new section 2 13.41 to read as follows:

S 13.41 DIRECT SUPPORT PROFESSIONAL CREDENTIAL PILOT PROGRAM.

4 (A) THE OFFICE SHALL INITIATE A PROGRAM TO CONTINUE TO GAIN THE EXPER-5 TISE AND KNOWLEDGE OF THE DEVELOPMENTAL DISABILITIES WORKFORCE AND OF 6 THE DEVELOPMENTAL DISABILITIES WORKFORCE RECRUITMENT AND RETENTION NEEDS 7 FIELD. THE OFFICE SHALL A DIRECT SUPPORT THROUGHOUT THE IMPLEMENT 8 PROFESSIONAL CREDENTIAL PILOT PROGRAM TO ASSIST AND ATTRACT INDIVIDUALS 9 INTO THE FIELD OF DIRECT SUPPORT, ADVANCE DIRECT SUPPORT AS A CAREER AND PROFESSIONALIZE THE FIELD TO PROMOTE WORKFORCE RECRUITMENT AND RETENTION 10 EFFORTS, ADVANCE SKILLS AND COMPETENCIES, WHILE CREATING A CAREER LADDER 11 12 COMMENSURATE PAY FOR ADVANCED SKILLS, AND FURTHER ENSURE THE WITH 13 HEALTH, SAFETY AND WELL BEING OF INDIVIDUALS BEING SERVED.

14 (B) THERE HEREBY IS CREATED THE DIRECT SUPPORT PROFESSIONAL CREDENTIAL
15 PILOT PROGRAM WITHIN THE OFFICE TO ASSIST INDIVIDUALS IN THE FIELD
16 OBTAIN A CREDENTIAL IN THEIR FIELD OF EXPERTISE.

17 (1)SUCH PILOT PROGRAM SHALL BE ADMINISTERED BY THE OFFICE FOR THREE YEARS. THE PILOT PROGRAM SHALL INCLUDE STATE-OPERATED FACILITIES 18 AND 19 NOT-FOR-PROFIT PROVIDERS, LICENSED AND CERTIFIED BY THE OFFICE. THE 20 PURPOSE OF THE PILOT PROGRAM SHALL BE TO ASSESS HOW THE ESTABLISHMENT OF A STATE ACCREDITED DIRECT SUPPORT PROFESSIONAL CREDENTIAL: (A) 21 PROMOTES 22 AND RETENTION EFFORTS THE DEVELOPMENTAL DISABILITIES RECRUITMENT IN 23 FIELD, NOTABLY THE DIRECT SUPPORT PROFESSIONAL POSITION; (B) ENHANCES 24 COMPETENCE IN THE DEVELOPMENTAL DISABILITIES FIELD; (C) YIELDS QUALITY 25 SUPPORTS AND SERVICES TO INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES;

AND (D) ADVANCES THE HEALTH AND SAFETY REOUIREMENTS SET FORTH BY THE 1 2 STATE. 3 (2) THE OFFICE IN ADMINISTERING THE PILOT PROGRAM SHALL CONSIDER, BUT 4 NOT BE LIMITED TO, THE FOLLOWING: 5 (A) BEST PRACTICES LEARNING INITIATIVES, INCLUDING THE UNIVERSITY OF 6 MINNESOTA'S COLLEGE OF DIRECT SUPPORT AND NEW YORK STATE DIRECT SUPPORT 7 PROFESSIONAL COMPETENCIES; (B) NATIONAL DIRECT SUPPORT PROFESSIONAL COMPETENCIES OR CREDENTIALING 8 9 BASED STANDARDS AND TRAININGS; 10 (C) FACILITATING DIRECT SUPPORT PROFESSIONALS PORTFOLIO DEVELOPMENT; 11 (D) THE ROLE AND VALUE OF SKILL MENTORS; AND (E) CREATING A CAREER LADDER. 12 13 (3) DIRECT SUPPORT PROFESSIONAL CREDENTIAL MEANS A DOCUMENT ISSUED TO 14 AN INDIVIDUAL BY A RECOGNIZED ACCREDITING BODY ATTESTING THAT SUCH INDI-15 VIDUAL HAS MET THE PROFESSIONAL REQUIREMENTS OF THE CREDENTIALING PROGRAM BY THE OFFICE. 16 (4) THE OFFICE SHALL PRODUCE A REPORT DETAILING THE 17 PROGRESS OF THE PILOT PROGRAM, INCLUDING, BUT NOT LIMITED TO: 18 THE RATE OF RECRUITMENT AND RETENTION FOR DIRECT SUPPORT PROFES-19 (A) SIONALS OF PROVIDERS PARTICIPATING IN THE PILOT PROGRAM COMPARED TO 20 THE 21 RATE FOR NON-PARTICIPATING PROVIDERS; (B) THE NUMBER OF DIRECT SUPPORT PROFESSIONALS CREDENTIALED; AND 22 23 (C) THE ENHANCEMENT OF QUALITY SUPPORTS AND SERVICES TO INDIVIDUALS 24 WITH DEVELOPMENTAL DISABILITIES. 25 S 2. This act shall take effect on the ninetieth day after it shall 26 have become a law.
